**PROPOSED AMENDMENTS TO
SENATE BILL 5516**

1 On page 1 of the printed bill, delete lines 5 through 22 and delete pages
2 2 and 3 and insert:

3 **“SECTION 1. There are appropriated to the Department of Educa-**
4 **tion, for the biennium beginning July 1, 2017, out of the General Fund,**
5 **the following amounts, for the following purposes:**

6 (1) Operations..... \$ 77,167,794

7 (2) Oregon School for the Deaf..... \$ 12,317,072

8 **“SECTION 2. There are appropriated to the Department of Educa-**
9 **tion, for the biennium beginning July 1, 2017, out of the General Fund,**
10 **the following amounts, which are to be distributed as grants-in-aid,**
11 **for program costs and to purchase services, for the following purposes:**

12 (1) Early intervention services
13 and early childhood special
14 education programs \$175,014,948

15 (2) Other special education
16 programs..... \$ 48,980,693

17 (3) Nutrition programs..... \$ 2,090,517

18 (4) Other K-12 grant-in-aid
19 programs..... \$ 51,634,644

4 **“SECTION 3. Notwithstanding any other law limiting expenditures,**
5 **the following amounts are established for the biennium beginning July**
6 **1, 2017, as the maximum limits for payment of expenses, other than**
7 **expenses described in sections 6 and 10 of this 2017 Act, from fees,**
8 **moneys or other revenues, including Miscellaneous Receipts, but ex-**
9 **cluding lottery funds and federal funds, collected or received by the**
10 **Department of Education, for the following purposes:**

- 11 (1) Operations..... \$ 39,120,017
- 12 (2) Oregon School for the Deaf..... \$ 6,025,702

13 **“SECTION 4. Notwithstanding any other law limiting expenditures,**
14 **the following amounts are established for the biennium beginning July**
15 **1, 2017, as the maximum limits for payment of expenses from federal**
16 **funds, other than those described in sections 5 and 10 of this 2017 Act,**
17 **collected or received by the Department of Education, for the follow-**
18 **ing purposes:**

- 19 (1) Operations..... \$ 80,093,895
- 20 (2) Oregon School for the Deaf..... \$ 264,004

21 **“SECTION 5. Notwithstanding any other law limiting expenditures,**
22 **the following amounts are established for the biennium beginning July**
23 **1, 2017, as the maximum limits for payment of grants-in-aid, program**
24 **costs and purchased services from federal funds, other than those de-**
25 **scribed in sections 4 and 10 of this 2017 Act, received by the Depart-**
26 **ment of Education, for the following purposes:**

- 27 (1) Early learning programs..... \$121,035,508
- 28 (2) Youth development programs... \$ 750,000
- 29 (3) All other grants \$851,958,120

30 **“SECTION 6. Notwithstanding any other law limiting expenditures,**

1 the following amounts are established for the biennium beginning July
2 1, 2017, as the maximum limits for payment of grants-in-aid, program
3 costs and purchased services from fees, moneys or other revenues,
4 including Miscellaneous Receipts, but excluding lottery funds and fed-
5 eral funds, collected or received by the Department of Education for
6 programs other than those specified in sections 3 and 10 of this 2017
7 Act, for the following purposes:

- 8 (1) Early learning programs..... \$ 11,580,868
- 9 (2) Youth development programs... \$ 6,281,409
- 10 (3) All other grants \$102,588,037

11 **“SECTION 7.** Notwithstanding any other law limiting expenditures,
12 the amount of \$651,225 is established for the biennium beginning July
13 1, 2017, as the maximum limit for payment of expenses by the De-
14 partment of Education from lottery moneys allocated from the Oregon
15 Education Fund to the department for debt service on outstanding
16 state education lottery bonds.

17 **“SECTION 8.** There is appropriated to the Department of Education,
18 for the biennium beginning July 1, 2017, out of the General Fund, the
19 amount of \$19,851,315 for debt service on Article XI-P general obli-
20 gation bonds.

21 **“SECTION 9.** Notwithstanding section 2, chapter 1, Oregon Laws
22 2017 (Ballot Measure 98 (2016)), there is appropriated to the Department
23 of Education, for the biennium beginning July 1, 2017, out of the
24 General Fund, the amount of \$170,000,000 for deposit in the High
25 School Graduation and College and Career Readiness Fund.

26 **“SECTION 10.** For the biennium beginning July 1, 2017, the follow-
27 ing expenditures by the Department of Education are not limited:

28 **“(1)** Moneys from the School Lunch Revolving Account, Education
29 Training Revolving Account and Common School Fund; and

30 **“(2)** Expenditures for grants-in-aid and purchased services from

1 federal funds received by the Department of Education from the
2 United States Department of Agriculture.

3 **“SECTION 11. This 2017 Act being necessary for the immediate
4 preservation of the public peace, health and safety, an emergency is
5 declared to exist, and this 2017 Act takes effect July 1, 2017.”**
