**PROPOSED AMENDMENTS TO
SENATE BILL 243**

1 On page 1 of the printed bill, line 2, after the semicolon insert “creating
2 new provisions;”.

3 In line 28, after “(3)” insert “(a)”.

4 On page 2, line 2, delete “(a)” and insert “(A)”.

5 In line 4, delete “(b)” and insert “(B)”.

6 In line 5, delete “(c)” and insert “(C)”.

7 After line 5, insert:

8 “(b) ‘Child in care’ does not include a person under 21 years of age who
9 is residing in any of the entities listed in paragraph (a) of this subsection
10 when the care provided is in the home of the child by the child’s parent.”.

11 In line 8, after “children” insert “who are 18 years of age or younger
12 and”.

13 After line 9, insert:

14 “(6) ‘Involuntary seclusion’ means the confinement of a child in care
15 alone in a room from which the child in care is physically prevented from
16 leaving. ‘Involuntary seclusion’ does not include age-appropriate discipline,
17 including but not limited to, a time-out.”.

18 In line 10, delete “(6)” and insert “(7)”.

19 In line 11, delete “(7)(a)” and insert “(8)(a)”.

20 In line 23, delete “(8)” and insert “(9)”.

21 In line 25, delete “(9)” and insert “(10)”.

1 In line 31, delete “(10)” and insert “(11”).
2 In line 37, delete “(11)” and insert “(12”).
3 In line 40, delete “(12)” and insert “(13”).
4 On page 3, line 4, delete “(13)” and insert “(14”).
5 In line 5, delete “(14)” and insert “(15”).
6 In line 7, delete “(15)” and insert “(16”).
7 In line 32, after “(2)” insert “(a)”.
8 In line 37, delete “(a)” and insert “(A)”.
9 In line 42, delete “(b)” and insert “(B)”.
10 On page 4, line 3, delete “(c)” and insert “(C)”.
11 After line 9, insert:
12 “(b) A child-caring agency, certified foster home or developmental disa-
13 bilities residential facility need not develop and maintain procedures and
14 protocols or provide an annual training and written materials under para-
15 graph (a) of this subsection if the agency, home or facility does not have any
16 employees, staff or volunteers.”
17 On page 5, delete lines 22 through 27.
18 In line 28, delete “(g)” and insert “(f)”.
19 After line 29, insert:
20 “(g) The local citizen review board established by the Judicial Department
21 under ORS 419A.090.”
22 In line 38, after “or” insert “, provided there are five or more certified
23 foster homes in the county,”.
24 On page 6, after line 1, insert:
25 **“SECTION 4. (1) The amendments to sections 36, 37 and 38, chapter**
26 **106, Oregon Laws 2016, by sections 1 to 3 of this 2017 Act become op-**
27 **erative on January 1, 2018.**
28 **“(2) The Director of Human Services may take any action that is**
29 **necessary to enable the director to exercise, on and after the operative**
30 **date specified in subsection (1) of this section, all the duties, functions**

1 **and powers conferred on the director by this 2017 Act.”.**

2 In line 2, delete “4” and insert “5”.
