**PROPOSED AMENDMENTS TO
SENATE BILL 360**

1 On page 1 of the printed bill, line 22, delete “supervising agency” and
2 insert “supervisory authority”.

3 On page 2, line 11, delete “supervising” and insert “supervisory”.

4 In line 12, delete “agency” and insert “authority”.

5 In line 15, delete “super-”.

6 In line 16, delete “vising agency” and insert “supervisory authority”.

7 In line 19, delete “supervising agency’s” and insert “supervisory
8 authority’s”.

9 In line 21, delete “supervising agency” and insert “supervisory
10 authority”.

11 In line 22, delete “supervising” and insert “supervisory”.

12 In line 23, delete “agency” and insert “authority”.

13 Delete lines 24 through 28 and insert:

14 “(b) If a person is under the supervision of a community corrections
15 agency, the local supervisory authority shall notify the community cor-
16 rections agency. The community corrections agency or the local supervisory
17 authority shall cause all collection of supervision fees, including but not
18 limited to those ordered pursuant to ORS 423.570, to be ceased.”.

19 In line 29, delete “supervising agency” and insert “supervisory
20 authority”.

21 In line 30, delete “supervising agency” and insert “supervisory

1 authority”.

2 In line 33, delete “supervising” and insert “supervisory”.

3 In line 34, delete the first “agency” and insert “authority” and delete
4 “supervising agency” and insert “supervisory authority”.

5 In line 36, delete “supervising agency” and insert “supervisory
6 authority”.

7 In line 37, delete “supervising agency” and insert “supervisory
8 authority”.

9 In line 42, delete “supervising agency” and insert “supervisory
10 authority” and delete “or”.

11 In line 43, delete the first “local supervisory authority”.

12 On page 3, line 2, delete “supervising agency” and insert “supervisory
13 authority”.

14 Delete lines 7 through 11 and insert:

15 “(a) The community-based organization shall notify the local supervisory
16 authority and, if applicable, the local supervisory authority shall notify the
17 community corrections agency or other local supervisory authority. Upon
18 notification, the local supervisory authority or the community corrections
19 agency shall resume collection of the supervision fees, including but not
20 limited to those ordered pursuant to ORS 423.570.”.

21 In line 12, delete “supervising agency’s” and insert “supervisory
22 authority’s”.

23 In line 13, delete “supervising agency” and insert “supervisory
24 authority”.

25 In line 15, delete “supervising agency” and insert “supervisory
26 authority”.
