**PROPOSED AMENDMENTS TO
SENATE BILL 374**

1 On page 1 of the printed bill, line 2, delete “802.179,” and insert
2 “807.021,”.

3 In line 3, after “807.115,” insert “807.130,”.

4 Delete lines 6 through 30 and delete pages 2 through 12 and insert:

5 **“SECTION 1. ORS 801.060, 801.063 and 801.066 are repealed.**

6 **“SECTION 2. Sections 3 to 9 of this 2017 Act are added to and made**
7 **a part of the Oregon Vehicle Code.**

8 **“SECTION 3. Real ID definition. ‘Real ID’ means a driver license,**
9 **driver permit or identification card that complies with the Real ID Act**
10 **of 2005, P.L. 109-13, that is issued by this state and marked with a**
11 **distinguishing feature.**

12 **“SECTION 4. Real ID issuance, replacement and renewal; require-**
13 **ments. (1) The Department of Transportation shall issue a Real ID to**
14 **any person who:**

15 **“(a) Meets the requirements for a driver license, driver permit or**
16 **identification card as described in the vehicle code;**

17 **“(b) Submits proof, as required by rule by the department, estab-**
18 **lishing the person’s:**

19 **“(A) Identity;**

20 **“(B) Date of birth;**

21 **“(C) Social Security number, or proof that the person is not eligible**

1 for a Social Security number; and

2 “(D) Lawful status in the United States;

3 “(c) Pays the fee described in section 5 of this 2017 Act; and

4 “(d) Surrenders any Real ID previously issued to the person by this
5 state or another jurisdiction.

6 “(2) If there is any change to the applicant’s name, date of birth
7 or Social Security number after the department issues a Real ID to the
8 applicant, the department may not replace or renew the Real ID unless
9 the applicant appears in person and submits proof of the change, as
10 required by rule by the department.

11 “SECTION 5. Real ID fee. In addition to any fee imposed under ORS
12 807.370, 807.410 or 807.375, the Department of Transportation shall im-
13 pose a fee for each Real ID issued, renewed or replaced, for the pur-
14 pose of covering the additional costs to the department related to the
15 issuance of Real IDs.

16 “SECTION 6. Document retention. For the purpose of issuing Real
17 IDs only, the Department of Transportation shall:

18 “(1) Capture digital images of identity source documents and retain
19 the images in a transferable format.

20 “(2) Retain digital images of identity source documents for a mini-
21 mum of 10 years.

22 “SECTION 7. Disclosure of identity source documents. (1) Except
23 as provided in subsection (2) of this section, an officer, employee or
24 contractor of the Department of Transportation may not knowingly
25 disclose, or otherwise make available to any person copies of, identity
26 source documents submitted to the department in connection with an
27 application for a driver license, driver permit or identification card.

28 “(2) An officer, employee or contractor of the department may
29 make information or copies described in subsection (1) of this section
30 available to:

1 “(a) Law enforcement officials, motor vehicle agencies from other
2 states and employees of the department acting in an official capacity;
3 and

4 “(b) For purposes of verification, to the agency that issued the
5 identity source document.

6 “SECTION 8. Fingerprint requirements. (1) The Department of
7 Transportation may require all employees, volunteers or contractors
8 with access to systems that enable them to affect the information that
9 appears on driver licenses, driver permits or identification cards to be
10 fingerprinted.

11 “(2) Fingerprints acquired under this section may be used for the
12 purpose of requesting state or nationwide criminal records checks
13 under ORS 181A.195.

14 “SECTION 9. Real ID; verification of lawful status in the United
15 States. (1) The Department of Transportation shall verify an
16 applicant’s Social Security number before issuing an original or re-
17 newal Real ID.

18 “(2) The department shall verify the applicant’s lawful status in the
19 United States before issuing an original Real ID.

20 “(3) The department shall verify the lawful status in the United
21 States of an applicant who is not a citizen of the United States when
22 the applicant is applying to renew a Real ID.

23 “(4) Notwithstanding the requirements of subsections (2) and (3) of
24 this section, the department may verify the lawful status in the United
25 States of any applicant applying for renewal or replacement of a Real
26 ID, as determined by the department by rule.

27 “SECTION 10. ORS 807.021 is amended to read:

28 “807.021. (1) Except as provided in ORS 807.310 (5) and 807.405 (4), prior
29 to issuing, renewing or replacing [*any*] a driver license, driver permit or
30 identification card **that is not a Real ID**, the Department of Transportation

1 shall require a person to provide the Social Security number assigned to the
2 person by the United States Social Security Administration and proof of le-
3 gal presence in the United States or, if the person is not eligible for a Social
4 Security number, proof of legal presence in the United States and proof that
5 the person is not eligible for a Social Security number.

6 “(2) For the purposes of subsection (1) of this section:

7 “(a) A person provides proof of legal presence in the United States by
8 submitting valid documentation, as defined by the department by rule, that
9 the person is a citizen or permanent legal resident of the United States or
10 is otherwise legally present in the United States in accordance with federal
11 immigration laws.

12 “(b) A member of a federally recognized tribe located in Oregon or with
13 an Oregon affiliation may submit a tribal identification card as proof of legal
14 presence in the United States if the department determines that the proce-
15 dures used in issuing the card are sufficient to prove that a member is le-
16 gally present in the United States.

17 “(c) If a person is not eligible for a Social Security number, the person
18 shall provide proof, as defined by the department by rule, that the person is
19 not eligible for a Social Security number.

20 “(3) The department may issue, renew or replace a driver license, driver
21 permit or identification card **that is not a Real ID** for an applicant who
22 has submitted a Social Security number only after the department verifies
23 the Social Security number with the United States Social Security Adminis-
24 tration. In order to verify the person’s Social Security number, the depart-
25 ment may require the person to provide proof, as defined by rule, of the
26 person’s Social Security number.

27 “(4) This section does not apply if the department previously verified the
28 Social Security number as required by subsection (3) of this section and the
29 person applying for the driver license, driver permit or identification card
30 is a citizen or permanent legal resident of the United States.

1 **“SECTION 11.** ORS 807.022 is amended to read:

2 “807.022. (1) [*Prior to*] **Before** issuing, renewing or replacing a driver li-
3 cense, driver permit or identification card, the Department of Transportation
4 may verify with the issuing agency the validity and completeness of each
5 identity source document presented by the applicant.

6 **“(2) The department may require a person who holds a driver li-**
7 **cence, driver permit or identification card issued by this state who**
8 **previously presented an identity source document that was not re-**
9 **tained by the department as a digital image to present an identity**
10 **source document for the purpose of capturing and retaining a digital**
11 **copy of the identity source document. This subsection applies only to**
12 **a person who elects to hold a Real ID.**

13 **“SECTION 12.** ORS 807.024 is amended to read:

14 “807.024. (1) A person who applies for issuance, renewal or replacement
15 of a driver license, driver permit or identification card shall submit to col-
16 lection of biometric data by the Department of Transportation for the pur-
17 pose of establishing the person’s identity. Submitting to collection of
18 biometric data under this section does not excuse a person from responsibil-
19 ity for complying with requirements for proof of identity, [*age or residence*]
20 **date of birth or address** pursuant to ORS [*807.050*] **807.040.**

21 “(2) Notwithstanding subsection (1) of this section and ORS 807.040 (1)(c),
22 the department, by rule, may provide for issuance, renewal or replacement
23 of a valid driver license or driver permit without the collection of biometric
24 data.

25 “(3) For purposes of this section, a person’s identity is established if:

26 “(a) The department finds that the biometric data collected as required
27 under subsection (1) of this section match the biometric data that are already
28 in the department’s records for that person; or

29 “(b) The department finds that the biometric data collected as required
30 under subsection (1) of this section do not match biometric data in the

1 department's records for any other person and the department does not oth-
2 erwise have reason to believe that the person is not who the person claims
3 to be.

4 “(4) If a person's identity is established as described in subsection (3) of
5 this section, the department shall mail the driver license, driver permit or
6 identification card to the address provided by the person when the person
7 applied for the issuance, renewal or replacement of the license, permit or
8 identification card.

9 “(5) If a person's identity is not established as described in subsection (3)
10 of this section, the department shall:

11 “(a) Inform the person who submitted to collection of biometric data that
12 the person's identity was not established; and

13 “(b) Provide the person with the opportunity to establish the person's
14 identity by an alternative method approved by the department by rule.

15 “(6) If a person's identity was not established as described in subsection
16 (3) of this section and the department has reason to believe that the crime
17 of identity theft, as described in ORS 165.800, was committed by the person
18 currently submitting to collection of biometric data or by a person who
19 previously submitted to collection of biometric data under the identity of the
20 person currently submitting to collection of biometric data, the department
21 shall notify a law enforcement agency that has jurisdiction over the crime.

22 “(7) The department by rule shall establish procedures for providing ex-
23 pedited processing of driver licenses, driver permits or identification cards.

24 “(8) The department and employees of the department are immune from
25 liability for any damages resulting from the issuance, renewal or replacement
26 of a driver license, driver permit or identification card under another
27 person's identity if the employee who processed the biometric data for a li-
28 cense, permit or identification card established the applicant's identity as
29 described in subsection (3) of this section.

30 **“SECTION 13.** ORS 807.040 is amended to read:

1 “807.040. (1) The Department of Transportation shall issue a driver license
2 to any person who complies with all of the following requirements:

3 “(a) The person must complete an application for a license under ORS
4 807.050.

5 “(b) As required by ORS 807.021 and 807.730, the person must provide the
6 Social Security number assigned to the person by the United States Social
7 Security Administration and proof of legal presence in the United States or,
8 if the person is not eligible for a Social Security number, proof of legal
9 presence in the United States and proof that the person is not eligible for
10 a Social Security number.

11 “(c) The person must submit to collection of biometric data by the de-
12 partment that establish the identity of the person as described in ORS
13 807.024.

14 “(d) The person must not be ineligible for the license under ORS 807.060
15 and must be eligible for the license under ORS 807.062.

16 “(e) The person must successfully pass all examination requirements un-
17 der ORS 807.070 for the class of license sought.

18 “(f) The person must pay the appropriate license fee under ORS 807.370
19 for the class of license sought.

20 “(g) The person must pay the Student Driver Training Fund eligibility fee.

21 “(h) If the application is for a commercial driver license, the person must
22 be the holder of a Class C license or any higher class of license.

23 “(i) If the application is for a commercial driver license, the person must
24 submit to the department, in a form approved by the department, the report
25 of a medical examination that establishes that the person meets the medical
26 requirements for the particular class of license. The department, by rule,
27 shall establish medical requirements for purposes of this paragraph. The
28 medical requirements established under this paragraph may include any re-
29 quirements the department determines are necessary for the safe operation
30 of vehicles permitted to be operated under the class of license for which the

1 requirements are established.

2 “(j) If the application is for a commercial driver license, the person must:

3 “(A) Have at least one year’s driving experience, including relevant ex-
4 perience obtained in the military;

5 “(B) Not be subject to a lifetime suspension of commercial driving privi-
6 leges under ORS 809.520;

7 “(C) Not be otherwise ineligible to hold a commercial driver license;

8 “(D) Hold a commercial learner driver permit if the person must complete
9 a skills demonstration under ORS 807.070 (3); and

10 “(E) In addition to meeting the requirement of providing proof of legal
11 presence under ORS 807.021 and this section, the person must submit valid
12 documentation, as defined by the department by rule, that the person is a
13 citizen or permanent legal resident of the United States.

14 “**(k) The person must present acceptable documents to prove iden-**
15 **tity, date of birth and address. The department shall determine by rule**
16 **which documents are acceptable to prove identity, date of birth and**
17 **address.**

18 “**(L) If the application is for a Real ID, the person must comply with**
19 **the requirements under the vehicle code for issuance of Real IDs.**

20 “(2) The department shall work with other agencies and organizations to
21 attempt to improve the issuance system for driver licenses.

22 “**SECTION 14.** ORS 807.050 is amended to read:

23 “807.050. An application for a **driver** license shall be in a form approved
24 by the [*Oregon*] Department of Transportation. An application must contain
25 all the following:

26 “(1) The applicant’s full legal name, [*age,*] sex, **date of birth**, residence
27 address, except as otherwise provided for corrections officers in ORS 802.253,
28 eligible employees in ORS 802.250 or Address Confidentiality Program par-
29 ticipants in ORS 192.846, and post-office address other than general delivery.
30 The department may provide by rule for acceptance of something other than

1 an actual residence or post-office address if the department determines that
2 the applicant does not have an actual address. The department shall require
3 proof to verify the address in addition to anything else the department may
4 require of the applicant. The department shall adopt rules to identify what
5 constitutes proof of address for purposes of this subsection. [*Verification of*]
6 Proof of address may include, but is not limited to, providing a utility bill,
7 a tax return, a record from a financial institution, a proof of insurance card
8 or a health benefits card, a selective service card, a mortgage document or
9 a lease agreement. The applicant may provide the proof of address by sub-
10 mitting proof in the form of an original document or a copy of a document,
11 use an electronic device to display proof of address, or provide proof through
12 the use of a third party address verification system.

13 “(2) Whether or not the applicant has ever been issued any driver license
14 or driver permit. If the applicant has been issued any **driver** license or driver
15 permit:

16 “(a) When the **driver** license or driver permit was granted;

17 “(b) What jurisdiction granted the **driver** license or driver permit;

18 “(c) Whether or not the driving privileges under the **driver** license or
19 driver permit are currently suspended or revoked; and

20 “(d) If the driving privileges are revoked or suspended, the date and rea-
21 son for the suspension or revocation.

22 “(3) The class of **driver** license sought.

23 “(4) The Social Security number of the applicant or other number or
24 identifying information determined appropriate by the Secretary of the
25 United States Department of Transportation, if the application is for a com-
26 mercial driver license or a commercial learner driver permit or if the Oregon
27 Department of Transportation by rule requires the Social Security number
28 on the application.

29 “(5) Whether or not the applicant wants to make an anatomical gift, as
30 defined in ORS 97.953.

1 “(6) Any other information the department deems necessary to assist the
2 department in determining whether the applicant is qualified or eligible to
3 be licensed.

4 “(7) **The signature of the applicant.**

5 “**SECTION 15.** ORS 807.110 is amended to read:

6 “807.110. (1) A **driver** license issued by the Department of Transportation
7 shall contain all of the following:

8 “(a) The distinguishing number assigned to the person issued the **driver**
9 license by the department.

10 “(b) For the purpose of identification, a brief description of the person to
11 whom the **driver** license is issued.

12 “(c) The full legal name of the person to whom the **driver** license is is-
13 sued, except that the department may limit the number of characters dis-
14 played on the **driver** license.

15 “(d) The date of birth **and sex** of the person to whom the **driver** license
16 is issued.

17 “(e) Except as provided for corrections officers in ORS 802.253, eligible
18 employees in ORS 802.250 or Address Confidentiality Program participants
19 in ORS 192.846, the residence address of the person to whom the **driver** li-
20 cense is issued.

21 “(f) Upon request of the person to whom the **driver** license is issued, the
22 fact that the person is an anatomical donor.

23 “(g) Upon request of the person to whom the **driver** license is issued and
24 presentation of proof, as determined by the department, the fact that the
25 person is a veteran, as defined in ORS 408.225.

26 “(h) Upon order of the juvenile court, the fact that the person to whom
27 the **driver** license is issued is an emancipated minor.

28 “(i) Except as otherwise provided in subsection (2) of this section, a pho-
29 tograph described in this paragraph. A photograph required under this par-
30 agraph shall:

1 “(A) Be a full-faced, color photograph of the person to whom the **driver**
2 license is issued;

3 “(B) Be of a size approved by the department; and

4 “(C) Be taken at the time of application for issuance of the **driver** license
5 whether the application is for an original **driver** license, replacement of a
6 **driver** license under ORS 807.160 or [for] renewal of a **driver** license under
7 ORS 807.150, except that the department, by rule, may allow the applicant
8 to use a photograph already on file with the department.

9 “(j) The class of **driver** license issued and any endorsements granted. If
10 the **driver** license is a commercial driver license, the words ‘commercial
11 driver license’ or the letters ‘CDL’ shall appear on the **driver** license.

12 “(k) The signature of the person to whom the **driver** license is issued.

13 “(L) **If the driver license is not a Real ID, a design differentiating**
14 **it from a Real ID.**

15 “(2) The department may issue a valid **driver** license without a photo-
16 graph to an applicant:

17 “(a) Who objects on religious grounds;

18 “(b) Who objects because of the applicant’s facial disfigurement; or

19 “(c) Who is stationed outside of this state while serving in the active
20 military service in the Armed Forces of the United States or the National
21 Guard, and the department does not have an acceptable photograph of the
22 applicant, as determined by the department by rule. This paragraph applies
23 to an applicant who is renewing or replacing a **driver** license.

24 “(3) A limited term driver license issued under ORS 807.730 shall indicate:

25 “(a) That it is a limited term driver license; and

26 “(b) The date on which the limited term driver license expires.

27 “(4) The department shall use security procedures, processes and materials
28 in the preparation, manufacture and issuance of any **driver** license that
29 prohibit as nearly as possible anyone’s ability to alter, counterfeit, duplicate
30 or modify the **driver** license without ready detection. The security features

1 used in the production of the **driver** licenses shall provide for:

2 “(a) The authentication of a genuine document in a reasonable time; and

3 “(b) The production of the **driver** license only by equipment that requires
4 verification of the identity of the operator of the equipment before a **driver**
5 license may be produced.

6 “**SECTION 16.** ORS 807.115 is amended to read:

7 “807.115. (1) The Department of Transportation shall retain a [*duplicate*]
8 **digital** image of each photograph [*used*] **and signature shown** on a driver
9 license under the provisions of ORS 807.110 or an identification card under
10 ORS 807.400.

11 “(2) The [*duplicates*] **digital images of photographs** may not be made
12 available to anyone other than law enforcement officials, **motor vehicle**
13 **agencies from other states** and employees of the department acting in an
14 official capacity.

15 “**SECTION 17.** ORS 807.400 is amended to read:

16 “807.400. (1) The Department of Transportation shall issue an identifica-
17 tion card to any person who:

18 “(a) Is domiciled in or is a resident of this state, as described in ORS
19 807.062;

20 “(b) As required by ORS 807.021 and 807.730, provides the Social Security
21 number assigned to the person by the United States Social Security Admin-
22 istration and proof of legal presence in the United States or, if the person
23 is not eligible for a Social Security number, proof of legal presence in the
24 United States and proof that the person is not eligible for a Social Security
25 number;

26 “(c) Does not have a current, valid driver license;

27 “(d) Furnishes evidence of the person’s full legal name[, *age and identity*
28 *as the department may require*] **and date of birth**; and

29 “(e) Submits to collection of biometric data by the department that es-
30 tablish the identity of the person as provided in ORS 807.024.

1 “(2) The department shall work with other agencies and organizations to
2 attempt to improve the issuance system for identification cards.

3 “(3) Every original application for an identification card must be signed
4 by the applicant. The department shall require proof to verify the address
5 of an applicant for issuance of an identification card in addition to other
6 documents the department may require of the applicant. If the address of an
7 applicant has changed since the last time an identification card was issued
8 to or renewed for the applicant, the department shall require proof to verify
9 the address of the applicant for renewal of an identification card, in addition
10 to anything else the department may require. The department shall adopt
11 rules to identify what constitutes proof of address for purposes of this sub-
12 section. [*Verification of*] Proof of address may include, but is not limited to,
13 providing a utility bill, a tax return, a record from a financial institution,
14 a proof of insurance card or a health benefits card, a selective service card,
15 a mortgage document or a lease agreement. The applicant may provide the
16 proof of address by submitting proof in the form of an original document or
17 a copy of a document, use an electronic device to display proof of address,
18 or provide proof through the use of a third party address verification system.

19 “(4) Every identification card shall be issued upon the standard **driver**
20 license form described under ORS 807.110 and shall bear a statement to the
21 effect that the identification card is not a **driver** license or any other grant
22 of driving privileges to operate a motor vehicle and is to be used for iden-
23 tification purposes only. The department shall use the same security proce-
24 dures, processes, materials and features for an identification card as are
25 required for a **driver** license under ORS 807.110. The identification card is
26 not required to contain the residence address of persons listed in ORS 807.110
27 (1)(e).

28 “(5) If the identification card is a limited term identification card issued
29 under ORS 807.730, the limited term identification card shall indicate:

30 “(a) That it is a limited term identification card; and

1 “(b) The date on which the limited term identification card expires.

2 “(6) Upon order of the juvenile court, the department shall include on the
3 card the fact that the person issued the identification card is an emancipated
4 minor.

5 “(7) Upon request of the person to whom the identification card is issued
6 and presentation of proof, as determined by the department by rule, that the
7 person is a veteran, as defined in ORS 408.225, the department shall include
8 on the card the fact that the person is a veteran.

9 “(8) Each original identification card shall expire on a date consistent
10 with the expiration dates of licenses as set forth in ORS 807.130.

11 “(9) Identification cards shall be renewed under the terms for renewal of
12 licenses as set forth in ORS 807.150.

13 “(10) The fee for an original identification card or a renewal thereof shall
14 be the fee established under ORS 807.410.

15 “(11) An identification card becomes invalid if the holder of the card
16 changes the holder’s residence address from that shown on the identification
17 card and does not provide the department with notice of the change as re-
18 quired under ORS 807.420.

19 “(12) If a person to whom an identification card was issued and who
20 changes the person’s residence address appears in person at a department
21 office that issues identification cards, the department may do any of the
22 following:

23 “(a) Issue a replacement identification card containing the new address
24 upon receipt of the old identification card and payment of the fee established
25 for issuing a replacement identification card with a changed address under
26 ORS 807.410. Except as otherwise provided in subsection (14) of this section,
27 the replacement identification card shall bear the same distinguishing num-
28 ber as the card being replaced.

29 “(b) Note the new address on the old identification card in a manner to
30 be determined by the department by rule.

1 “(13) An identification card becomes invalid if the holder of the card
2 changes the holder’s name from that shown on the card, including a change
3 of name by marriage, without providing the department with notice of the
4 change as required under ORS 807.420. Upon receiving such notice and the
5 old identification card, the department shall issue a replacement identifica-
6 tion card upon payment of the fee required under ORS 807.410.

7 “(14) In the event that, for a reason identified by the department by rule,
8 a person needs a replacement identification card that bears a distinguishing
9 number different from the number on the card being replaced, the person to
10 whom the card was issued may obtain a replacement card from the depart-
11 ment upon furnishing proof satisfactory to the department of the need for
12 such replacement and payment of the replacement fee under ORS 807.410.

13 “(15) If a person furnishes proof that the person is a veteran, as defined
14 in ORS 408.225, and the person’s identification card does not include the fact
15 that the person is a veteran, the department shall issue a replacement iden-
16 tification card that includes the fact that the person is a veteran.

17 “(16) The department may establish by rule reasons for issuing replace-
18 ment identification cards that are in addition to the reasons identified in
19 subsections (12) to (15) of this section. The fee for a replacement identifica-
20 tion card is provided under ORS 807.410.

21 “(17) Upon cancellation of an identification card, the card is terminated
22 and must be surrendered to the department. An identification card may be
23 canceled for any of the reasons that driving privileges or a driver license
24 may be canceled under ORS 809.310. The department may reissue an iden-
25 tification card canceled under this subsection when the applicant has satis-
26 fied all requirements for the identification card.

27 “(18) Notwithstanding any other provision of this section, the department
28 may issue an identification card to a person under this subsection without
29 charge when the person surrenders the person’s driver license or driver per-
30 mit to the department for reasons described in this subsection. If the de-

1 department issues an identification card under this subsection, the
2 identification card shall expire at the same time as the surrendered driver
3 license or driver permit would have expired. An identification card issued
4 under this subsection is subject to the same requirements and fees for re-
5 newal or upon expiration as any other identification card issued under this
6 section. The department may issue identification cards under this subsection
7 for any of the following reasons:

8 “(a) The person voluntarily surrenders the person’s driver license or
9 driver permit to the department based upon the person’s recognition that the
10 person is no longer competent to drive.

11 “(b) The person’s driving privileges are suspended under ORS 809.419 (1).
12 This paragraph only applies if the person voluntarily surrenders the person’s
13 driver license or driver permit to the department as provided under ORS
14 809.500.

15 **“(19) If a person is applying for an identification card that is a Real**
16 **ID, the person must comply with the requirements under the vehicle**
17 **code for issuance of Real IDs.**

18 **“SECTION 18.** ORS 807.730 is amended to read:

19 “807.730. (1) The Department of Transportation may issue or replace a
20 limited term driver license, limited term driver permit or limited term iden-
21 tification card only for a person who provides proof, as determined by the
22 department by rule, that the person is legally present in the United States
23 on a temporary basis.

24 “(2) A limited term driver license or limited term identification card is
25 valid:

26 “(a) During the applicant’s authorized stay in the United States, but no
27 longer than eight years from the date of issuance; or

28 “(b) If there is no definite end to the authorized stay, for a period of one
29 year.

30 “(3) A limited term driver permit is valid:

1 “(a) During the applicant’s authorized stay in the United States, but no
2 longer than the period of time for which a driver permit of the same type is
3 issued by the department.

4 “(b) If there is no definite end to the authorized stay, for a period of one
5 year but no longer than the period of time for which a driver permit of the
6 same type is issued by the department.

7 “(4) A limited term driver license, limited term driver permit or limited
8 term identification card may be renewed only upon presentation of valid
9 documentation, as determined by the department by rule, that the status by
10 which the applicant qualified for the limited term driver license, limited term
11 driver permit or limited term identification card has been extended or is still
12 in effect.

13 “(5) A limited term driver license or limited term driver permit grants the
14 same privileges as a driver license or driver permit.

15 “(6) A limited term identification card shall bear a statement to the effect
16 that the limited term identification card is not a license or any other grant
17 of driving privileges to operate a motor vehicle and is to be used for iden-
18 tification purposes only.

19 “(7) **A limited term driver license or limited term identification card**
20 **shall clearly indicate that it is a limited term driver license or limited**
21 **term identification card and indicate the date on which it expires.**

22 “**SECTION 19.** ORS 807.130 is amended to read:

23 “807.130. (1) A license that is issued as an original license and not as a
24 license that is renewed expires on the anniversary of the licensee’s birthday
25 in the eighth calendar year after the year of issuance.

26 “(2) A license that is renewed under ORS 807.150 expires eight years from
27 the specified expiration date of the immediately preceding license.

28 “(3) Notwithstanding subsections (1) and (2) of this section, a license that
29 is issued to a person who is not a citizen or permanent legal resident of the
30 United States expires on the date the licensee is no longer authorized to stay

1 in the United States, as indicated by the documentation the person presented
2 to the Department of Transportation to provide proof of legal presence in the
3 United States as required by ORS 807.021 and 807.730[,] **or proof of lawful**
4 **status in the United States as required by section 4 of this 2017 Act,**
5 but no longer than eight years from the date of issuance or, if there is no
6 definite end to the authorized stay, after a period of one year.

7 “(4) Subsection (3) of this section does not apply to a person who is a
8 citizen of a country with a Compact of Free Association with the United
9 States and who provides proof of legal presence in the United States as de-
10 fined by the department by rule.

11 “(5) **Notwithstanding subsection (4) of this section, a Real ID issued**
12 **to a person who is a citizen of a country with a Compact of Free As-**
13 **sociation with the United States expires on the date the licensee is no**
14 **longer authorized to stay in the United States, as indicated by the**
15 **documentation the person presented to the department or, if there is**
16 **no definite end to the authorized stay, after a period of one year.**

17 “[5] (6) A license that has expired does not grant driving privileges and
18 is not valid evidence of driving privileges.

19 “**SECTION 20. (1) Sections 3 to 9 of this 2017 Act and the amend-**
20 **ments to ORS 807.021, 807.022, 807.024, 807.040, 807.050, 807.110, 807.115,**
21 **807.130, 807.400 and 807.730 by sections 10 to 19 of this 2017 Act become**
22 **operative July 1, 2020.**

23 “(2) **The Department of Transportation may take any action before**
24 **the operative date specified in subsection (1) of this section that is**
25 **necessary to enable the department to exercise, on and after the op-**
26 **erative date specified in subsection (1) of this section, all the duties,**
27 **powers and functions conferred on the department by sections 3 to 9**
28 **of this 2017 Act and the amendments to ORS 807.021, 807.022, 807.024,**
29 **807.040, 807.050, 807.110, 807.115, 807.130, 807.400 and 807.730 by sections**
30 **10 to 19 of this 2017 Act.**

1 **“SECTION 21. The section captions used in this 2017 Act are pro-**
2 **vided only for the convenience of the reader and do not become part**
3 **of the statutory law of this state or express any legislative intent in**
4 **the enactment of this 2017 Act.**

5 **“SECTION 22. This 2017 Act being necessary for the immediate**
6 **preservation of the public peace, health and safety, an emergency is**
7 **declared to exist, and this 2017 Act takes effect on its passage.”.**
