**PROPOSED AMENDMENTS TO  
SENATE BILL 89**

1 On page 4 of the printed bill, delete lines 44 and 45 and insert:

2 **“SECTION 3.** ORS 293.226 is amended to read:

3 “293.226. (1) Subject to subsection (2) of this section, a state agency [*that*  
4 *requests a person to*] **may request that a person** voluntarily supply the  
5 person’s Social Security number **for use in collecting debts owed to the**  
6 **State of Oregon** on any document relating to any monetary obligation or  
7 transaction. **A state agency that so requests shall** [*may*] include on the  
8 document a notice disclosing that the Social Security number **is requested**  
9 **for and** may be used for state agency debt collection activities.

10 “(2) The Oregon Department of Administrative Services shall adopt rules:

11 “(a) Specifying the form of the notice, including provisions specifying  
12 when the notice must state [*that*] **whether** the disclosure of a Social Security  
13 number is voluntary **or mandatory**; and

14 “(b) Setting procedures for the sharing of Social Security numbers be-  
15 tween state agencies, **and between the Department of Revenue** and pri-  
16 vate collection agencies, for the purpose of collecting debts owed state  
17 agencies.

18 “(3) If a person is required to provide the person’s Social Security number  
19 to [*the requesting*] **a state agency** under federal or state law **for purposes**  
20 **other than collection of a debt owed to the State of Oregon**, [*this section*  
21 *does not apply.*] **the agency may not use the Social Security number for**

1 **debt collection purposes, except:**

2 **“(a) When the agency requests that the person voluntarily disclose**  
3 **the person’s Social Security number for the purpose of collecting debts**  
4 **owed to the State of Oregon, the agency provides the notice required**  
5 **under subsection (1) of this section and the person subsequently vol-**  
6 **untarily provides the person’s Social Security number; or**

7 **“(b) When otherwise allowed under state or federal law.**

8 “(4) A state agency, the Department of Revenue [*under ORS 293.250*] or  
9 a private collection agency [*assigned*] **that is collecting** a liquidated and  
10 delinquent account [*under ORS 1.197 or 293.231*] may use a Social Security  
11 number collected under this section, or collected as otherwise allowed by  
12 law, to collect any debt owed a state agency or local government by the  
13 person associated with the Social Security number.

14 “(5) Nothing in this section authorizes a state agency, the Department of  
15 Revenue or a private collection agency [*assigned an*] **that is collecting a**  
16 **liquidated and delinquent** account [*under ORS 1.197, 293.231 or 293.250*] to  
17 use or disclose a Social Security number for any reason other than a reason  
18 specified in this section.

19 “(6) Rules adopted under subsection (2) of this section do not apply to  
20 state courts and commissions, departments and divisions in the judicial  
21 branch of state government, the Secretary of State or the State Treasurer.

22 “(7) Except as provided in subsection (6) of this section, as used in this  
23 section, ‘state agency’ means any state officer, board, commission, corpo-  
24 ration, institution, department or other state organization.”.
