#### Public Hearing and Possible Work Session

- HB 4005 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2-5-2018 AGENDA: Requires prescription drug manufacturer to report annually information to Department of Consumer and Business Services regarding prices of prescription drugs and costs associated with developing and marketing prescription drugs.
- HB 4156  
Prohibits carriers offering health benefit plans from making specified changes to prescription drug coverage during plan year.
- HB 4137 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires Alcohol and Drug Policy Commission to report to interim committees of Legislative Assembly, no later than September 15, 2018, its comprehensive addiction, prevention, treatment and recovery plan.
- HB 4135  
Establishes Advance Directive Adoption Committee for purpose of adopting form of advance directive to be used in this state.
- HB 4018  
Makes governing body of coordinated care organization subject to Oregon's public meetings law.

**At the conclusion of the hearings listed above, the committee will recess until 6:00 p.m., at which time the meeting will resume and proceed as follows:**

- HJR 203 \*\* \*\*Subsequent Referral(s) to Rules  
Proposes amendment to Oregon Constitution establishing obligation of state to ensure every resident of state access to effective, medically appropriate and affordable health care.
