HB 4020 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Specifies criteria for licensing of extended stay centers and requires Oregon Health Authority to adopt rules.

#### Work Session

HB 4005 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2-7-2018 AGENDA: Requires prescription drug manufacturer to report annually information to Department of Consumer and Business Services regarding prices of prescription drugs and costs associated with developing and marketing prescription drugs.

HB 4137 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2-7-2018 AGENDA: Requires Alcohol and Drug Policy Commission to report to interim committees of Legislative Assembly, no later than September 15, 2018, its comprehensive addiction, prevention, treatment and recovery plan.

HB 4018  
CARRIED OVER FROM THE 2-7-2018 AGENDA: Makes governing body of coordinated care organization subject to Oregon's public meetings law.

#### Public Hearing and Possible Work Session

HB 4133 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Maternal Mortality and Morbidity Review Committee to conduct studies and reviews of incidence of maternal mortality and severe maternal morbidity.

HB 4103  
Limits pharmacy benefit managers' ability to require or encourage enrollees to fill or refill prescription drugs at mail order pharmacy.

HB 4156  
CARRIED OVER FROM THE 2-7-2018 AGENDA: Prohibits carriers offering health benefit plans from making specified changes to prescription drug coverage during plan year.

HB 4135

CARRIED OVER FROM THE 2-7-2018 AGENDA: Establishes Advance Directive Adoption Committee for purpose of adopting form of advance directive to be used in this state.

HB 4003

Requires certain public improvement contracts to meet certain requirements related to use of diesel engines in course of performing public improvement contract.
