CARRIED OVER FROM THE 2-12-2018 AGENDA: Specifies criteria for licensing of extended stay centers and requires Oregon Health Authority to adopt rules.
- HB 4133 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2-12-2018 AGENDA: Establishes Maternal Mortality and Morbidity Review Committee to conduct studies and reviews of incidence of maternal mortality and severe maternal morbidity.
- HB 4003  
CARRIED OVER FROM THE 2-12-2018 AGENDA: Requires certain public improvement contracts to meet certain requirements related to use of diesel engines in course of performing public improvement contract.
- HB 4103  
CARRIED OVER FROM THE 2-12-2018 AGENDA: Limits pharmacy benefit managers' ability to require or encourage enrollees to fill or refill prescription drugs at mail order pharmacy.
- HB 4151 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2-12-2018 AGENDA: Requires state agencies that purchase prescription drugs and Public Employees' Benefit Board, Oregon Educators Benefit Board, Public Employees Retirement System and Oregon Health and Science University to purchase prescription drugs through Oregon Prescription Drug Program.
- HB 4018  
CARRIED OVER FROM THE 2-12-2018 AGENDA: Makes governing body of coordinated care organization subject to Oregon's public meetings law.
