**Subsequent Referral(s) to Ways and Means

Provides proceedings to escheat to State of Oregon matured United States savings bonds presumed abandoned and in custody of state.

HB 4083

Creates tax credit for short line railroad rehabilitation projects.

HR 4109

Allows credit against net income taxes for portion of eligible costs of newly constructed single-family dwelling that sells for price affordable to household with annual income at or below 120 percent of area median income.

HB 4139 **

**Subsequent Referral(s) to Ways and Means

Imposes tax on rental price of construction, mining, earthmoving or industrial equipment, together with attachments and other equipment and tools, that is mobile and held primarily for rental.

HB 4026

CARRIED OVER FROM THE 2-07-2018 MEETING: Modifies disposition of certain estimated excess corporate excise tax revenues by dividing estimated excess between Education Stability Fund and Oregon Rainy Day Fund.

CARRIED OVER FROM THE 2-07-2018 MEETING: Modifies annual limitation on total amount of tax credits for production or collection of bovine manure allowed for all taxpayers by tying limitation to calendar year instead (tax year.

HB 4078

CARRIED OVER FROM THE 2-07-2018 MEETING: Provides that "eligible location," for purposes of certain property tax benefits, includes location not formerly used for industrial purposes.
