SB 1507 \*\*

#### \*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 2-12-2018 MEETING: Requires Environmental Quality Commission to adopt by rule program that places cap on greenhouse gas emissions and that provides market-based mechanism for covered entities to demonstrate compliance. 1508 \*\* \*\*Subsequent Referral(s) to Ways and Means

## SB 1508 \*\*

Requires Environmental Quality Commission to establish fee applicable to certain air contamination sources to cover direct and indirect costs of Department of Environmental Quality and commission in developing and implementing a program and rules to reduce public health risks of emissions of toxic air contaminants from industrial and commercial air contamination sources.

SB 1509

CARRIED OVER FROM THE 2-12-2018 MEETING: Provides additional exception to prohibition on commercial vehicle idling.

SB 1550

Authorizes State Fish and Wildlife Commission to adopt record keeping requirements for person engaged in taking, landing, buying or selling of food fish for commercial purposes or otherwise dealing in food fish for commercial purposes.

SB 1533

Allows facility providing therapy or counseling that incorporates activities utilizing nonclinical setting to be established in area zoned for exclusive farm use if certain conditions are met. 1541 \*\* \*\* Subsequent Referral(s) to Ways and Means

SB 1541 \*\*

Authorizes Environmental Quality Commission to adopt program and rules to reduce public health risks of emissions of toxic air contaminants from industrial and commercial air contamination sources.
