HB 4087 A

Requires person, before creating, attaching, asserting or claiming lien on motor vehicle, to have in effect bond of not less than \$20,000 for purpose of paying owner of motor vehicle full amount of damages, costs, reimbursements or attorney fees owner obtains in action to obtain release or restored title to motor vehicle.

HB 4008 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Makes calculation of projected future earning potential of plaintiff that takes into account race or ethnicity of plaintiff inadmissible in civil action.

HB 4050 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Consolidates provisions prohibiting commercial transactions related to cockfighting equipment.

HB 4056 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Distributes civil forfeiture proceeds to scholarship program for children of deceased or disabled public safety officers.

HB 4094 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Provides that affidavit submitted to court in support of petition for approval of settlement of personal injury claim of incapacitated person, minor or decedent is confidential.

HB 4097 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Modifies provisions relating to law libraries and law library services provided by certain counties.

HB 4116 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Modifies definitions, exceptions and affirmative defenses applicable to offense of driving a motor vehicle while using a mobile electronic device.

HB 4149 A

CARRIED OVER FROM THE 2/23/2018 AGENDA: Prohibits prosecuting attorney from conditioning plea offer on requirement that defendant or defense attorney stipulate to unconstitutionality of existing law.
