**Measure Description:**

Adjusts certain fees imposed by Department of Transportation.

**Impact Explanation:**

The measure makes statutory changes to DMV fees. The measure aligns fees for similar transactions consistent across Oregon statutes, and changes nine fees by rounding up to whole dollar amounts. The measure reinstates the registration fee for vehicles 8,000 pounds or less registered with quarterly tow/recovery registration, which authority was inadvertently deleted in the 2017 session. Finally, the bill requires DMV to routinely report to the legislature regarding costs for products and services and their associated fees. The increase fees will pay for DMV costs that otherwise would be subsidized by the highway fund.
