Oregon House Committee on Energy and Environment :

This is being written in support of a total rejection of the proposals being made from the authors and special interest groups supporting this flawed and fraudulent measure.

The arguments concerning atmospheric CO2 changing the climate have been fronted and tested after over 20 years of running climate models and their predictions pinned against reality. The results clearly show the modeling has failed and does not support the notion that atmospheric CO2 is causing the claimed climate effects of rising temperatures or any other weather events we have been able to measure. Those results have shown that temperatures have quit rising to any statistical significance in 20 years of global temperature records tracked by orbiting satellites with the exception of two back to back El Ninio events in 2015 and 2016. This means the warming linear trend line starting from the beginning of the record in 1979 when there was warming until 1998 continues to lessen, contrary to failed climate models that predicted continued steady warming as atmospheric CO2 continues to rise. The UAH satellite temperature record is included with this e-mail and it's examination self evident and proves climate modeling has failed, the only tool that supports this failed notion. Also included is the computer climate simulations initialized in 1998 that show the predicted temperatures of the surface records are off by a factor of more than 2 when compared to 2015 and there is now also reason to believe the temperature trends of all the surface data sets have been altered to closer reflect the failed modeling rather than the satellite trends which show a temperature stasis since 1998. Supporting evidence can be found concerning the unjustified temperature manipulations by watching the video presentation of quality control electrical engineer Tony Heller who has analyzed the NOAA and NASA GISS surface temperature records and compared them to the unadjusted sets.
