

# Prosperity 1000

HB 4042: Oregon's Solution to Pressing Workforce and Poverty Concerns in the Portland Metro Area

Legislation to invest \$5 million to address poverty caused by a reduction in middle-income employment resulting in 50% match in federal funding for training and jobs and establishing a sustainable system within Oregon's public workforce system that supports individual and business prosperity.

### The Problem

- Squeezed out middle class Structural changes in Oregon's
  economy have increased low-income employment, widening
  economic disparity and disproportionately affecting immigrants
  and people of color. This crisis is most accelerated in Portland
  Metro area; East Multnomah County and the City of Hillsboro
  have the highest concentrations of poverty in the state.
- 2) <u>Increasing poverty</u>— In the new economy, marked by increasing income polarization, "average" economic measures obscure the current poverty crisis. 600,000 Oregonians live in poverty and Portland has the third highest rate of people receiving Supplemental Nutrition Assistance Program (SNAP) of any major metro area, following only Detroit and Miami.
- Shortage of skilled workers
   Employers grapple with a shortage of skilled labor to drive productivity and growth while unskilled residents struggle with insufficient, stagnating wages.
- 4) <u>Significant cuts in Federal Funding</u>— The coming years will be marked by cuts to federal employment and training, anti-poverty and related support programs, reducing the state's ability to meaningfully address poverty, inequity, and skill shortages

#### **The Solution**

Prosperity 1000 will generate investment into the Portland Metro Area through the WorkSource Oregon SNAP 50/50 program which leverages a 50% federal match for training and employment services provided to SNAP recipients.

<u>Address growing poverty</u> caused by declining middle-income employment, through skill development and career-track employment in targeted sectors that have quality jobs and shortages of skilled labor

**<u>Restore federal funding</u>** by evoking a 50% match in federal funding for training and jobs

<u>Pilot a sustainable system</u> within the public workforce system that supports individual and business prosperity

This investment will support a pilot to establish the program infrastructure, key partnerships, and implementation of a federal matching program that will support Oregon's public workforce development system and address poverty long after Prosperity 1000.

## **The Outcome**

1000 Oregonians experiencing poverty will receive occupational training and job placement into target industries with 75% earning \$15/hour or more.
