SUMMARY

Extends sunset on long term care facility assessment to 2026. Removes limitation on penalties imposed on long term care facilities for failing to file reports or pay assessments. Authorizes Department of Human Services to adopt separate reimbursement methodology for patients with complex medical needs. Repeals provisions authorizing increased reimbursement for decreases in bed capacity. Reduces reimbursement of long term care facility costs to 62nd percentile of rebased allowable costs.

Declares emergency, effective on passage.

- Be It Enacted by the People of the State of Oregon:
- **SECTION 1.** Section 19, chapter 736, Oregon Laws 2003, is amended to 8 read:
- 9 **Sec. 19.** (1) A long term care facility that fails to file a report or pay an
- assessment under section 16, [of this 2003 Act] chapter 736, Oregon Laws
- 2003, by the date the report or payment is due shall be subject to a penalty
- of \$500 per day of delinquency. [The total amount of penalties imposed under
- 13 this section for each reporting period may not exceed five percent of the as-
- 14 sessment for the reporting period for which penalties are being imposed.]
- 15 (2) Penalties imposed under this section shall be collected by the De-
- 16 partment of Human Services and deposited in the Department of Human
- 17 Services Account established under ORS 409.060.

- 1 (3) Penalties paid under this section are in addition to and not in lieu of
- 2 the assessment imposed under section 16, [of this 2003 Act] chapter 736,

- [(c)] (C) Continuing the use of the complex medical needs additional

- 16 when calculating the pediatric rate in [paragraph (b) of this subsection]
- 17 subparagraph (B) of this paragraph.
- 18 [(5)(a) The department shall reimburse costs using the methodology de-
- 19 scribed in subsection (4) of this section at a rate not lower than a percentile
- 20 of allowable costs for the period for which the reimbursement is made.]
- 21 (b) In addition to the reimbursement methodology described in
- 22 paragraph (a) of this subsection, the department may adopt and im-
- 23 plement rates applicable to patients with complex medical needs for
- 24 which the reimbursement methodology described in paragraph (a) of
- 25 this subsection is insufficient.
- 26 **(5)** For the period beginning July 1, [2013] **2018**, and ending June 30,
- 27 [2016] **2026**, the department shall reimburse costs at a rate not lower than
- 28 the [63rd] **62nd** percentile of rebased allowable costs for that period.
- 29 [(c) For each three-month period beginning on or after July 1, 2016, in
- 30 which the reduction in bed capacity in Medicaid-certified long term care fa-
- 31 cilities is less than 1,500 in bed capacity statewide that existed on the effective

- 1 date of this 2013 Act, the department shall reimburse costs at a rate not lower
- 2 than the percentile of allowable costs according to the following schedule:]
- 3 [(A) 62nd percentile for a reduction of 1,350 or more beds.]
- 4 [(B) 61st percentile for a reduction of 1,200 or more beds but less than 1,350
- 5 beds.]
- 6 [(C) 60th percentile for a reduction of 1,050 or more beds but less than 1,200
- 7 *beds*.]
- 8 [(D) 59th percentile for a reduction of 900 or more beds but less than 1,050
- 9 *beds*.]
- 10 [(E) 58th percentile for a reduction of 750 or more beds but less than 900
- 11 *beds*.]
- 12 [(F) 57th percentile for a reduction of 600 or more beds but less than 750
- $13 \quad beds.$
- 14 [(G) 56th percentile for a reduction of 450 or more beds but less than 600
- 15 *beds*.]
- 16 [(H) 55th percentile for a reduction of 300 or more beds but less than 450
- 17 *beds*.]
- 18 [(I) 54th percentile for a reduction of 150 or more beds but less than 300
- 19 beds.
- [(J) 53rd percentile for a reduction of 1 to 149 beds.]
- 21 [(6) A reduction in the percentile ceiling of allowable costs reimbursed un-
- 22 der subsection (5) of this section is not subject to ORS 410.555.]
- 23 SECTION 5. Section 26, chapter 608, Oregon Laws 2013, is repealed.
- SECTION 6. The amendments to sections 19, 23, 24 and 31, chapter
- 25 736, Oregon Laws 2003, by sections 1 to 4 of this 2018 Act and the repeal
- of section 26, chapter 608, Oregon Laws 2013, by section 5 of this 2018
- 27 Act become operative July 1, 2018.
- SECTION 7. This 2018 Act being necessary for the immediate pres-
- 29 ervation of the public peace, health and safety, an emergency is de-
- 30 clared to exist, and this 2018 Act takes effect on its passage.
