Whereas:

All residents of Oregon may attend any Community College in Oregon But:

- There are real estate properties in the State of Oregon that are outside the boundaries of and not taxed by any Community College District
- 2. Residents outside of a Community College District may not sit on the Board of a Community College
- 3. Residents outside of a Community College District may not vote in an election of Members of the Board of a Community College District


The following Bill is proposed:

Community College boundaries shall be re-drawn so that all real estate property in the State of Oregon shall be designated to exist within a Community College District, be taxable by it, and residents eligible to stand for election to a Community College Board and to vote for its members.

Currently, Grant County receives community college services through Contracts Out-of-District (CODs) with Blue Mountain Community College.

Lake County receives community college services through CODs with Klamath Community College.

The city of Burns and Harney County receive community college services through CODs with Treasure Valley Community College.



The Lane Community College District serves a 5,000 square-mile area stretching from the Pacific Ocean to the Cascade Mountains. The district includes most of Lane County, as well as the Monroe Elementary School District in Benton County, the Harrisburg Union High School District in Linn County and a small area in northern Douglas County. The total district population includes about 300,000 people.

- 3 Be It Enacted by the People of the State of Oregon:
- SECTION 1. (1) As used in this section, "community college district" has the meaning given that term in ORS 341.005.
- (2) The Higher Education Coordinating Commission, in consultation with the Director of the Office of Community Colleges and Workforce Development, shall develop a plan to ensure that all real property in this state is located is within a community college district.
 - (3) The commission shall prepare and submit a report detailing the plan developed under subsection (2) of this section, including any proposed legislation necessary to carry out the plan, to the interim legislative committees on higher education no later than September 15, 2018.
 - SECTION 2. Section 1 of this 2017 Act is repealed on January 2, 2020.
