Additional property recording insights from OACC (relating to Section 12 of HB 4007)

The Oregon Association of County Clerks (OACC) seeks to add clarity to questions regarding which documents recorded in Oregon have the Affordable Housing fee applied currently.

With that goal in mind, we retrieved the list of documents recorded in 2017 across 15 counties that offer a good cross-section. These 15 counties range in size and include Coastal, Metro, Valley, Central and Eastern Oregon Counties. The 15 counties include: Benton, Columbia, Coos, Deschutes, Douglas, Jackson, Josephine, Lane, Linn, Malheur, Multnomah, Polk, Tillamook, Washington, and Yamhill Counties.

These 15 lists of recorded documents were flagged with the qualifier of whether or not they received the Affordable Housing fee.

We assembled a single combined report from all 15 lists. When reviewing the report there are a few key things to remember:

- A. Not all counties list documents in their receipting systems with exactly the same text (some abbreviate words, some pool like documents in sub-type categories, etc.)
- B. Some document types are exempt from the fee – while some entities are exempt from paying the fee.
 - a. All “Federal Tax Lien” documents are exempt
 - b. But, a standard “Lien” is only exempt when filed by an exempt entity
- C. Some recordings are exempt by local laws in accordance with 205.323(2)(a) & (c).
- D. We intentionally kept some documents listed in a singular manner from those listed in the plural (like “Lien” vs. “Liens”) as there are occasions where multiple titles are recorded within the same filing.

Following this cover letter, please find an alphabetical listing of all property documents recorded in 2017 across the specified 15 counties.
