### **STATE GRANT FUNDING – 2017-19**

### Oregon Opportunity Grant - \$145.9 million (GF+LF)

- \$125.2 million General Fund
- \$20.7 million Lottery Funds (Ed Stability Fund interest)
- Current service level (3.7% increase over 2015-17)
- 2015-17 LAB = \$140.9 million

### Oregon Promise Grant - \$40 million (GF)

- = \$34.7 million from SB 5524 + \$5.3M from HB 5006
- 2015-17 LAB = \$12 million est. (Original = \$9.5 million grants + \$0.5 million admin; Supplemental = \$2 million)



### **STATE GRANTS – POPULATIONS SERVED**

**Oregon Opportunity Grants** – Oregon resident undergraduates with demonstrated financial need who meet other eligibility requirements and attend an eligible Oregon postsecondary institution at least half time.

Awards available for up to 4 years at full-time, full-year enrollment; awards prorated for half-time and partialyear enrollment.

**Oregon Promise Grants** – Oregon resident undergraduates who attend an Oregon community college at least half time within 6 months of graduating high school or completing a GED.

> Awards available for up to 90 college credits attempted.



Advisory Groups

- Oregon Promise Advisory Group 6 financial aid directors, 3 representatives from CC student support services.
- Oregon Student Aid Advisory Group 4 for each sector: 2 financial aid directors, 1 administrator, 1 representative from constituency organization. Also includes a representative from the Oregon Student Association.

## **OREGON OPPORTUNITY GRANT (OOG)**

Oregon's only state-funded, need-based grant program to help low-income Oregonians achieve their academic goals.

- •No age restrictions
- EFC limits : \$4000 for 2016-17; \$3500 for 2017-18 (estimated)
- Maximum award for 2016-17 and 2017-18 = \$2250\*
- Used at all eligible public and private nonprofit Oregon colleges and universities.

**GOAL:** To increase college enrollment, completion, and affordability for Oregon students who have demonstrated financial need.



\*Based on full-time (12 credit/term) full-year enrollment.

# ELIGIBLE STUDENTS - OOG

- <u>U.S. citizen or permanent noncitizen resident\*</u>
- Oregon resident and out-of-state members of certain tribes with historical ties to Oregon
- Attend <u>eligible 2- or 4-year public/private</u> nonprofit postsecondary institution located & headquartered in Oregon
- Undergraduate with no prior baccalaureate degrees, enrolled at least half time
- Demonstrated <u>financial need</u>
- Foster youth prioritized awards, regardless of FAFSA filing date, start of enrollment, or EFC
- Up to equivalent of 12 terms or 8 semesters at full-time enrollment, prorated for half-time enrollment.



\* Also students eligible for in-state tuition under Tuition Equity guidelines.



In 2016-17, 42,271 lowincome students received OOG funds totaling approximately \$71.7 M.

Based on Fall 2017 data, approximately 39,300 students will receive an estimated \$68 M during the 2017-18 academic year.



### TOTAL OOG DISBURSEMENTS BY SECTOR -2005-06 TO 2016-17




\$33.9 M disbursed in 2016-17 vs. \$26.5 M disbursed in 2015-16 to students at Oregon community colleges.

\$32.6 M disbursed in 2016-17 vs. \$32.9 M disbursed in 2015-16 to students at Oregon public universities.

\$5.0 M disbursements to Oregon private colleges and universities in both 2016-17 and 2015-16.





### OREGON PROMISE GRANT

MERIT & NEED BASED AID

# **OREGON PROMISE (OPG)**

Provides grants to support most community college tuition costs for recent high school graduates and GED recipients.

- Established by Senate Bill 81 (2015) to "provide a waiver of tuition for community college courses."
- Grants apply after Federal Pell and Oregon Opportunity Grant ("last dollar" model).
- Students eligible for up to 90 credits attempted (i.e. up to 2 years, or more, at full-time enrollment).
- Grant sizes range from minimum of \$1,000 to maximum of \$3,540 in 2017-18 (based on average CC tuition) for 12 credits.

GOAL: To increase college enrollment, completion, and affordability for recent high school graduates and GED recipients.



### OPG – ELIGIBILITY CRITERIA



Be a recent Oregon high school graduate or GED recipient



Be an Oregon resident at least 12 months prior to attendance



Have 2.5 cumulative GPA or higher



Plan to attend an Oregon community college within 6 months of graduation



Must not have more than 90 college credits completed or attempted



Starting in 2017-2018, eligibility may be determined by the student's Expected Family Contribution (EFC). EFC limits are subject to change.



### ADDITIONAL CHANGES: WAIVERS

OSAC has established a 6 –month enrollment waiver process for rare circumstances:

- Student: serious illness/injury
- Immediate family member: serious illness, injury, or death
- Active military duty, or training (including national guard)
- Major natural disaster
- Service in certain career and technical student organizations related to farming (including Future Farmers of America)



# HOW DOES THE EXPECTED FAMILY CONTRIBUTION (EFC) CRITERIA IMPACT 2017-18 APPLICANTS?

The EFC limit for new 2017-18 applicants is <u>\$20,000\*</u>. With this EFC limit, OSAC was able to award approximately 4 out of 5 eligible new applicants in Fall 2017.






### Oregon Promise pays remaining tuition after: Federal Pell Grant & Oregon Opportunity Grant



### MOST STUDENTS IN COHORT 1 COMPLETED ALL REQUIREMENTS

	70% of fall recipients ✓ Enrolled for three terms ✓ Enrolled in at least 6 credits each term ✓ Completed the first-year experience
Retention and term requirements	<ul> <li>87 percent of fall students enrolled in winter term</li> <li>74 percent of fall students enrolled 3 consecutive terms</li> </ul>

### NEARLY ALL STUDENTS WITH REMAINING ELIGIBILITY RETURNED FOR YEAR 2



84% of Cohort 1 students who completed all requirements and were not at the 90-credit limit returned in year 2

An additional **9%** (424 students) had less than one full term of remaining eligibility at the end of year 1 (fewer than 12 credits)



### HOWEVER, SOME STUDENTS DID NOT FULFILL REQUIREMENTS, USUALLY MISSING A TERM

#### 30% of students did not complete all requirements

- Nearly all missed one or more terms of enrollment
  - 44 percent missed winter and spring term
  - 50 percent missed spring term
- 94 percent of students who missed a term had not met the 90-credit limit

#### Some students applied for a second year of the program and were denied



# RENEWAL ELIGIBILITY

- **1. Complete the First-Year Experience** as directed by the community college.
- 2. Maintain **Satisfactory Academic Progress**, as determined by the community college.
- 3. Maintain at least half-time **continuous enrollment** (6 or more credits) during fall, winter and spring terms each year.
- 4. Complete any other requirements or requests from the community college in a timely manner.
- 5. Not exceed the maximum of 90 credits.
