PROPOSED AMENDMENTS TO HOUSE BILL 4031

Boone Donation Land Claim in township 3 8 south, range 1 west of the Willamette Meridian, said tract being also 9 in section 26, said township and range, described as follows: Beginning 10 at a point on the east donation land claim line 22.83 chains north of 11 the southeast corner of said claim, which point is the northeasterly 12 corner of the tract described in the deed recorded February 2, 1960, in 13deed book 566, page 0716; thence north 70 degrees west 603.9 feet to the 14 15northwesterly corner of said tract and a point in the east line of the tract described in the deed recorded November 4, 1927, in deed book 16 190, page 0495; thence north on the east line of said tract 1159.18 feet, 17 more or less, to the southerly line of the tract conveyed to Harry A. 18 Ross, et ux., by the deed recorded September 22, 1965, in deed book 663, 19 page 0311; thence north 61 degrees 45 east on the southerly line of said 20Ross tract to the east line of said donation land claim; thence south 21

- along said donation land claim line to the point of beginning. Excepting therefrom that portion conveyed to the State of Oregon, by and
 through its State Highway Commission by the deed recorded July 30,
 1969, as fee number 69014321.".

- 6 On page 3, line 2, delete "2" and insert "3".
- 7 In line 30, delete "3" and insert "4".
- 8 On page 4, line 13, delete "4" and insert "5".
- 9 In line 26, delete "5" and insert "6".
