On Feb 12 2018 at the house committee on business and labour (at 21:26 of the record) Rep Sherri Malstrom read into the record a statement from Commissioner Dick Schouten. The statement referred to section 2015-ors 656.027 (13) who are subject workers.

Mr Schouten and Rep Malstrom attempted to try and classify Portland winterhawks players as amateur under the rules of the OIC and USOC (olympic commeitties)

I would now submit to you that this section should apply to Portland and give cause NOT to pass HB 4093 for the reasons in the section that state the following.

A person who has been declared an amateur athlete under the rules of the United States Olympic Committee or the Canadian Olympic Committee and who receives no remuneration for performance of services as an athlete other than board, room, rent, housing, lodging or other reasonable incidental subsistence allowance,

Clearly this player has receive more money that is allowed under the act. We ask to vote NO for bill HB 4093 and have it dismissed.
