**Subject:** HB 5201 – Relating to state financial administration

Work Session Recommendations

HB 5201 is the budget reconciliation bill that adjusts the state budget for the 2017-19 biennium. Along with 2018 session budget decisions, the bill includes technical adjustments, and actions recommended by the Interim Joint Committee on Ways and Means.

The bill allocates \$96.9 million of the special purpose appropriation of \$100 million that was established for state agencies to cover employee compensation costs. This is expected to cover almost all the estimated General Fund costs for changes to the compensation plans of state agencies. Lottery Funds, Other Funds, and Federal Funds are also increased to cover costs associated with compensation plan changes.

Other actions include, but are not limited to:

- Establishes a \$30 million special purpose appropriation to be used for potential future costs in the Oregon Health Authority and the Department of Human Services.
- Appropriates \$27.5 million General Fund to cover the state's share of the costs of the 2017 fire season.
- Adds an additional \$15.7 million General Fund to support Child Welfare programs.
- Appropriates a total of \$6.4 million General Fund to the Department of Administrative Services for various local projects across the state.
- Provides \$5.2 million General Fund for emergency winter housing and shelter.
- Appropriates \$3.3 million General Fund to the Secretary of State and the Emergency Board for Ballot Measure 101 special elections costs.
- Gives \$3 million General Fund to OSU for Northwest National Marine Renewable Energy Center.
- Increases the General Fund support for the Oregon State Police by \$2.9 million for rebalance actions.
- Adds \$2.2 million General Fund for Mental Health Residential rates.

- Appropriates \$1.9 million for an Environmental Data Management System at the Department of Environmental Quality.
- Appropriates \$1.6 million to the Military Department to pay for disallowed federal charges at the Office of Emergency Management.
- Provides \$1.4 million to the Department of Administrative Services for a Carbon Policy Office.
