SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies and adds laws related to transportation.
Takes effect on 91st day following adjournment sine die.

8 sections 56, 59 and 119, chapter 750, Oregon Laws 2017; and prescribing an effective date.

9 **Be It Enacted by the People of the State of Oregon:**

10 **SECTION 1.** ORS 184.620 is amended to read:

11 184.620. (1) The Department of Transportation shall be under the supervision of a Director of
12 Transportation. The Oregon Transportation Commission shall appoint the director, after consulta-
13 tion with the Governor. The director serves at the pleasure of the commission.

14 (2) The appointment of the director shall be subject to confirmation by the Senate in the manner
15 provided [*by ORS 171.562 and 171.565*] **in section 2 of this 2018 Act.**

16 (3) The director may appoint:

17 (a) Deputy directors with full authority to act for the director, but subject to the director's
18 control. The appointment of a deputy director shall be by written order filed with the Secretary of
19 State. A deputy director shall be in the unclassified services for purposes of the State Personnel
20 Relations Law.

21 (b) All subordinate officers and employees of the department and may prescribe their duties,
22 assignments and reassignments and fix their compensation, subject to any applicable provisions of
23 the State Personnel Relations Law.

24 (4) Subject to the approval of the commission, the director may organize and reorganize the
25 department as the director considers necessary to properly conduct the work of the department. As
26 directed by the chairperson of the commission, the director shall assign employees of the department
27 to staff the commission.

28 (5) When service of summons or other process is required by statute to be served on the Di-

1 rector of Transportation, the Department of Transportation or the Oregon Transportation Commis-
2 sion, such service shall be made upon the office of the director.

3 **SECTION 2. (1) The executive appointment of the Director of Transportation by the**
4 **Oregon Transportation Commission under ORS 184.620 is subject to confirmation by the**
5 **Senate. Confirmation requires the affirmative vote of a majority of the members of the**
6 **Senate.**

7 **(2) If an appointment made under ORS 184.620 is not confirmed by the Senate, the com-**
8 **mission shall make another appointment, subject to confirmation by the Senate.**

9 **(3) The name of the individual to be appointed or reappointed shall be submitted to the**
10 **Senate by the commission under ORS 184.620. The Senate shall take up the question of con-**
11 **firmation as soon after the convening of a regular or special session as is appropriate. The**
12 **question of confirmation may be referred to committee or may be acted upon without a re-**
13 **ferral.**

14 **(4) If the name of an individual to be appointed or reappointed submitted by the com-**
15 **mission is not acted upon during the term of the Legislative Assembly to which it is sub-**
16 **mitted, the name may be resubmitted to the subsequent term by the commission on or after**
17 **the date the Legislative Assembly convenes in the subsequent regular session.**

18 **SECTION 3.** ORS 805.045 is amended to read:

19 805.045. (1) If approval is granted under ORS 283.390, the Department of Transportation may
20 issue:

21 (a) Registration plates or other evidence of registration from any regular series rather than from
22 any specially designed government series for a vehicle owned or operated by any state department
23 or institution; or

24 (b) Wine country registration plates for a vehicle operated by a member of the Oregon Wine
25 Board in discharging the board's duties if requested to do so by the board.

26 (2) The registration period for a vehicle described under this section shall be the same as the
27 regular registration period for the type of vehicle registered.

28 (3)(a) The fee for registration or renewal of a regular series registration plate for a vehicle un-
29 der subsection (1)(a) of this section is the fee established under ORS 803.420 for registration or re-
30 newal of a state-owned vehicle registered under [*ORS 805.040*] **this section.**

31 (b) The fee for registration or renewal of a wine country registration plate for a vehicle under
32 subsection (1)(b) of this section is the fee established under ORS 803.420 for that type of vehicle, and
33 not for renewal of a state-owned vehicle registered under [*ORS 805.040*] **this section.** Additionally,
34 the applicant shall pay the surcharge described under ORS 805.266.

35 (4) Any vehicle registered under this section and not exempted under ORS 815.300 must meet
36 the requirements for certification of compliance with pollution control under ORS 815.310.

37 **SECTION 4.** ORS 805.205 is amended to read:

38 805.205. (1) Except as provided in subsection (7) of this section, the Department of Transporta-
39 tion shall provide for issuance of registration plates described in this section for nonprofit groups
40 meeting the qualifications for tax exempt status under section 501(c)(3) of the Internal Revenue Code
41 and for institutions of higher education. Plates issued under this section may be issued to owners
42 of motor vehicles registered under the provisions of ORS 803.420 (6)(a). Plates issued under this
43 section may not contain expressions of political opinion or religious belief. Rules adopted under this
44 section shall include, but need not be limited to, rules that:

45 (a) Specify circumstances under which the department may cease to issue plates for any partic-

1 ular group.

2 (b) Require each group for which plates are issued to file an annual statement on a form de-
3 signed by the department showing that the group is a nonprofit group or is an institution of higher
4 education and that the group or institution otherwise meets the qualifications imposed for eligibility
5 for plates issued under this section. The statement shall include names and addresses of current
6 directors or officers of the group or institution or of other persons authorized to speak for the group
7 or institution on matters affecting plates issued under this section.

8 (2)(a) Except as otherwise provided in paragraphs (b) and (c) of this subsection, in addition to
9 any other fee authorized by law, upon issuance of a plate under this section and upon renewal of
10 registration for a vehicle that has plates issued under this section, the department shall collect a
11 surcharge for each year of the registration period. The surcharge shall be determined by the de-
12 partment by rule and may not be less than \$2.50 per plate or more than \$16 per plate. In setting the
13 amount of the surcharge, the department shall consult with the nonprofit group for which the plates
14 are issued.

15 (b) In addition to any other fee authorized by law, upon issuance of a plate under this section
16 that recognizes an institution of higher education in this state, and upon renewal of registration for
17 a vehicle that has such plates, the department shall collect a surcharge of \$8 per plate for each year
18 of the registration period.

19 (c) In addition to any other fee authorized by law, upon issuance of a Share the Road registra-
20 tion plate the department shall collect a surcharge of \$5 per year of registration.

21 (3) Plates issued under this section shall be from the current regular issue of plates except that:

22 (a) If the group requesting the plates is an institution of higher education, the plates shall, upon
23 request, contain words that indicate the plates are issued to recognize the institution or shall con-
24 tain the institution's logo or an image of the institution's mascot; or

25 (b) If the group requesting the plates is a group that recognizes fallen public safety officers, the
26 plates shall, upon request, contain a decal that indicates the plates are issued to recognize fallen
27 public safety officers.

28 (4) Except as otherwise required by the design chosen, the plates shall comply with the re-
29 quirements of ORS 803.535. The department shall determine how many sets of plates shall be man-
30 ufactured for each group approved under this section. If the department does not sell or issue
31 renewal for 500 sets of plates for a particular group in any one year, the department shall cease
32 production of those plates.

33 (5) Except as otherwise provided in subsection (6) of this section, each group that is found by
34 the department to be eligible for plates issued under this section may designate an account into
35 which the net proceeds of the surcharge collected by the department under subsection (2) of this
36 section are to be deposited. The department shall keep accurate records of the number of plates is-
37 sued for each group that qualifies. After payment of administrative expenses of the department,
38 moneys collected under this section for each group shall be deposited by the department into an
39 account specified by that group. If any group does not specify an account for the moneys collected
40 from the sale of plates issued under this section, the department shall deposit moneys collected for
41 those plates into the Passenger Rail Transportation Account established under ORS 802.100 to be
42 used as other moneys in the account are used. Deposits under this subsection shall be made at least
43 quarterly.

44 (6)(a) Each institution of higher education that requests a plate under this section shall desig-
45 nate an account in the general fund of the institution, and the proceeds in the account shall be used

1 for the purpose of academic enrichment at the institution.

2 (b) Net proceeds of the surcharge collected by the department for Share the Road registration
3 plates shall be deposited into two accounts designated by The [*Bicycle Transportation Alliance*]
4 **Street Trust Community Fund** and Cycle Oregon. The department shall evenly distribute the net
5 proceeds to each account. Deposits under this paragraph shall be made at least quarterly. At any
6 time that the department determines that the accounts designated by The [*Bicycle Transportation*
7 *Alliance*] **Street Trust Community Fund** and Cycle Oregon cease to exist, the department may
8 deposit the proceeds into the Passenger Rail Transportation Account established under ORS 802.100.

9 (c) Net proceeds of the surcharge collected by the department for Keep Kids Safe registration
10 plates shall be deposited into an account designated by the Children’s Trust Fund of Oregon Foun-
11 dation to fund strategies and approaches shown to prevent or reduce child abuse. Deposits made
12 under this paragraph shall be made at least quarterly. At any time that the department determines
13 that the account designated by the Children’s Trust Fund of Oregon Foundation ceases to exist, the
14 department shall deposit the proceeds into the Keep Kids Safe Registration Plate Account estab-
15 lished in ORS 805.207. At the beginning of each biennium, the Early Learning Council shall evenly
16 distribute the moneys in the Keep Kids Safe Registration Plate Account to the counties in this state,
17 until each county receives \$1,000. After each county has received \$1,000, the council shall distribute
18 any remaining moneys to each county in an amount equal to the percentage of Keep Kids Safe
19 registration plates sold in that county. Each county shall use the moneys received under this para-
20 graph solely for the purpose of funding strategies and approaches shown to prevent or reduce child
21 abuse.

22 (7) The department may not accept applications to create new group registration plates on or
23 after August 12, 2015.

24 **SECTION 5.** Section 71d, chapter 750, Oregon Laws 2017, is amended to read:

25 **Sec. 71d.** (1) **On and after January 1, 2020,** the Oregon Transportation Commission shall use
26 the proceeds of bonds, as defined in ORS 367.010, authorized under ORS 367.620 (3)(d) to finance the
27 transportation projects listed in this section. The commission shall determine the order of com-
28 pletion for the projects listed in subsection (2) of this section.

29 (2) No later than January 1, 2024, the commission shall allocate the following amounts to each
30 region, as described in ORS 366.805, for the projects listed below, provided that the commission de-
31 termines that the projects could constitutionally be funded by revenues described in Article IX,
32 section 3a, of the Oregon Constitution:

39 (3)(a) When the commission determines that a project described in this section is completed, the
40 commission shall reallocate any amount remaining from the allocation made under this section to
41 another project described in the same region.

42 (b) When the commission determines that all of the projects within a region are completed, the
43 commission shall reallocate any amount remaining from the allocation made under this section to
44 any other project listed in this section.

45 (4) The amounts described in this section for jurisdiction transfers described in [section 134 of

1 *this 2017 Act*] **ORS 366.483** may not be allocated until after the transfer for which the allocation is
2 dedicated occurs.

3 **SECTION 6.** ORS 366.772 is amended to read:

4 366.772. (1) Not later than July 31 in each calendar year, the sum of \$5,500,000 shall be with-
5 drawn from the appropriation specified in ORS 366.762 and the sum of \$250,000 shall be withdrawn
6 from moneys available to the Department of Transportation from the State Highway Fund. The sums
7 withdrawn shall be transferred to a separate account to be administered by the Department of
8 Transportation.

9 (2) Not later than July 31 in each calendar year, the sum of \$5,750,000 shall be withdrawn from
10 the separate account described in subsection (1) of this section and distributed to counties as fol-
11 lows:

12 (a) An amount of \$750,000 shall be distributed to the following counties in the following
13 amounts:

14	(A) Harney County.....	\$	271,909

20 (b) An amount of \$5,000,000 shall be distributed proportionally to counties with fewer than
21 200,000 registered vehicles [*based on a ratio of registered vehicles to road miles maintained by each*
22 *county*] **based on a ratio of road miles maintained by each county to registered vehicles.**

23 (3) Moneys allocated as provided in this section may be used only for maintenance, repair and
24 improvement of existing roads that are:

- 25 (a) Not a part of the state highway system;
- 26 (b) Within counties with fewer than 200,000 registered vehicles; and
- 27 (c) Inadequate for the capacity the roads serve or are in a condition detrimental to safety.
- 28 (4) All moneys in the account shall be allotted each year.

29 **SECTION 7.** ORS 366.155 is amended to read:

30 366.155. (1) The Department of Transportation shall, among other things:

31 (a) So far as practicable, compile statistics relative to the public highways of the state and
32 collect all information in regard thereto which the Director of Transportation may deem important
33 or of value in connection with highway location, construction, maintenance, improvement or opera-
34 tion.

35 (b) Keep on file in the office of the department copies of all plans, specifications and estimates
36 prepared by the department.

37 (c) Make all necessary surveys for the location or relocation of highways and cause to be made
38 and kept in the department a general highway plan of the state.

39 (d) Collect and compile information and statistics relative to the mileage, character and condi-
40 tion of highways and bridges in the different counties in the state, both with respect to state and
41 county highways.

42 (e) Investigate and determine the methods of road construction best adapted in the various
43 counties or sections of the state, giving due regard to the topography, natural character and avail-
44 ability of road-building materials and the cost of building and maintaining roads under this Act.

45 (f) Prepare surveys, plans, specifications and estimates for the construction, reconstruction, im-

1 improvement, maintenance and repair of any bridge, street, road and highway. In advertising for bids
2 on any such project the director shall invite bids in conformity with such plans and specifications.

3 (g) Keep an accurate and detailed account of all moneys expended in the location, survey, con-
4 struction, reconstruction, improvement, maintenance or operation of highways, roads and streets,
5 including costs for rights of way, under this Act, and keep a record of the number of miles so lo-
6 cated, constructed, maintained or operated in each county, the date of construction, the width of
7 such highways and the cost per mile for the construction and maintenance of the highways.

8 (h) Upon request of a county governing body, assist the county on matters relating to road lo-
9 cation, construction or maintenance. Plans and specifications for bridges or culverts that are pro-
10 vided under this paragraph shall be provided without cost to the 10 counties with the lowest ratio
11 of [*registered vehicles to road miles maintained by each county*] **road miles maintained by each**
12 **county to registered vehicles**. Standard specifications for road projects shall be provided without
13 cost to all counties. The Department of Transportation shall determine an amount to be charged for
14 assistance under this paragraph in establishing specifications and standards for roads under ORS
15 368.036. The costs of assistance not specifically provided for under this paragraph shall be paid as
16 provided by agreement between the county governing body and the director.

17 (i) Upon request of the State Parks and Recreation Department, assist the State Parks and Re-
18 creation Department in evaluating the potential need for construction, reconstruction, improvement,
19 maintenance or operation of highways, roads and streets that would result if the State Parks and
20 Recreation Commission acquired and developed a new historic site, park or recreation area under
21 the criteria established pursuant to ORS 390.112 or any other criteria for acquisition established by
22 the State Parks and Recreation Commission.

23 (2) The director may require duties with respect to audits and accounting procedures provided
24 for in this section and ORS 366.165 to be performed and responsibilities to be assumed by the fiscal
25 officer of the department appointed under ORS 184.637.

26 (3) In carrying out the duties set forth in this section, the director shall act in a manner that
27 is consistent with the goal set forth in ORS 468B.155.

28 **SECTION 8.** Section 85, chapter 750, Oregon Laws 2017, is amended to read:

29 **Sec. 85.** (1) The Oregon Transportation Commission shall pursue methods to streamline the
30 process for submitting applications under ORS 367.080 to 367.086.

31 (2) The Oregon Transportation Commission shall report to the Joint Committee on Transporta-
32 tion established under [*section 26 of this 2017 Act*] **ORS 171.858** no later than September 15, [*2017*]
33 **2018**, on the implementation of this section.

34 **SECTION 9. Any report due no later than September 15, 2017, under section 85, chapter**
35 **750, Oregon Laws 2017, and filed on or before September 15, 2018, is considered to be filed**
36 **timely.**

37 **SECTION 10.** ORS 320.400 is amended to read:

38 320.400. As used in ORS 320.400 to 320.490 and 803.203:

39 (1)(a) "Bicycle" means a vehicle that is designed to be operated on the ground on wheels and
40 is propelled exclusively by human power.

41 **(b) "Bicycle" includes an electric assisted bicycle as defined in ORS 801.258.**

42 [(b)] (c) "Bicycle" does not include durable medical equipment.

43 [(2) "New motor vehicle" has the meaning given that term in ORS 803.350 (8)(c).]

44 [(3)] **(2)(a)** "Retail sales price" means the total price paid at retail for a taxable vehicle, exclu-
45 sive of the amount of any excise, privilege or use tax, to a seller by a purchaser of the taxable ve-

1 hicle.

2 (b) **“Retail sales price” does not include the retail value of:**

3 (A) **Modifications to a taxable vehicle that are necessary for a person with a disability**
4 **to enter or drive or to otherwise operate or use the vehicle.**

5 (B) **Customized industrial modifications to the chassis of a truck that has a gross vehicle**
6 **weight rating of at least 10,000 pounds and not more than 26,000 pounds.**

7 [(4)] (3) **“Seller” means:**

8 (a) With respect to the privilege tax imposed under ORS 320.405 and the use tax imposed under
9 ORS 320.410, a vehicle dealer.

10 (b) With respect to the excise tax imposed under ORS 320.415, a person engaged in whole or in
11 part in the business of selling bicycles.

12 [(5)] (4) **“Taxable bicycle” means a new bicycle that has [wheels of at least 26 inches in diameter**
13 **and] a retail sales price of \$200 or more.**

14 [(6)] (5) **“Taxable motor vehicle” means a [new motor] vehicle [with] that:**

15 (a) **Has a gross vehicle weight rating of 26,000 pounds or less [that is:];**

16 (b)(A) **If equipped with an odometer, has 7,500 miles or less on the odometer; or**

17 (B) **If not equipped with an odometer, has a manufacturer’s certificate of origin or a**
18 **manufacturer’s statement of origin; and**

19 (c) **Is:**

20 [(a)] (A) **A vehicle as defined in ORS 744.850, other than an all-terrain vehicle or a trailer;**

21 [(b)] *A bus trailer as defined in ORS 801.165;*

23 [(d)] (C) **A commercial bus as defined in ORS 801.200;**

24 [(e)] (D) **A commercial motor vehicle as defined in ORS 801.208;**

25 [(f)] (E) **A commercial vehicle as defined in ORS 801.210;**

26 [(g)] *An electric assisted bicycle as defined in ORS 801.258;*

27 [(h)] (F) **A fixed load vehicle as defined in ORS 801.285;**

28 [(i)] (G) **A moped as defined in ORS 801.345;**

29 [(j)] *A motor assisted scooter as defined in ORS 801.348;*

30 [(k)] (H) **A motor home as defined in ORS 801.350;**

31 [(L)] (I) **A motor truck as defined in ORS 801.355;**

32 [(m)] (J) **A tank vehicle as defined in ORS 801.522;**

34 [(n)] (L) **A truck tractor as defined in ORS 801.575; or**

35 [(o)] *A truck trailer as defined in ORS 801.580; or]*

36 [(p)] (M) **A worker transport bus as defined in ORS 801.610.**

37 [(7)] (6) **“Taxable vehicle” means a taxable bicycle or a taxable motor vehicle.**

38 [(8)] (7) **“Transportation project taxes” means the privilege tax imposed under ORS 320.405, the**
39 **use tax imposed under ORS 320.410 and the excise tax imposed under ORS 320.415.**

40 [(9)(a)] (8)(a) **“Vehicle dealer” means:**

41 (A) **A person engaged in business in this state that [has been issued] is required to obtain a**
42 **vehicle dealer certificate under ORS [822.020] 822.005; and**

8 (B) An owner of an outdoor advertising sign shall be considered to have suffered a partial
9 loss with respect to the outdoor advertising sign if, due to a highway construction project,
10 the face of the outdoor advertising sign would be substantially but not totally blocked in its
11 current location.

12 (b) Full compensation for loss of an outdoor advertising sign equals the market value of
13 the outdoor advertising sign, measured by comparable sales of outdoor advertising signs as
14 determined by an appraiser recognized as a specialist in such valuations, less the salvage
15 value of the components of the outdoor advertising sign.

16 (2)(a) When the Department of Transportation determines that a highway construction
17 project supervised by the department will result in the total or partial loss of an outdoor
18 advertising sign, the department shall enter into negotiations with the owner of the outdoor
19 advertising sign for relocation of the outdoor advertising sign.

20 (b) The department may require the owner to provide information about the owner's ef-
21 forts to acquire a comparable location for the outdoor advertising sign.

22 (c) The department may assist the owner's efforts to acquire and obtain approval for a
23 comparable location for the outdoor advertising sign.

24 (3)(a) The department may enter into an agreement with the owner of an outdoor ad-
25 vertising sign for relocation of the outdoor advertising sign on any terms not prohibited by
26 law or inconsistent with this section.

27 (b) An agreement entered into under this subsection may not require the department to
28 pay the owner of the outdoor advertising sign an amount in compensation that is greater
29 than the actual cost to the owner of relocating the outdoor advertising sign.

30 (4)(a) If, after reasonable efforts, the owner of an outdoor advertising sign subject to
31 total or partial loss is unable to acquire a comparable location in the same market area for
32 the outdoor advertising sign, except as provided in ORS 377.725 (4), the department shall pay
33 the owner compensation as provided in this subsection.

34 (b) Except as provided in paragraph (c) of this subsection, for a total loss of an outdoor
35 advertising sign, the department shall pay the owner full compensation for the loss and
36 permanently cancel the sign permit, and the owner shall remove the sign.

37 (c) For a total loss of an outdoor advertising sign in which a new site for the outdoor
38 advertising sign is found at a less than comparable location, the department shall pay the
39 owner the difference between the amount of full compensation for the loss and the market
40 value of the outdoor advertising sign as located at the new site. If the new site is on a state
41 highway, the owner may use the outdoor advertising sign's existing permit issued under ORS
42 377.725 to apply for a relocation permit. If the new site is not on a state highway, the de-
43 partment shall permanently cancel the permit.

44 (d) For a partial loss of an outdoor advertising sign, the department shall pay the owner
45 the percentage of full compensation that is equal to the loss of market value due to the

1 **blockage of the sign's face.**

2 (e) **The department and the owner may enter into an agreement for partial or full com-**
3 **ensation under this subsection in the form of additional relocation credits or other in-kind**
4 **value.**

5 (5)(a) **If the department and the owner of an outdoor advertising sign do not agree that**
6 **a comparable location is available in the case of the total loss of an outdoor advertising sign,**
7 **or do not agree to the amount of compensation offered by the department, the department**
8 **shall provide written notice of the final offer of compensation to the owner.**

9 (b) **The owner may appeal to the department the comparable location determination and**
10 **the amount of compensation contained in the written notice. The hearing on the appeal shall**
11 **be conducted as a contested case hearing under ORS chapter 183.**

12 (c) **Notwithstanding paragraph (b) of this subsection, in the case of the total loss of an**
13 **outdoor advertising sign, the owner shall remove the outdoor advertising sign that is the**
14 **subject of the written notice within 90 days after receipt of the notice.**

24 furnished by the director. The permit application shall include a precise description of the outdoor

27 advertising sign that complies with ORS 377.700 to 377.844. A valid permit may be transferred to
28 another person upon written notice to the director.

30 highway or freeway unless the director determines that access to the **outdoor advertising** sign from
31 the interstate highway or freeway can be obtained without violating the access control line of the
32 interstate highway or freeway.

33 (4) **If an application for a permit to relocate or reconstruct an outdoor advertising sign**
34 **is for a location identified in the current Statewide Transportation Improvement Program,**
35 **the department shall require the applicant to execute an affidavit acknowledging the project**
36 **and forgoing any claim for compensation under section 46 of this 2018 Act.**

37 [(4)] (5) A permit shall be renewed annually on the first day of January. Application for renewal
38 of a permit shall be filed prior to expiration of the term of the permit. If application for renewal of
39 a permit is filed within 30 days after the expiration of the term, the permit shall be granted if any
40 additional fee specified by the department in rules adopted under ORS 377.729 is paid at the time
41 the application is filed. Any permit not renewed in accordance with this section shall be canceled.

42 [(5)] (6) Permit fees for purposes of this section are as established by the department by rule
43 under ORS 377.729.

44 [(6)] (7) A permit shall be issued for one year. The applicable fee shall accompany the permit
45 application. A fee may not be prorated for a fraction of a year or be refunded if the outdoor ad-

2 [(7)] (8) The display surface of an outdoor advertising sign may be changed or cutouts may be
3 attached or removed within the sign area without obtaining a permit. However, a permit shall be
4 obtained if the outdoor advertising sign is reconstructed.

5 [(8)] (9) A reconstruction permit may be issued for the addition of another display surface on
6 the opposite side of an existing, conforming **outdoor advertising** sign under permit, that is no
7 larger than the existing display surface.

8 [(9)] (10) The director shall require removal of a sign or shall cancel a permit and require re-
9 moval of an outdoor advertising sign as provided by ORS 377.775 if the director finds a sign **or an**
10 **outdoor advertising sign** has been erected, maintained or serviced from the highway right of way
11 at any portion of the right of way where the department has acquired rights of access to the high-
12 way or rights of access have not accrued to the abutting property. If there is no permit for the
13 outdoor advertising sign, then the director shall require removal of the outdoor advertising sign. In
14 addition, the department may recover from the owner of the sign or outdoor advertising sign or from
15 the person erecting, maintaining or servicing the sign or outdoor advertising sign, the amount of
16 damage to landscaping, sod, fencing, ditches or other highway appurtenances resulting from such
17 acts. If a permit is canceled under this subsection, an outdoor advertising sign may not be relocated
18 under ORS 377.767.

19 [(10)(a)] (11)(a) The director may cancel a permit, unless a corrected application is filed or the
20 outdoor advertising sign is brought into compliance within 30 days after written notice thereof is
21 mailed to the permittee, if the director finds:

22 (A) The applicant has knowingly supplied materially false or misleading information in the ap-
23 plication for a permit or renewal thereof; or

24 (B) The **outdoor advertising** sign covered by the permit violates ORS 377.700 to 377.844.

25 (b) If a permit is canceled under this subsection, an outdoor advertising sign may not be relo-
26 cated under ORS 377.767, and the holder of the permit is not entitled to a relocation credit.

27 [(11)] (12) The director shall cancel a permit immediately upon failure of a permittee to erect
28 or maintain the outdoor advertising sign as described by the permit application and to attach a
29 permit plate to the **outdoor advertising** sign 180 days after the date of issuance of the permit.

30 [(12)] (13) The director shall assign a permit plate with an identification number to the permit
31 issued for an outdoor advertising sign. The permittee shall attach the permit plate to the outdoor
32 advertising sign so the plate is visible from the adjacent state highway. The absence of a permit
33 plate or failure to renew the permit annually is prima facie evidence that the outdoor advertising
34 sign does not comply with ORS 377.700 to 377.844.

35 [(13)] (14) Except as otherwise provided in ORS 377.712, 377.753 and 377.765, no permits shall
36 be issued for the erection of any new outdoor advertising sign after May 30, 2007.

37 [(14)] (15) The director may establish more than one class or type of outdoor advertising sign
38 permit as necessary or desirable to carry out ORS 377.700 to 377.844.

39 [(15)] (16) Any hearing under this section shall be conducted as a contested case hearing under
40 ORS chapter 183.
