SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Describes fees required when person is applying to replace or renew current driver license with Real ID compliant driver license or is applying for new original driver license that is Real ID compliant.

Provides that Department of Transportation may issue, renew or replace limited term driver license, limited term driver permit or limited term identification card to persons previously issued limited term driver license, limited term driver permit or limited term identification card whose Employment Authorization Document has expired under certain circumstances. Sunsets December 31, 2021.

A BILL FOR AN ACT

2 Relating to documents issued by the Department of Transportation; creating new provisions;
3 amending ORS 807.460; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 807.460 is amended to read:

6 807.460. (1) In addition to any fee imposed under ORS 807.370, 807.410 or 807.375, the Depart-
7 ment of Transportation shall impose a fee for each Real ID issued, renewed or replaced, for the
8 purpose of covering the additional costs to the department related to the issuance of Real IDs.

9 (2) **An applicant who applies for a Real ID driver license as an original driver license shall**
10 **pay the driver license issuance fee under ORS 807.370, plus the fee described in subsection**
11 **(1) of this section.**

12 (3) **An applicant who applies to replace a current driver license with a Real ID driver li-**
13 **cense shall pay the driver license replacement fee under ORS 807.370, plus the fee described**
14 **in subsection (1) of this section.**

15 (4) **An applicant who applies to renew a driver license with a Real ID driver license shall**
16 **pay the driver license renewal fee under ORS 807.370, plus the fee described in subsection (1)**
17 **of this section.**

18 (5) **In addition to the fees in subsection (2), (3) or (4) of this section, an applicant who**
19 **applies for a class of driver license that is different from the driver license the applicant**
20 **currently holds, or who applies to add or remove an endorsement, as part of Real ID issu-**
21 **ance, shall pay the fees associated with the new class of license or the endorsement for**
22 **which the applicant is applying.**

23 **SECTION 2.** Section 3 of this 2018 Act is added to and made a part of the Oregon Vehicle
24 **Code.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **SECTION 3.** (1) Notwithstanding ORS 807.021 and 807.730, a person is not required to
2 provide proof of legal presence in the United States when applying for a limited term iden-
3 tification card, a limited term driver license or a limited term driver permit if:

4 (a) The Department of Transportation previously issued a limited term identification
5 card, a limited term driver license or a limited term driver permit to the applicant;

6 (b) The applicant presents to the department an Employment Authorization Document
7 issued by the United States Citizenship and Immigration Services under category C33, A12
8 or C19; and

9 (c) The applicant's Employment Authorization Document expired on or after August 1,
10 2014.

11 (2) Notwithstanding ORS 807.022, the department may not verify the documents described
12 in this section.

13 (3) Notwithstanding ORS 807.130, a limited term driver license issued or renewed under
14 this section expires two years from the date of issuance.

15 **SECTION 4.** Section 3 of this 2018 Act is repealed on December 31, 2021.

16 **SECTION 5.** Section 3 of this 2018 Act applies to limited term identification cards, limited
17 term driver licenses and limited term driver permits issued, renewed or replaced on or after
18 July 1, 2018.

19 **SECTION 6.** (1) The amendments to ORS 807.460 by section 1 of this 2018 Act become
20 operative on January 1, 2019.

21 (2) Section 3 of this 2018 Act becomes operative on July 1, 2018.

22 (3) The Department of Transportation may take any action before the operative dates
23 specified in subsections (1) and (2) of this section that is necessary to enable the department
24 to exercise, on and after the operative dates specified in subsections (1) and (2) of this sec-
25 tion, all the duties, functions and powers conferred on the department by section 3 of this
26 2018 Act and the amendments to ORS 807.460 by section 1 of this 2018 Act.

27 **SECTION 7.** This 2018 Act being necessary for the immediate preservation of the public
28 peace, health and safety, an emergency is declared to exist, and this 2018 Act takes effect
29 on its passage.
