**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows Health Licensing Office to issue residential care facility administrator license to qualified applicant. Renames Nursing Home Administrators Board as Long Term Care Administrators Board. Prohibits board from carrying out disciplinary action against licensee unless at least one board member who represents type of license held by licensee is present at board meetings related to disciplinary action. Requires individual currently employed as residential care facility administrator in Oregon, **or individual seeking employment as residential care facility administrator in Oregon prior to January 1, 2022**, to apply for residential care facility administrator license by July 1, 2019. Allows Health Licensing Office to issue provisional residential care facility administrator license to qualified individual. Requires individual who holds provisional residential care facility administrator license to obtain residential care facility administrator license not later than January 1, 2022.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7  
8 **RESIDENTIAL CARE FACILITY ADMINISTRATOR LICENSE**

9  
10 **SECTION 1. Sections 2 to 4 of this 2018 Act are added to and made a part of ORS 678.710**  
11 **to 678.820.**

12 **SECTION 2. (1) The Health Licensing Office may issue a residential care facility admin-**  
13 **istrator license to an applicant who:**

14 **(a) Is at least 21 years of age;**

15 **(b) Has earned at least a high school diploma or its equivalent;**

16 **(c)(A) For at least two of the last five years has been employed in a professional or**  
17 **managerial capacity in a health or social service related field, or has a combination of expe-**  
18 **rience and education deemed sufficient by the office; or**

19 **(B) Has earned at least a bachelor's degree in a health or social service related field;**

20 **(d) Has completed at least 40 hours of training approved by the office by rule;**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (e) Pays a licensure fee; and

2 (f) Passes an examination described in section 3 of this 2018 Act.

3 (2) When issuing a license under this section, the office shall consider the qualifications  
4 for employment under ORS 443.004.

5 **SECTION 3.** (1) The Long Term Care Administrators Board shall:

6 (a) Approve at least one examination for licensure as a residential care facility adminis-  
7 trator; and

8 (b) Ensure that the examinations are easily and frequently accessible to applicants.

9 (2) An applicant for licensure under section 2 of this 2018 Act shall pay an examination  
10 or reexamination fee established by the Health Licensing Office under ORS 676.576.

11 (3) The board shall adopt rules to:

12 (a) Determine the subjects, scope and content of the examinations;

13 (b) Ensure the examinations are specific to Oregon law and administrative rules;

14 (c) Determine a passing score for each examination approved by the board; and

15 (d) Ensure the integrity of the examination process.

16 **SECTION 4.** The Health Licensing Office shall adopt rules to:

17 (1) Approve training and continuing education for residential care facility administrators;  
18 and

19 (2) Establish continuing education requirements for residential care facility administra-  
20 tors, including that a residential care facility administrator complete at least 20 hours each  
21 year of approved continuing education.

22 **SECTION 5.** ORS 678.710 is amended to read:

23 678.710. As used in ORS 678.710 to 678.820, unless the context requires otherwise:

24 (1) "Dual facility" means a facility that operates both a hospital and a long term care facility  
25 on the same campus.

26 (2) "Nursing home" means any institution or facility defined as a long term care facility for li-  
27 censing purposes under state statute or the rules of the Department of Human Services, including  
28 a long term care facility operated as part of a dual facility.

29 (3) "Nursing home administrator" means an individual responsible for planning, organizing and  
30 managing the operation of a nursing home, whether or not [*such*] **the** individual has an ownership  
31 interest in [*such*] **the nursing** home and whether or not [*such*] **the** functions are shared by one or  
32 more other individuals, if:

33 (a) Final responsibility and authority are retained in the nursing home administrator; and

34 (b) In the case of a dual facility, the nursing home administrator may be subject to the authority  
35 of the administrator of the dual facility or the dual facility administrator may administer the nursing  
36 home if the **dual facility** administrator is licensed or otherwise qualified by statute to administer  
37 a nursing home.

38 (4) "Provisional license" means a temporary license issued to a provisional nursing home ad-  
39 ministrator under the rules of the Health Licensing Office.

40 (5) "**Residential care facility**" has the meaning given that term in ORS 443.400.

41 (6) "**Residential care facility administrator**" means an individual who is responsible for  
42 **planning, organizing and managing the operation of a residential care facility.**

43 **SECTION 6.** ORS 678.720 is amended to read:

44 678.720. (1)(a) Unless an individual holds an active license issued under [*the provisions of*] ORS  
45 678.710 to 678.820, an individual may not:

1 [(a)] (A) Practice or offer to practice as a nursing home administrator; or

2 [(b)] (B) Use in connection with the name of the individual the words or letters “nursing home  
3 administrator,” “NHA” or any other words, letters or abbreviations or insignia tending to indicate  
4 that the individual is a licensed nursing home administrator.

5 [(2)] (b) A nursing home [shall] **must** be conducted or operated under the supervision of a  
6 nursing home administrator who holds an active license issued under [the provisions of] ORS 678.710  
7 to 678.820.

8 (2)(a) **Unless an individual holds an active license issued under ORS 678.710 to 678.820, an  
9 individual may not:**

10 (A) **Practice or offer to practice as a residential care facility administrator; or**

11 (B) **Use in connection with the name of the individual the words or letters “residential  
12 care facility administrator,” “RCFA” or any other words, letters or abbreviations or insignia  
13 tending to indicate that the individual is a licensed residential care facility administrator.**

14 (b) **Subject to rules adopted under paragraph (c) of this subsection, a residential care  
15 facility must be conducted or operated under the supervision of a residential care facility  
16 administrator who holds an active license issued under ORS 678.710 to 678.820.**

17 (c) **The Department of Human Services shall adopt rules to allow a residential care fa-  
18 cility to be operated by an individual who is not a residential care facility administrator who  
19 holds an active license under ORS 678.710 to 678.820 in transitional, emergency and similar  
20 situations.**

21 **SECTION 7.** ORS 678.740 is amended to read:

22 678.740. (1) Examinations for licensure as a nursing home administrator shall be conducted at  
23 such times and places as the [Nursing Home] **Long Term Care** Administrators Board designates,  
24 but not less than once a year.

25 (2) At the time of taking an examination for licensure as a nursing home administrator, an ap-  
26 plicant shall pay an examination or reexamination fee established by the Health Licensing Office  
27 under ORS 676.576.

28 (3) The board shall, consistent with the purposes for which the examination is given, determine  
29 the subjects, scope, content and the minimum passing grade for examinations.

30 **SECTION 8.** ORS 678.770 is amended to read:

31 678.770. (1) The [Nursing Home] **Long Term Care** Administrators Board may establish by rule  
32 standards for the issuance of a **nursing home administrator or residential care facility admin-  
33 istrator** license by endorsement to an applicant who:

34 (a) Meets the requirements as established by the board; and

35 (b) On the date of making application, is a nursing home administrator **or residential care fa-  
36 cility administrator** licensed under the laws of any other state or territory of the United States if  
37 the requirements for licensing of nursing home administrators **or residential care facility admin-  
38 istrators** in the state or territory in which the applicant is licensed are not less than those required  
39 by ORS 678.710 to 678.820.

40 (2) [Each] **An** applicant under this section shall pay to the Health Licensing Office at the time  
41 of filing the application the applicable fees established under ORS 676.576.

42 **SECTION 9.** ORS 678.800 is amended to read:

43 678.800. (1) The [Nursing Home] **Long Term Care** Administrators Board is established within  
44 the Health Licensing Office.

45 (2) The board consists of nine members appointed by the Governor and subject to confirmation

1 by the Senate in the manner provided in ORS 171.562 and 171.565. All members of the board must  
2 be concerned with the care and treatment of the chronically ill or infirm elderly patients and must  
3 be residents of this state. Of the members of the board:

4 (a) Three must be nursing home administrators licensed under ORS 678.710 to 678.820;

5 **(b) Three must be residential care facility administrators licensed under ORS 678.710 to**  
6 **678.820, at least one of whom serves in a memory care community;**

7 [(b)] (c) One must be a physician licensed under ORS 677.100 to 677.228 [*actively engaged in*  
8 *private practice and conversant with the care and treatment of the long-term patient;*] **who has ex-**  
9 **pertise in geriatric care or care for persons with disabilities; and**

10 [(c) One must be a licensed professional nurse actively engaged in caring for chronically ill and  
11 infirm patients and licensed by the Oregon State Board of Nursing;]

12 [(d) One must be a pharmacist licensed by the State Board of Pharmacy; and]

13 [(e)] (d) [Three] **Two** must be members of the public who are not:

14 (A) Otherwise eligible for appointment to the board; or

15 (B) A spouse, domestic partner, child, parent or sibling of a nursing home administrator **or**  
16 **residential care facility administrator.**

17 (3)(a) Board members required to be nursing home administrators **and residential care facility**  
18 **administrators** may be selected by the Governor from a list of three to five nominees submitted  
19 by any professional organization representing [*nursing home administrators*] **those professions.**

20 (b) Except for those persons described in paragraph (a) of this subsection, [*no*] **a** member of the  
21 board may **not** have a direct financial interest in a nursing home **or residential care facility.**

22 (c) No more than two of the members of the board may be officials or full-time employees of  
23 state or local governments.

24 (d) At least one public member must be at least 62 years of age.

25 (e) [*No*] Public members of the board may **not** hold any pecuniary interest in, or have any em-  
26 ployment contract with, a [*long term care facility*] **nursing home or residential care facility.**

27 (f) In selecting the members of the board, the Governor shall strive to balance the represen-  
28 tation on the board according to:

29 (A) Geographic areas of this state, **ensuring that at least one member is from a rural**  
30 **area;** and

31 (B) [*Ethnic group*] **Ethnicity.**

32 (4)(a) The term of office of each member is three years but a member serves at the pleasure of  
33 the Governor. The terms must be staggered so that no more than three terms end each year. Before  
34 the expiration of the term of a member, the Governor shall appoint a successor whose term begins  
35 on July 1 next following. A member is eligible for reappointment. If there is a vacancy for any cause  
36 the Governor shall make an appointment to become immediately effective for the unexpired term.

37 (b) A board member shall be removed immediately from the board if, during the member's term,  
38 the member:

39 (A) Is not a resident of this state;

40 (B) Has been absent from three consecutive board meetings, unless at least one absence is ex-  
41 cused; [*or*]

42 (C) Is not a licensed nursing home administrator or a retired nursing home administrator whose  
43 license as a nursing home administrator was in good standing at the time of retirement, if the  
44 member was appointed to serve on the board as a nursing home administrator; **or**

45 **(D) Is not a licensed residential care facility administrator or a retired residential care**

1 **facility administrator whose license as a residential care facility administrator was in good**  
2 **standing at the time of retirement, if the member was appointed to serve on the board as a**  
3 **residential care facility administrator.**

4 (5) The members of the board are entitled to compensation and expenses as provided in ORS  
5 292.495. The board may provide by rule for compensation to board members for the performance of  
6 official duties at a rate that is greater than the rate provided in ORS 292.495.

7 **SECTION 10.** ORS 678.810 is amended to read:

8 678.810. (1) The [*Nursing Home*] **Long Term Care** Administrators Board shall [*hold at least one*  
9 *meeting*] **meet at least once** each year. A majority of the members of the board constitutes a quo-  
10 rum for the transaction of business.

11 (2) The board shall select one of its members as chairperson and another as vice chairperson,  
12 for a one-year term and with [*such*] **the** duties and powers necessary for the performance of the  
13 functions of the offices as the board determines.

14 **SECTION 11.** ORS 678.820 is amended to read:

15 678.820. (1) The [*Nursing Home*] **Long Term Care** Administrators Board is responsible for ad-  
16 vising the Health Licensing Office in all matters relating to the administration of ORS 678.710 to  
17 678.820, including:

18 (a) Developing standards for education and training;

19 (b) Developing standards of practice and professional conduct;

20 (c) Establishing standards related to the issuance, denial, revocation, suspension or renewal of  
21 licenses to practice as a nursing home administrator **or residential care facility administrator**;

22 (d) Preparing or approving the examinations required under ORS 678.710 to 678.820, in accord-  
23 ance with standards provided by the office; and

24 (e) Assisting the office in administering [*the provisions of*] ORS 678.710 to 678.820.

25 (2) The office shall administer ORS 678.710 to 678.820 by:

26 (a) Determining the qualifications and fitness of applicants for licenses, renewed licenses, re-  
27 ciprocal licenses and provisional licenses under ORS 678.710 to 678.820.

28 (b) Examining, approving, issuing, denying, revoking, suspending and renewing licenses to prac-  
29 tice as a nursing home administrator **and residential care facility administrator**.

30 (c) Providing for waivers of examinations or provisional licenses.

31 (d) Establishing and carrying out procedures to ensure compliance with professional standards  
32 adopted by the board.

33 (e) Pursuant to ORS 676.608, receiving and investigating complaints filed regarding nursing  
34 home administrators **and residential care facility administrators**.

35 (f) Establishing and collecting fees and charges to carry out the office's duties under ORS  
36 678.710 to 678.820.

37 (g) In accordance with ORS 183.330 and 676.615, adopting, amending and repealing rules that  
38 are necessary to carry out the administration of ORS 678.710 to 678.820.

39 (h) Maintaining a register of all licensed nursing home administrators **and residential care**  
40 **facility administrators**.

41 (3) The office shall consider and be guided by the recommendations of the board in all matters  
42 relating to the administration of ORS 678.710 to 678.820.

43 **SECTION 12.** **The Long Term Care Administrators Board may not carry out a discipli-**  
44 **nary action against an individual who holds a license under ORS 678.710 to 678.820 unless at**  
45 **least one board member who represents the type of license held by the individual attends all**

1 **board meetings related to the disciplinary action.**

11 state or another state to administer health care services in the ordinary course of business or  
12 practice of a profession; and

14 (3) "Health professional regulatory board" means a health professional regulatory board, as de-

21 (3) "Health professional regulatory board" means a health professional regulatory board, as de-  
22 fined in ORS 676.160, the [*Nursing Home*] **Long Term Care** Administrators Board, the Board of Li-  
23 censed Dietitians and the Behavior Analysis Regulatory Board.

24 (4) "Medical director" means a physician employed by a hospital, health care clinic or system  
25 of hospitals or health care clinics for the purposes of overseeing the operations of the hospital,  
26 clinic or system and ensuring the delivery of quality health care within the hospital, clinic or sys-  
27 tem.

28 (5) "Pharmacist" means:

29 (a) A pharmacist as defined in ORS 689.005; or

37 (a) A practitioner as defined in ORS 689.005; or

38 (b) An individual licensed to practice a profession in another state, if the requirements for  
39 licensure are similar, as determined by the authority, to the requirements for being licensed as a  
40 practitioner as defined in ORS 689.005.

41 (8) "Prescription" has the meaning given that term in ORS 475.005.

42 (9) "Prescription drug" has the meaning given that term in ORS 689.005.

43 **SECTION 15.** ORS 433.045 is amended to read:

44 433.045. (1) As used in this section:

45 (a) "Health care provider" means an individual licensed by a health professional regulatory

1 board, as defined in ORS 676.160, the [*Nursing Home*] **Long Term Care** Administrators Board, the  
2 Board of Licensed Dietitians or the Behavior Analysis Regulatory Board.

3 (b) “HIV test” means a test of an individual for the presence of HIV, or for antibodies or  
4 antigens that result from HIV infection, or for any other substance specifically indicating infection  
5 with HIV.

6 (c) “Insurance producer” has the meaning given that term in ORS 746.600.

7 (d) “Insurance-support organization” has the meaning given that term in ORS 746.600.

8 (e) “Insurer” has the meaning given that term in ORS 731.106.

9 (2) Except as provided in ORS 433.017, 433.055 (3) and 433.080, a health care provider or the  
10 provider’s designee shall, before subjecting an individual to an HIV test:

11 (a) Notify the individual being tested; and

12 (b) Allow the individual being tested the opportunity to decline the test.

13 (3) The notification and opportunity to decline testing required under subsection (2) of this sec-  
14 tion may be verbal or in writing, and may be contained in a general medical consent form.

15 (4)(a) Regardless of the manner of receipt or the source of the information, including information  
16 received from the tested individual, a person may not disclose or be compelled to disclose the iden-  
17 tity of any individual upon whom an HIV-related test is performed, or the results of such a test in  
18 a manner that permits identification of the subject of the test, except as required or permitted by  
19 federal law, the law of this state or any rule, including any authority rule considered necessary for  
20 public health or health care purposes, or as authorized by the individual whose blood is tested.

21 (b) This subsection does not apply to an individual acting in a private capacity and not in an  
22 employment, occupational or professional capacity.

23 (5) A person who complies with the requirements of this section is not subject to an action for  
24 civil damages.

25 (6) Whenever an insurer, insurance producer or insurance-support organization asks an appli-  
26 cant for insurance to take an HIV test in connection with an application for insurance, the insurer,  
27 insurance producer or insurance-support organization must reveal the use of the test to the appli-  
28 cant and obtain the written consent of the applicant. The consent form must disclose the purpose  
29 of the test and the persons to whom the results may be disclosed.

30 **SECTION 16.** ORS 441.057 is amended to read:

31 441.057. (1) Rules adopted pursuant to ORS 441.025 shall include procedures for the filing of  
32 complaints as to the standard of care in any health care facility and provide for the confidentiality  
33 of the identity of any complainant.

34 (2) A health care facility, or person acting in the interest of the facility, may not take any dis-  
35 ciplinary or other adverse action against any employee who in good faith brings evidence of inap-  
36 propriate care or any other violation of law or rules to the attention of the proper authority solely  
37 because of the employee’s action as described in this subsection.

38 (3) Any employee who has knowledge of inappropriate care or any other violation of law or  
39 rules shall utilize established reporting procedures of the health care facility administration before  
40 notifying the Department of Human Services, Oregon Health Authority or other state agency of the  
41 alleged violation, unless the employee believes that patient health or safety is in immediate jeopardy  
42 or the employee makes the report to the department or the authority under the confidentiality pro-  
43 visions of subsection (1) of this section.

44 (4) The protection of health care facility employees under subsection (2) of this section shall  
45 commence with the reporting of the alleged violation by the employee to the administration of the

1 health care facility or to the department, authority or other state agency pursuant to subsection (3)  
2 of this section.

3 (5) Any person suffering loss or damage due to any violation of subsection (2) of this section has  
4 a right of action for damages in addition to other appropriate remedy.

5 (6) The provisions of this section do not apply to a nursing staff, as defined in ORS 441.179, who  
6 claims to be aggrieved by a violation of ORS 441.181 committed by a hospital.

7 (7) Information obtained by the department or the authority during an investigation of a com-  
8 plaint or reported violation under this section is confidential and not subject to public disclosure  
9 under ORS 192.311 to 192.478. Upon the conclusion of the investigation, the department or the au-  
10 thority may publicly release a report of the department's or the authority's findings but may not  
11 include information in the report that could be used to identify the complainant or any patient at  
12 the health care facility. The department or the authority may use any information obtained during  
13 an investigation in an administrative or judicial proceeding concerning the licensing of a health care  
14 facility, and may report information obtained during an investigation to a health professional regu-  
15 latory board as defined in ORS 676.160, the [*Nursing Home*] **Long Term Care** Administrators Board,  
16 the Board of Licensed Dietitians or the Behavior Analysis Regulatory Board as that information  
17 pertains to a licensee of the board.

18 **SECTION 17.** ORS 441.406 is amended to read:

19 441.406. (1) The Long Term Care Ombudsman shall carry out the following duties:

20 (a) Investigate and resolve complaints made by or for residents of long term care facilities about  
21 administrative actions that may adversely affect their health, safety, welfare or rights, including  
22 subpoenaing any person to appear, to give sworn testimony or to produce documentary or other  
23 evidence that is reasonably material to any matter under investigation.

24 (b) Undertake, participate in or cooperate with persons and agencies in such conferences, in-  
25 quiries, meetings or studies as may lead to improvements in the functioning of long term care fa-  
26 cilities.

27 (c) Monitor the development and implementation of federal, state and local laws, regulations and  
28 policies that relate to long term care facilities in this state.

29 (d) Provide information to public agencies about the problems of residents of long term care  
30 facilities.

31 (e) Work closely with cooperative associations and citizen groups in this state and the state  
32 protection and advocacy system under ORS 192.517.

33 (f) Widely publicize the Long Term Care Ombudsman's services, purpose and mode of operation.

34 (g) Collaborate with the Oregon Health Authority, the Department of Human Services, the  
35 [*Nursing Home*] **Long Term Care** Administrators Board and any other appropriate agencies and  
36 organizations to establish a statewide system to collect and analyze information on complaints and  
37 conditions in long term care facilities for the purpose of publicizing improvements and resolving  
38 significant problems.

39 as a residential care facility administrator; and

40 (g) Pays the licensure fee established by the office by rule.

41 (2)(a) The office may issue a provisional residential care facility administrator license to  
42 an individual who applies for licensure under this section and who is employed in Oregon as  
43 a residential care facility administrator but who does not meet all the requirements of sub-  
44 section (1)(e) and (f) of this section. An individual described in this subsection must earn a  
45 passing score on an examination described in section 3 of this 2018 Act on or before Decem-

ber 31, 2021.

(b) At its discretion and for good cause, the office may waive the requirements of subsection (1)(e) and (f) of this section.

(3) The office may issue a provisional residential care facility administrator license to an individual who is employed in a state other than Oregon as a residential care facility administrator, or similar role, but who meets the requirements of section 2 (1)(a) to (e) of this 2018 Act. An individual described in this subsection must earn a passing score on an examination described in section 3 of this 2018 Act on or before December 31, 2021.

(4) An individual who applies for a provisional license under subsection (2) or (3) of this section must pay the provisional licensure fee established by the office by rule.

(5) When issuing a license or a provisional license under this section, the office shall consider the qualifications for employment under ORS 443.004.

(6) An individual issued a license or a provisional license under this section shall meet any requirements for continuing education established by the office by rule.

(7) A provisional residential care facility administrator license issued under this section is not renewable and expires on the earlier of December 31, 2021, or the date upon which the holder is issued a license under section 2 of this 2018 Act.

(8) Not later than January 1, 2022, an individual who holds a provisional residential care facility administrator license and who is employed in Oregon as a residential care facility administrator must obtain a residential care facility license under section 2 of this 2018 Act.

(9) Licenses and provisional licenses issued under this section are subject to the provisions of ORS 678.790.

(10) Moneys collected under this section shall be paid into the General Fund and credited to the Health Licensing Office Account established under ORS 676.625.

(11) The office may adopt rules to carry out the requirements of this section, and may consult with the department in establishing any standards under this section.

SECTION 29. Section 27 of this 2018 Act is repealed on January 2, 2022.

SECTION 30. Section 28 of this 2018 Act is repealed on January 2, 2022.

SECTION 31. The unit captions used in this 2018 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2018 Act.

11 by section 6 of this 2018 Act.

12 SECTION 33. The amendments to ORS 743B.454 by section 26 of this 2018 Act apply to  
13 residential care facility administrators as defined in ORS 678.710 on and after January 1,  
14 2022.

15 SECTION 34. This 2018 Act being necessary for the immediate preservation of the public  
16 peace, health and safety, an emergency is declared to exist, and this 2018 Act takes effect  
17 on its passage.
