Extends sunset of open enrollment by one year.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** Section 21, chapter 718, Oregon Laws 2011, as amended by section 9, chapter 434,
7 Oregon Laws 2013, and section 1, chapter 60, Oregon Laws 2016, is amended to read:

8 **Sec. 21.** Section 9, chapter 718, Oregon Laws 2011, and section 7, chapter 434, Oregon Laws
9 2013, are repealed on July 1, [2019] **2020**.

10 **SECTION 2.** Section 7, chapter 690, Oregon Laws 2017, is amended to read:

11 **Sec. 7.** (1) The amendments to ORS 339.133 by section 6 [*of this 2017 Act*], **chapter 690, Oregon**
12 **Laws 2017**, become operative on July 1, [2019] **2020**.

13 (2) The amendments to ORS 339.133 by section 6 [*of this 2017 Act*], **chapter 690, Oregon Laws**
14 **2017**, apply to State School Fund distributions commencing with the [2019-2020] **2020-2021** distrib-
15 utions.

16 **SECTION 3.** Section 22, chapter 718, Oregon Laws 2011, as amended by sections 18 and 19,
17 chapter 60, Oregon Laws 2016, is amended to read:

18 **Sec. 22.** (1) Nothing in the amendments to ORS 339.133 by [*section 16 of this 2016 Act*] **section**
19 **6, chapter 690, Oregon Laws 2017**, and the repeal of section 9, chapter 718, Oregon Laws 2011,
20 by section 21, chapter 718, Oregon Laws 2011, affects the status of a person who was considered a
21 resident as provided by ORS 339.133 (5)(a)(B) prior to the [2019-2020] **2020-2021** school year.

22 **(2) A person who was not considered a resident as provided by ORS 339.133 (5)(a)(B) prior**
23 **to the 2020-2021 school year cannot be considered a resident as provided by ORS 339.133**
24 **(5)(a)(B) for the 2020-2021 school year or any subsequent school year.**

25 [(2)] **(3)** Notwithstanding section 9, chapter 718, Oregon Laws 2011, a school district is not re-
26 quired to take any action under section 9, chapter 718, Oregon Laws 2011, for the [2019-2020]
27 **2020-2021** school year.

28 **SECTION 4.** Section 24, chapter 60, Oregon Laws 2016, is amended to read:
