**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Creates tax credit for contributions to Opportunity Grant Fund. Directs Department of Revenue, in cooperation with Higher Education Coordinating Commission, to conduct auction of tax credits. Establishes Opportunity Grant Fund. Directs commission to use moneys in fund for Oregon Opportunity Grant program. Limits amount of credits per fiscal year. Applies to tax years beginning on or after January 1, 2018, and before January 1, 2024.]*

*[Requires, for Oregon income tax purposes, addition to federal taxable income of amount of federal deduction for qualified business income from pass-through entity. Applies to tax years beginning on or after January 1, 2018.]*

**Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.**

Takes effect on 91st day following adjournment sine die.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 178.300 is amended to read:

8 178.300. As used in ORS 178.300 to 178.355:

9 (1) "Account" means an individual account established in accordance with ORS 178.300 to  
10 178.355.

11 (2) "Account owner" means the person who has the right to withdraw funds from the account.  
12 The account owner may also be the designated beneficiary of the account.

13 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

14 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated  
15 at the time the account is opened as having the right to receive a qualified withdrawal for the  
16 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-  
17 cordance with ORS 178.350, the replacement.

18 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,  
19 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a  
20 mutual fund, an investment firm or other similar entity authorized to do business in this state.

21 (6) "Higher education institution" means an eligible education institution as defined in section

1 529(e)(5) of the Internal Revenue Code.

2 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect  
3 on December 31, [2016] **2017**.

4 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the  
5 Internal Revenue Code.

6 (9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

7 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified  
8 withdrawal.

9 (11) "Qualified higher education expenses" means tuition and other permitted expenses as set  
10 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated  
11 beneficiary at a higher education institution.

12 (12) "Qualified withdrawal" means a withdrawal made as prescribed under ORS 178.355 and  
13 made:

14 (a) From an account to pay the qualified higher education expenses of the designated benefi-  
15 ciary;

16 (b) As the result of the death or disability of the designated beneficiary;

17 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)  
18 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the  
19 extent of the amount of the scholarship, allowance or payment; or

20 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

21 **SECTION 1a.** ORS 178.375 is amended to read:

22 178.375. As used in this section and ORS 178.380 and 178.385:

23 (1) "ABLE account" means an account established by an eligible individual, owned by the eli-  
24 gible individual and maintained under the qualified ABLE program established by the Oregon 529  
25 Savings Board under ORS 178.380.

26 (2) "ABLE Act" means the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014  
27 (Division B of P.L. 113-295).

28 (3) "Designated beneficiary" has the same meaning as contained in section 529A of the Internal  
29 Revenue Code.

30 (4) "Eligible individual" has the same meaning as contained in section 529A of the Internal Re-  
31 venue Code.

32 (5) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect  
33 on December 31, [2015] **2017**.

34 (6) "Qualified disability expense" has the same meaning as contained in section 529A of the  
35 Internal Revenue Code.

36 **SECTION 2.** ORS 238A.005 is amended to read:

37 238A.005. For the purposes of this chapter:

38 (1) "Active member" means a member of the pension program or the individual account program  
39 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

40 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the  
41 payment or series of payments replaced, computed on the basis of interest rate and mortality as-  
42 sumptions adopted by the board.

43 (3) "Board" means the Public Employees Retirement Board.

44 (4) "Eligible employee" means a person who performs services for a participating public em-  
45 ployer, including elected officials other than judges. "Eligible employee" does not include:

- 1 (a) Persons engaged as independent contractors;
- 2 (b) Aliens working under a training or educational visa;
- 3 (c) Persons provided sheltered employment or make-work by a public employer;
- 4 (d) Persons categorized by a participating public employer as student employees;
- 5 (e) Any person who is an inmate of a state institution;
- 6 (f) Employees of foreign trade offices of the Oregon Business Development Department who live  
7 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);
- 8 (g) An employee actively participating in an alternative retirement program established under  
9 ORS 353.250 or an optional retirement plan established under ORS 341.551;
- 10 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an  
11 optional retirement plan offered under ORS 243.800;
- 12 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-  
13 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;
- 14 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,  
15 for membership in the system under the provisions of ORS chapter 238 or other law;
- 16 (k) Any person who belongs to a class of employees who are not eligible to become members  
17 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);
- 18 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who  
19 continues to receive retirement benefits while employed; and
- 20 (m) Judges.
- 21 (5) "Firefighter" means:
- 22 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job  
23 duties include the fighting of fires;
- 24 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;  
25 and
- 26 (c) An employee of the State Forestry Department who is certified by the State Forester as a  
27 professional wildland firefighter and whose primary duties include the abatement of uncontrolled  
28 fires as described in ORS 477.064.
- 29 (6) "Fund" means the Public Employees Retirement Fund.
- 30 (7)(a) "Hour of service" means:
- 31 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment  
32 by a participating public employer for performance of duties in a qualifying position; and
- 33 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave  
34 during which an employee does not perform duties but for which the employee is directly or indi-  
35 rectly paid or entitled to payment by a participating public employer for services in a qualifying  
36 position, as long as the hour is within the number of hours regularly scheduled for the performance  
37 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-  
38 thorized leave.
- 39 (b) "Hour of service" does not include any hour for which payment is made or due under a plan  
40 maintained solely for the purpose of complying with applicable unemployment compensation laws.
- 41 (8) "Inactive member" means a member of the pension program or the individual account pro-  
42 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who  
43 is not a retired member and who is not employed in a qualifying position.
- 44 (9) "Individual account program" means the defined contribution individual account program of  
45 the Oregon Public Service Retirement Plan established under ORS 238A.025.

1 (10) "Institution of higher education" means a public university listed in ORS 352.002, the  
2 Oregon Health and Science University or a community college, as defined in ORS 341.005.

3 (11) "Member" means an eligible employee who has established membership in the pension pro-  
4 gram or the individual account program of the Oregon Public Service Retirement Plan and whose  
5 membership has not been terminated under ORS 238A.110 or 238A.310.

6 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that  
7 provides retirement benefits for employees of the public employer under the system.

8 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service  
9 Retirement Plan established under ORS 238A.025.

10 (14) "Police officer" means a police officer as described in ORS 238.005.

11 (15) "Qualifying position" means one or more jobs with one or more participating public em-  
12 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,  
13 excluding any service in a job for which benefits are not provided under the Oregon Public Service  
14 Retirement Plan pursuant to ORS 238A.070 (2).

15 (16) "Retired member" means a pension program member who is receiving a pension as provided  
16 in ORS 238A.180 to 238A.195.

17 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the  
18 participating public employer, including remuneration in the form of living quarters, board or other  
19 items of value, to the extent the remuneration is includable in the employee's taxable income under  
20 Oregon law. "Salary" includes the additional amounts specified in paragraph (b) of this subsection,  
21 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether  
22 those amounts are includable in taxable income.

23 (b) "Salary" includes the following amounts:

24 (A) Payments of employee and employer money into a deferred compensation plan that are made  
25 at the election of the employee.

26 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the  
27 employee.

28 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit  
29 plan by the employer at the election of the employee and that is not includable in the taxable in-  
30 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2016]  
31 **2017**.

32 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the  
33 election of the employee and that is not included in the taxable income of the employee by reason  
34 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2016] **2017**.

35 (E) Retroactive payments described in ORS 238.008.

36 (F) The amount of an employee contribution to the individual account program that is paid by  
37 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335  
38 (1) and (2)(a).

39 (G) The amount of an employee contribution to the individual account program that is not paid  
40 by the employer under ORS 238A.335.

41 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS  
42 652.190.

43 (c) "Salary" does not include the following amounts:

44 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the  
45 employer.

1 (B) Payments made on account of an employee's death.

2 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid  
3 leave.

4 (D) Any severance payment, accelerated payment of an employment contract for a future period  
5 or advance against future wages.

6 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

7 (F) Payment for a leave of absence after the date the employer and employee have agreed that  
8 no future services in a qualifying position will be performed.

9 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or  
10 the Oregon Health and Science University when those services are in excess of full-time employment  
11 subject to this chapter. A person employed under a contract for less than 12 months is subject to  
12 this subparagraph only for the months covered by the contract.

13 (H) The amount of an employee contribution to the individual account program that is paid by  
14 the employer and is not deducted from the compensation of the employee, as provided under ORS  
15 238A.335 (1) and (2)(b).

16 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is  
17 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a  
18 fraction, the numerator of which is the number of months in the determination period and the de-  
19 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate  
20 cost-of-living adjustments authorized by the Internal Revenue Service.

21 (18) "System" means the Public Employees Retirement System.

22 (19) "Workers' compensation benefits" means:

23 (a) Payments made under ORS chapter 656; or

24 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

25 **SECTION 3.** ORS 238A.125 is amended to read:

26 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall  
27 be paid an annual pension for the life of the member as follows:

28 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied  
29 by the number of years of retirement credit attributable to service as a police officer or firefighter.

30 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary  
31 multiplied by the number of years of retirement credit attributable to service as other than a police  
32 officer or firefighter.

33 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to  
34 a member under the pension program and under any other tax-qualified defined benefit plan main-  
35 tained by the participating public employer may not exceed the applicable limitations set forth in  
36 26 U.S.C. 415(b), as in effect on December 31, [2016] 2017. The Public Employees Retirement Board  
37 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar  
38 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

39 (3) The board shall make no actuarial adjustment in a member's pension calculated under this  
40 section by reason of the member's retirement after normal retirement age.

41 **SECTION 4.** ORS 238A.150 is amended to read:

42 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-  
43 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-  
44 vices, and who subsequently returns to employment with a participating public employer with  
45 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the

1 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS  
2 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)  
3 of this section.

4 (2) The board shall adopt rules establishing benefits and service credit for any period of service  
5 in the uniformed services by an employee described in subsection (1) of this section. For the purpose  
6 of adopting rules under this subsection, the board shall consider and take into account all federal  
7 law relating to benefits and service credit for any period of service in the uniformed services, in-  
8 cluding 26 U.S.C. 414(u), as in effect on December 31, [2016] **2017**. Benefits and service credit under  
9 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit  
10 required under federal law for periods of service in the uniformed services.

11 **SECTION 5.** ORS 238A.170 is amended to read:

12 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must  
13 retire not later than April 1 of the calendar year following the calendar year in which the member  
14 terminates employment with all participating public employers. An inactive member of the pension  
15 program must retire not later than April 1 of the calendar year following the calendar year in which  
16 the member attains 70-1/2 years of age.

17 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a  
18 member of the pension program must be distributed over a time period commencing no later than  
19 the required beginning date set forth in subsection (1) of this section, and must be distributed in a  
20 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-  
21 lations implementing that section, as in effect on December 31, [2016] **2017**. The Public Employees  
22 Retirement Board shall adopt rules implementing those minimum distribution requirements.

23 **SECTION 6.** ORS 238A.230 is amended to read:

24 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-  
25 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided  
26 for in this section to:

27 (a) The spouse of the member to the extent not provided to a former spouse in accordance with  
28 a judgment or order under ORS 238.465;

29 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

30 (c) Any other person who is constitutionally required to be treated in the same manner as a  
31 spouse for the purpose of retirement benefits.

32 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse, former  
33 spouse or other person who is constitutionally required to be treated in the same manner as a  
34 spouse, and shall be the actuarial equivalent of 50 percent of the pension that would otherwise have  
35 been paid to the deceased member.

36 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would  
37 otherwise have been paid to the deceased member shall be calculated:

38 (A) As of the date of death if the member dies after the earliest retirement date for the member  
39 under ORS 238A.165; or

40 (B) As if the member became an inactive member on the date of death and thereafter retired  
41 at the earliest retirement date if the member dies before the earliest retirement date for the member  
42 under ORS 238A.165.

43 (3) The death benefit provided under this section is first effective on the first day of the month  
44 following the date of death of the member. The surviving spouse, former spouse or other person  
45 entitled to the death benefit may elect to delay payment of the death benefit, but payment must

1 commence no later than December 31 of the calendar year in which the member would have reached  
2 70-1/2 years of age.

3 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death  
4 benefits under the pension program must comply with the minimum distribution requirements of 26  
5 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on December 31, [2016]  
6 **2017**. The board shall adopt rules implementing those minimum distribution requirements.

7 **SECTION 7.** ORS 238A.370 is amended to read:

8 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition  
9 to the employee and employer accounts of a member of the individual account program for a cal-  
10 endar year, together with the annual additions to the accounts of the member under any other de-  
11 fined contribution plan maintained by the participating public employer for a calendar year, may  
12 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.  
13 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.  
14 415(c)(2), as in effect on December 31, [2016] **2017**, and "compensation" has the meaning given the  
15 term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on December 31, [2016] **2017**.  
16 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,  
17 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized  
18 by the Internal Revenue Service.

19 **SECTION 8.** ORS 238A.400 is amended to read:

20 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS  
21 238A.165, a member of the individual account program shall receive in a lump sum the amounts in  
22 the member's employee account, rollover account and employer account to the extent the member  
23 is vested in those accounts under ORS 238A.320.

24 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-  
25 ual account program may elect to receive the amounts in the member's employee account and em-  
26 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in  
27 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is  
28 equal to the anticipated life span of the member as actuarially determined by the Public Employees  
29 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event  
30 may the period selected by the member exceed the time allowed by the minimum distribution re-  
31 quirements described in subsection (5) of this section. The board shall by rule establish the manner  
32 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance  
33 during the payout period elected by the member under this subsection. The board by rule may es-  
34 tablish minimum monthly amounts payable under this subsection. The board may require that a  
35 lump sum payment, or an installment schedule different than the schedules provided for in this  
36 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not  
37 adequate to generate the minimum monthly amounts specified by the rule.

38 (3) A member of the individual account program electing to receive installments under sub-  
39 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies  
40 before all amounts in the employee and vested employer accounts are paid, all remaining installment  
41 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary  
42 may elect to receive a lump sum distribution of the remaining amounts.

43 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive  
44 vested amounts in the member's employee account, rollover account and employer account in the  
45 manner provided by this section when the member retires for service under the provisions of ORS

1 chapter 238.

2 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a  
3 member of the individual account program must be distributed over a time period commencing no  
4 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner  
5 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-  
6 plementing that section, as in effect on December 31, [2016] **2017**. The board shall adopt rules im-  
7 plementing those minimum distribution requirements.

8 **SECTION 9.** ORS 238A.410 is amended to read:

9 238A.410. (1) If a member of the individual account program dies before retirement, the amounts  
10 in the member's employee account, rollover account and employer account, to the extent the member  
11 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or  
12 beneficiaries designated by the member for the purposes of this section.

13 (2) If a member of the individual account program is married at the time of death, or there exists  
14 at the time of death any other person who is constitutionally required to be treated in the same  
15 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the  
16 beneficiary for purposes of the death benefit payable under this section unless the spouse or other  
17 person consents to the designation of a different beneficiary or beneficiaries before the designation  
18 has been made and the consent has not been revoked by the spouse or other person as of the time  
19 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a  
20 notary public, and submitted to the Public Employees Retirement Board in accordance with rules  
21 adopted by the board. If the member's spouse is designated as the member's beneficiary and the  
22 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as  
23 predeceasing the member for purposes of this section, unless the member expressly designates the  
24 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-  
25 quired to be designated as a beneficiary under the provisions of ORS 238.465.

26 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-  
27 ciary, or if the person or persons designated do not survive the member, the death benefit provided  
28 for in this section shall be paid to the following person or persons, in the following order of priority:

29 (a) The member's surviving spouse or other person who is constitutionally required to be treated  
30 in the same manner as a spouse;

31 (b) The member's surviving children, in equal shares; or

32 (c) The member's estate.

33 (4) The entire amount of a deceased member's vested accounts must be distributed by December  
34 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other  
35 provision of this chapter, distributions of death benefits under the individual account program must  
36 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-  
37 plementing that section, as in effect on December 31, [2016] **2017**. The Public Employees Retirement  
38 Board shall adopt rules implementing those minimum distribution requirements.

39 **SECTION 10.** ORS 238A.415 is amended to read:

40 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-  
41 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-  
42 vices, and who subsequently returns to employment with a participating public employer with  
43 reemployment rights under federal law, is entitled to credit toward the probationary period required

39 Public Law 94-566.

40 (13) "Taxes" means the money payments to the Unemployment Compensation Trust Fund re-  
41 quired, or voluntary payments permitted, by this chapter.

42 (14) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the  
43 individual meets the wages-paid-for-employment requirements of ORS 657.150.

44 (15) "Week" means any period of seven consecutive calendar days ending at midnight, as the  
45 director may, by regulation, prescribe. The director may by regulation prescribe that a "week" shall



1 be “in,” “within,” or “during” the calendar quarter that includes the greater part of such week.

2 **SECTION 27.** (1) Except as provided in subsections (2) and (3) of this section, the  
3 amendments to statutes by sections 1, 1a to 26 of this 2018 Act apply to transactions or ac-  
4 tivities occurring on or after January 1, 2018, in tax years beginning on or after January 1,  
5 2018.

6 (2) The effective and applicable dates, and the exceptions, special rules and coordination  
7 with the Internal Revenue Code, as amended, relative to those dates, contained in the Dis-  
8 aster Tax Relief and Airport and Airway Extension Act of 2017 (P.L. 115-63), and An Act to  
9 Provide for Reconciliation Pursuant to Titles II and V of the Concurrent Resolution on the  
10 Budget for Fiscal Year 2018 (P.L. 115-97) and other federal law amending the Internal Re-  
11 venue Code and enacted before January 1, 2018, apply for Oregon personal income and cor-  
12 porate excise and income tax purposes, to the extent they can be made applicable, in the  
13 same manner as they are applied under the Internal Revenue Code and related federal law.

14 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before  
15 January 1, 2018, and the deficiency or any portion thereof is attributable to any retroactive  
16 treatment under the amendments to ORS 178.300, 178.375, 305.230, 305.494, 305.690, 305.842,  
17 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by sections 1, 1a and 13  
18 to 24 of this 2018 Act, then any interest or penalty assessed under ORS chapter 305, 314, 315,  
19 316, 317 or 318 with respect to the deficiency or portion thereof shall be canceled.

20 (b) If a refund is due any taxpayer for a tax year beginning before January 1, 2018, and  
21 the refund or any portion thereof is due the taxpayer on account of any retroactive treat-  
22 ment under the amendments to ORS 178.300, 178.375, 305.230, 305.494, 305.690, 305.842, 314.011,  
23 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by sections 1, 1a and 13 to 24 of  
24 this 2018 Act, for a tax year beginning before January 1, 2018, then notwithstanding ORS  
25 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without in-  
26 terest.

27 (c) Any changes required because of the amendments to ORS 178.300, 178.375, 305.230,  
28 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097  
29 by sections 1, 1a and 13 to 24 of this 2018 Act, for a tax year beginning before January 1, 2018,  
30 shall be made by filing an amended return within the time prescribed by law.

31 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,  
32 the Department of Revenue shall make any changes under paragraph (c) of this subsection  
33 on the return to which the changes relate within the period specified for issuing a notice of  
34 deficiency or claiming a refund as otherwise provided by law with respect to that return, or  
35 within one year after a return for a tax year beginning on or after January 1, 2018, and be-  
36 fore January 1, 2019, is filed, whichever period expires later.

37 **SECTION 28.** This 2018 Act takes effect on the 91st day after the date on which the 2018  
38 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
