SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. **Requires, for Oregon income tax purposes, addition to federal taxable income federal dividend received deduction for repatriated income, deemed or otherwise. Applies to tax years beginning on or after January 1, 2017.**

Directs Department of Revenue to estimate amount of increased corporate tax revenue attributable to treatment of post-1986 deferred foreign income and transfer equal amount to Oregon Rainy Day Fund, on or before July 1, 2021.

Creates credit against corporate taxes in amount of lesser of Oregon tax attributable to treatment of post-1986 deferred foreign income or Oregon tax attributable to requirement, applicable to previous tax years, to add income of member of unitary group incorporated in off-shore jurisdiction. Applies to tax years beginning on or after January 1, 2017, and before January 1, 2018.

Repeals provisions requiring addition of income of member of unitary group incorporated in off-shore jurisdiction.

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 178.300 is amended to read:

9 178.300. As used in ORS 178.300 to 178.355:

10 (1) "Account" means an individual account established in accordance with ORS 178.300 to
11 178.355.

12 (2) "Account owner" means the person who has the right to withdraw funds from the account.
13 The account owner may also be the designated beneficiary of the account.

14 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

15 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated
16 at the time the account is opened as having the right to receive a qualified withdrawal for the
17 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-
18 cordance with ORS 178.350, the replacement.

19 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,

1 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a

3 (6) "Higher education institution" means an eligible education institution as defined in section
4 529(e)(5) of the Internal Revenue Code.

5 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect
6 on December 31, [2016] 2017.

7 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the
8 Internal Revenue Code.

9 (9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

10 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified
11 withdrawal.

12 (11) "Qualified higher education expenses" means tuition and other permitted expenses as set
13 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
14 beneficiary at a higher education institution.

15 (12) "Qualified withdrawal" means a withdrawal made as prescribed under ORS 178.355 and
16 made:

17 (a) From an account to pay the qualified higher education expenses of the designated benefi-
18 cary;

19 (b) As the result of the death or disability of the designated beneficiary;

20 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
21 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
22 extent of the amount of the scholarship, allowance or payment; or

23 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

24 **SECTION 2.** ORS 238A.005 is amended to read:

25 238A.005. For the purposes of this chapter:

26 (1) "Active member" means a member of the pension program or the individual account program
27 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

28 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the
29 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
30 sumptions adopted by the board.

31 (3) "Board" means the Public Employees Retirement Board.

32 (4) "Eligible employee" means a person who performs services for a participating public em-
33 ployer, including elected officials other than judges. "Eligible employee" does not include:

34 (a) Persons engaged as independent contractors;

35 (b) Aliens working under a training or educational visa;

36 (c) Persons provided sheltered employment or make-work by a public employer;

37 (d) Persons categorized by a participating public employer as student employees;

38 (e) Any person who is an inmate of a state institution;

39 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
40 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

41 (g) An employee actively participating in an alternative retirement program established under
42 ORS 353.250 or an optional retirement plan established under ORS 341.551;

43 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an
44 optional retirement plan offered under ORS 243.800;

45 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-

1 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;

2 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
3 for membership in the system under the provisions of ORS chapter 238 or other law;

4 (k) Any person who belongs to a class of employees who are not eligible to become members
5 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

6 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who
7 continues to receive retirement benefits while employed; and

8 (m) Judges.

9 (5) "Firefighter" means:

10 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
11 duties include the fighting of fires;

12 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
13 and

14 (c) An employee of the State Forestry Department who is certified by the State Forester as a
15 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
16 fires as described in ORS 477.064.

17 (6) "Fund" means the Public Employees Retirement Fund.

18 (7)(a) "Hour of service" means:

19 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
20 by a participating public employer for performance of duties in a qualifying position; and

21 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
22 during which an employee does not perform duties but for which the employee is directly or indi-
23 rectly paid or entitled to payment by a participating public employer for services in a qualifying
24 position, as long as the hour is within the number of hours regularly scheduled for the performance
25 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
26 thorized leave.

27 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
28 maintained solely for the purpose of complying with applicable unemployment compensation laws.

29 (8) "Inactive member" means a member of the pension program or the individual account pro-
30 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
31 is not a retired member and who is not employed in a qualifying position.

32 (9) "Individual account program" means the defined contribution individual account program of
33 the Oregon Public Service Retirement Plan established under ORS 238A.025.

34 (10) "Institution of higher education" means a public university listed in ORS 352.002, the
35 Oregon Health and Science University or a community college, as defined in ORS 341.005.

36 (11) "Member" means an eligible employee who has established membership in the pension pro-
37 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
38 membership has not been terminated under ORS 238A.110 or 238A.310.

39 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that
40 provides retirement benefits for employees of the public employer under the system.

41 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service
42 Retirement Plan established under ORS 238A.025.

43 (14) "Police officer" means a police officer as described in ORS 238.005.

44 (15) "Qualifying position" means one or more jobs with one or more participating public em-
45 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,

1 excluding any service in a job for which benefits are not provided under the Oregon Public Service
2 Retirement Plan pursuant to ORS 238A.070 (2).

3 (16) "Retired member" means a pension program member who is receiving a pension as provided
4 in ORS 238A.180 to 238A.195.

5 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the
6 participating public employer, including remuneration in the form of living quarters, board or other
7 items of value, to the extent the remuneration is includable in the employee's taxable income under
8 Oregon law. "Salary" includes the additional amounts specified in paragraph (b) of this subsection,
9 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
10 those amounts are includable in taxable income.

11 (b) "Salary" includes the following amounts:

12 (A) Payments of employee and employer money into a deferred compensation plan that are made
13 at the election of the employee.

14 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
15 employee.

16 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
17 plan by the employer at the election of the employee and that is not includable in the taxable in-
18 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2016]
19 **2017**.

20 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
21 election of the employee and that is not included in the taxable income of the employee by reason
22 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2016] **2017**.

23 (E) Retroactive payments described in ORS 238.008.

24 (F) The amount of an employee contribution to the individual account program that is paid by
25 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
26 (1) and (2)(a).

27 (G) The amount of an employee contribution to the individual account program that is not paid
28 by the employer under ORS 238A.335.

29 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
30 652.190.

31 (c) "Salary" does not include the following amounts:

32 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
33 employer.

34 (B) Payments made on account of an employee's death.

35 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
36 leave.

37 (D) Any severance payment, accelerated payment of an employment contract for a future period
38 or advance against future wages.

39 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

40 (F) Payment for a leave of absence after the date the employer and employee have agreed that
41 no future services in a qualifying position will be performed.

42 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or
43 the Oregon Health and Science University when those services are in excess of full-time employment
44 subject to this chapter. A person employed under a contract for less than 12 months is subject to
45 this subparagraph only for the months covered by the contract.

1 (H) The amount of an employee contribution to the individual account program that is paid by
2 the employer and is not deducted from the compensation of the employee, as provided under ORS
3 238A.335 (1) and (2)(b).

4 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is
5 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a
6 fraction, the numerator of which is the number of months in the determination period and the de-
7 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate
8 cost-of-living adjustments authorized by the Internal Revenue Service.

9 (18) "System" means the Public Employees Retirement System.

10 (19) "Workers' compensation benefits" means:

11 (a) Payments made under ORS chapter 656; or

12 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

13 **SECTION 3.** ORS 238A.125 is amended to read:

14 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
15 be paid an annual pension for the life of the member as follows:

16 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
17 by the number of years of retirement credit attributable to service as a police officer or firefighter.

18 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
19 multiplied by the number of years of retirement credit attributable to service as other than a police
20 officer or firefighter.

21 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to
22 a member under the pension program and under any other tax-qualified defined benefit plan main-
23 tained by the participating public employer may not exceed the applicable limitations set forth in
24 26 U.S.C. 415(b), as in effect on December 31, [2016] 2017. The Public Employees Retirement Board
25 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar
26 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

27 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
28 section by reason of the member's retirement after normal retirement age.

29 **SECTION 4.** ORS 238A.150 is amended to read:

30 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-
31 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
32 vices, and who subsequently returns to employment with a participating public employer with
33 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
34 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
35 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
36 of this section.

37 (2) The board shall adopt rules establishing benefits and service credit for any period of service
38 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
39 of adopting rules under this subsection, the board shall consider and take into account all federal
40 law relating to benefits and service credit for any period of service in the uniformed services, in-
41 cluding 26 U.S.C. 414(u), as in effect on December 31, [2016] 2017. Benefits and service credit under
42 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit
43 required under federal law for periods of service in the uniformed services.

44 **SECTION 5.** ORS 238A.170 is amended to read:

45 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must

1 retire not later than April 1 of the calendar year following the calendar year in which the member
2 terminates employment with all participating public employers. An inactive member of the pension
3 program must retire not later than April 1 of the calendar year following the calendar year in which
4 the member attains 70-1/2 years of age.

5 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a
6 member of the pension program must be distributed over a time period commencing no later than
7 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
8 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
9 lations implementing that section, as in effect on December 31, [2016] **2017**. The Public Employees
10 Retirement Board shall adopt rules implementing those minimum distribution requirements.

11 **SECTION 6.** ORS 238A.230 is amended to read:

12 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
13 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
14 for in this section to:

15 (a) The spouse of the member to the extent not provided to a former spouse in accordance with
16 a judgment or order under ORS 238.465;

17 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

18 (c) Any other person who is constitutionally required to be treated in the same manner as a
19 spouse for the purpose of retirement benefits.

20 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse, former
21 spouse or other person who is constitutionally required to be treated in the same manner as a
22 spouse, and shall be the actuarial equivalent of 50 percent of the pension that would otherwise have
23 been paid to the deceased member.

24 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would
25 otherwise have been paid to the deceased member shall be calculated:

26 (A) As of the date of death if the member dies after the earliest retirement date for the member
27 under ORS 238A.165; or

28 (B) As if the member became an inactive member on the date of death and thereafter retired
29 at the earliest retirement date if the member dies before the earliest retirement date for the member
30 under ORS 238A.165.

31 (3) The death benefit provided under this section is first effective on the first day of the month
32 following the date of death of the member. The surviving spouse, former spouse or other person
33 entitled to the death benefit may elect to delay payment of the death benefit, but payment must
34 commence no later than December 31 of the calendar year in which the member would have reached
35 70-1/2 years of age.

36 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death
37 benefits under the pension program must comply with the minimum distribution requirements of 26
38 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on December 31, [2016]
39 **2017**. The board shall adopt rules implementing those minimum distribution requirements.

40 **SECTION 7.** ORS 238A.370 is amended to read:

41 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
42 to the employee and employer accounts of a member of the individual account program for a cal-
43 endar year, together with the annual additions to the accounts of the member under any other de-
44 fined contribution plan maintained by the participating public employer for a calendar year, may
45 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.

1 For purposes of this section, “annual addition” has the meaning given that term in 26 U.S.C.
 2 415(c)(2), as in effect on December 31, [2016] **2017**, and “compensation” has the meaning given the
 3 term “participant’s compensation” in 26 U.S.C. 415(c)(3), as in effect on December 31, [2016] **2017**.
 4 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,
 5 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized
 6 by the Internal Revenue Service.

7 **SECTION 8.** ORS 238A.400 is amended to read:

8 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
 9 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
 10 the member’s employee account, rollover account and employer account to the extent the member
 11 is vested in those accounts under ORS 238A.320.

12 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
 13 ual account program may elect to receive the amounts in the member’s employee account and em-
 14 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
 15 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
 16 equal to the anticipated life span of the member as actuarially determined by the Public Employees
 17 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
 18 may the period selected by the member exceed the time allowed by the minimum distribution re-
 19 quirements described in subsection (5) of this section. The board shall by rule establish the manner
 20 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
 21 during the payout period elected by the member under this subsection. The board by rule may es-
 22 tablish minimum monthly amounts payable under this subsection. The board may require that a
 23 lump sum payment, or an installment schedule different than the schedules provided for in this
 24 subsection, be used to pay the vested amounts in the member’s accounts if those amounts are not
 25 adequate to generate the minimum monthly amounts specified by the rule.

26 (3) A member of the individual account program electing to receive installments under sub-
 27 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
 28 before all amounts in the employee and vested employer accounts are paid, all remaining installment
 29 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
 30 may elect to receive a lump sum distribution of the remaining amounts.

31 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
 32 vested amounts in the member’s employee account, rollover account and employer account in the
 33 manner provided by this section when the member retires for service under the provisions of ORS
 34 chapter 238.

35 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
 36 member of the individual account program must be distributed over a time period commencing no
 37 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
 38 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
 39 plementing that section, as in effect on December 31, [2016] **2017**. The board shall adopt rules im-
 40 plementing those minimum distribution requirements.

41 **SECTION 9.** ORS 238A.410 is amended to read:

42 238A.410. (1) If a member of the individual account program dies before retirement, the amounts
 43 in the member’s employee account, rollover account and employer account, to the extent the member
 44 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or
 45 beneficiaries designated by the member for the purposes of this section.

1 (2) If a member of the individual account program is married at the time of death, or there exists
 2 at the time of death any other person who is constitutionally required to be treated in the same
 3 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
 4 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
 5 person consents to the designation of a different beneficiary or beneficiaries before the designation
 6 has been made and the consent has not been revoked by the spouse or other person as of the time
 7 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
 8 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
 9 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
 10 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
 11 predeceasing the member for purposes of this section, unless the member expressly designates the
 12 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
 13 quired to be designated as a beneficiary under the provisions of ORS 238.465.

14 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
 15 ciary, or if the person or persons designated do not survive the member, the death benefit provided
 16 for in this section shall be paid to the following person or persons, in the following order of priority:

17 (a) The member's surviving spouse or other person who is constitutionally required to be treated
 18 in the same manner as a spouse;

19 (b) The member's surviving children, in equal shares; or

20 (c) The member's estate.

21 (4) The entire amount of a deceased member's vested accounts must be distributed by December
 22 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
 23 provision of this chapter, distributions of death benefits under the individual account program must
 24 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
 25 plementing that section, as in effect on December 31, [2016] 2017. The Public Employees Retirement
 26 Board shall adopt rules implementing those minimum distribution requirements.

27 **SECTION 10.** ORS 238A.415 is amended to read:

28 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-
 29 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
 30 vices, and who subsequently returns to employment with a participating public employer with
 31 reemployment rights under federal law, is entitled to credit toward the probationary period required
 32 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under
 33 rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.

34 (2) The board shall adopt rules establishing contributions and service credit for any period of
 35 service in the uniformed services by an employee described in subsection (1) of this section. For the
 36 purpose of adopting rules under this subsection, the board shall consider and take into account all
 37 federal law relating to benefits and service credit for any period of service in the uniformed ser-
 38 vices, including 26 U.S.C. 414(u), as in effect on December 31, [2016] 2017. Contributions and service
 39 credit under rules adopted by the board pursuant to this subsection may not exceed contributions
 40 and service credit required under federal law for periods of service in the uniformed services.

41 **SECTION 11.** ORS 238A.430 is amended to read:

42 238A.430. (1) To the extent required by law, and except as otherwise provided by rules adopted
 43 by the Public Employees Retirement Board under subsection (4) of this section, any portion of a
 44 distribution of benefits described in subsection (2) of this section shall, at the election of and in lieu
 45 of distribution to the distributee, be paid directly to an eligible retirement plan specified by the

1 distributee.

6 (xviii) Rental allowance paid to a minister that is excluded from federal gross income.

7 (xix) Income from sources without the United States that is excluded from federal gross income.

8 (B) Adjusted gross income shall be increased due to the disallowance of the following de-
9 ductions:

10 (i) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intangible
11 properties.

12 (ii) The amount of the net loss, in excess of \$1,000, from the operation of a farm or farms.

13 (iii) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,
14 profession or other activity entered into for the production or collection of income.

15 (iv) The amount of the net loss, in excess of \$1,000, from tangible or intangible property held for
16 the production of rents, royalties or other income.

17 (v) The amount of any net operating loss carryovers or carrybacks included in federal adjusted
18 gross income.

23 (C) "Income" does not include the following:

27 (d) "Net pension income" means:

28 (A) For eligible individuals filing a joint return, the lesser of the pension income of the eligible
29 individuals received during the taxable year or the excess, if any, of \$15,000 over the sum of the
30 following amounts:

31 (i) Any Social Security benefits received by the eligible individual, or by the spouse of the in-
32 dividual, during the taxable year; and

 6 **318 with respect to the deficiency or portion thereof shall be canceled.**

7 **(b) If a refund is due any taxpayer for a tax year beginning before January 1, 2018, and**
 8 **the refund or any portion thereof is due the taxpayer on account of any retroactive treat-**
 9 **ment under the amendments to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306,**
 10 **315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by sections 1 and 13 to 24 of this 2018 Act,**
 11 **for a tax year beginning before January 1, 2018, then notwithstanding ORS 305.270 or 314.415**
 12 **or any other law, the refund or portion thereof shall be paid without interest.**

13 **(c) Any changes required because of the amendments to ORS 178.300, 305.230, 305.494,**
 14 **305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by**
 15 **sections 1 and 13 to 24 of this 2018 Act, for a tax year beginning before January 1, 2018, shall**
 16 **be made by filing an amended return within the time prescribed by law.**

17 **(d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,**
 18 **the Department of Revenue shall make any changes under paragraph (c) of this subsection**
 19 **on the return to which the changes relate within the period specified for issuing a notice of**
 20 **deficiency or claiming a refund as otherwise provided by law with respect to that return, or**
 21 **within one year after a return for a tax year beginning on or after January 1, 2018, and be-**
 22 **fore January 1, 2019, is filed, whichever period expires later.**

23 **SECTION 28.** ORS 317.267 is amended to read:

24 317.267. (1) To derive Oregon taxable income, there shall be added to federal taxable income
 25 amounts received as dividends from corporations deducted for federal purposes pursuant to section
 26 243 or 245 of the Internal Revenue Code, except section 245(c) of the Internal Revenue Code,
 27 **amounts deducted for income repatriated, deemed or otherwise, under section 965 of the**
 28 **Internal Revenue Code,** amounts paid as dividends by a public utility or telecommunications utility
 29 and deducted for federal purposes pursuant to section 247 of the Internal Revenue Code or dividends
 30 eliminated under Treasury Regulations adopted under section 1502 of the Internal Revenue Code
 31 that are paid by members of an affiliated group that are eliminated from a consolidated federal re-
 32 turn pursuant to ORS 317.715 (2).

33 (2) To derive Oregon taxable income, after the modification prescribed under subsection (1) of
 34 this section, there shall be subtracted from federal taxable income an amount equal to 70 percent
 35 of dividends (determined without regard to section 78 of the Internal Revenue Code) received or
 36 deemed received from corporations if such dividends are included in federal taxable income. How-
 37 ever:

38 (a) In the case of any dividend on debt-financed portfolio stock as described in section 246A of
 39 the Internal Revenue Code, the subtraction allowed under this subsection shall be reduced under the
 40 same conditions and in same amount as the dividends received deduction otherwise allowable for
 41 federal income tax purposes is reduced under section 246A of the Internal Revenue Code.

42 (b) In the case of any dividend received from a 20 percent owned corporation, as defined in
 43 section 243(c) of the Internal Revenue Code, this subsection shall be applied by substituting “80
 44 percent” for “70 percent.”

45 (c) A dividend that is not treated as a dividend under section 243(d) or 965(c)(3) of the Internal

1 Revenue Code may not be treated as a dividend for purposes of this subsection.

2 (d) If a dividends received deduction is not allowed for federal tax purposes because of section
3 246(a) or (c) of the Internal Revenue Code, a subtraction may not be made under this subsection for
4 received dividends that are described in section 246(a) or (c) of the Internal Revenue Code.

5 (e) In the case of any dividend received from an alien, domestic or foreign insurer, as defined
6 in ORS 731.082, that would be included in the taxpayer's consolidated Oregon return but for the
7 application of ORS 317.710 (5) or (7), this subsection shall be applied by substituting "100 percent"
8 for "70 percent."

9 (3) There shall be excluded from the sales factor of any apportionment formula employed to at-
10 tribute income to this state any amount subtracted from federal taxable income under subsection (2)
11 of this section.

12 **SECTION 29.** The amendments to ORS 317.267 by section 28 of this 2018 Act apply to tax
13 years beginning on or after January 1, 2017.

14 **SECTION 30.** Section 31 of this 2018 Act is added to and made a part of ORS chapter 317.

15 **SECTION 31.** On or before July 1, 2021, the Department of Revenue shall:

16 (1) Estimate the increase, if any, of corporate tax revenue received by the department
17 and attributable to the treatment of post-1986 deferred foreign income under section 965 of
18 the Internal Revenue Code, less amounts allowed as credits under section 33 of this 2018 Act;
19 and

20 (2) Transfer an amount equal to the estimate required under subsection (1) of this sec-
21 tion to the Oregon Rainy Day Fund established under ORS 293.144.

22 **SECTION 32.** Section 33 of this 2018 Act is added to and made a part of ORS chapter 317.

23 **SECTION 33.** (1) A credit against the taxes otherwise due under ORS chapter 317 or 318
24 shall be allowed to a taxpayer for Oregon tax attributable to income reported under section
25 965 of the Internal Revenue Code as post-1986 deferred foreign income.

26 (2) The credit allowed under this section may not exceed the lesser of:

27 (a) The amount of Oregon tax attributable to income reported under section 965 of the
28 Internal Revenue Code as post-1986 deferred foreign income for tax years beginning on or
29 after January 1, 2017, and before January 1, 2018; or

30 (b) The total amount of tax, if any, attributable to the addition required under ORS
31 317.716 and imposed for all tax years beginning on or after January 1, 2014, and before Jan-
32 uary 1, 2017.

33 (3) The credit allowed under this section may not exceed the tax liability of the taxpayer
34 for the tax year.

35 (4) Any tax credit otherwise allowable under this section that is not used by the taxpayer
36 in a particular tax year may be carried forward and offset against the taxpayer's tax liability
37 for the next succeeding tax year. Any credit remaining unused in the next succeeding tax
38 year may be carried forward and used in the second succeeding tax year. Any credit re-
39 maining unused in the second succeeding tax year may be carried forward and used in the
40 third succeeding tax year. Any credit remaining unused in the third succeeding tax year may
41 be carried forward and used in the fourth succeeding tax year. Any credit remaining unused
42 in the fourth succeeding tax year may be carried forward and used in the fifth succeeding
43 tax year, but may not be used in any tax year thereafter.

44 **SECTION 34.** Except as provided in section 33 (4) of this 2018 Act, section 33 of this 2018
45 Act applies to tax years beginning on or after January 1, 2017, and before January 1, 2018.

1 **SECTION 35.** ORS 317.716 and 317.717 are repealed.

2 **SECTION 36.** The repeal of ORS 317.716 and 317.717 by section 35 of this 2018 Act applies
3 to tax years beginning on or after January 1, 2017.

4 **SECTION 37.** This 2018 Act takes effect on the 91st day after the date on which the 2018
5 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
