**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. Requires, for Oregon income tax purposes, addition to federal taxable income federal dividend received deduction for repatriated income, deemed or otherwise. Applies to tax years beginning on or after January 1, 2017.

**Establishes Employer Incentive Fund for purpose of incentivizing participating public employers to make lump sum prepayments of employer contributions to Public Employees Retirement System. Establishes School Districts Unfunded Liability Fund for purpose of applying moneys against liabilities of participating public employers in system that are school districts.**

Directs Department of Revenue to estimate amount of increased corporate tax revenue attributable to treatment of post-1986 deferred foreign income and [*transfer equal amount to Oregon Rainy Day Fund,*] **distribute entire estimated amount to Employer Incentive Fund and to School Districts Unfunded Liability Fund,** on or before July 1, 2021.

Creates credit against corporate taxes in amount of lesser of Oregon tax attributable to treatment of post-1986 deferred foreign income or Oregon tax attributable to requirement, applicable to previous tax years, to add income of member of unitary group incorporated in off-shore jurisdiction. Applies to tax years beginning on or after January 1, 2017, and before January 1, 2018.

Repeals provisions requiring addition of income of member of unitary group incorporated in off-shore jurisdiction.

**Directs Department of Revenue to report to committee of Legislative Assembly on relative efficacy of Oregon law requiring inclusion for corporate tax purposes income of corporation incorporated in off-shore jurisdictions, in comparison to federal law provision requiring shareholders of controlled foreign corporations to include global intangible low-taxed income in gross income.**

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 178.300 is amended to read:

9 178.300. As used in ORS 178.300 to 178.355:

10 (1) "Account" means an individual account established in accordance with ORS 178.300 to  
11 178.355.

12 (2) "Account owner" means the person who has the right to withdraw funds from the account.

13 The account owner may also be the designated beneficiary of the account.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

2 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated  
3 at the time the account is opened as having the right to receive a qualified withdrawal for the  
4 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-  
5 cordance with ORS 178.350, the replacement.

6 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,  
7 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a  
8 mutual fund, an investment firm or other similar entity authorized to do business in this state.

9 (6) "Higher education institution" means an eligible education institution as defined in section  
10 529(e)(5) of the Internal Revenue Code.

11 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect  
12 on December 31, [2016] 2017.

13 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the  
14 Internal Revenue Code.

15 (9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

16 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified  
17 withdrawal.

18 (11) "Qualified higher education expenses" means tuition and other permitted expenses as set  
19 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated  
20 beneficiary at a higher education institution.

21 (12) "Qualified withdrawal" means a withdrawal made as prescribed under ORS 178.355 and  
22 made:

23 (a) From an account to pay the qualified higher education expenses of the designated benefi-  
24 ciary;

25 (b) As the result of the death or disability of the designated beneficiary;

26 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)  
27 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the  
28 extent of the amount of the scholarship, allowance or payment; or

29 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

30 **SECTION 2.** ORS 238A.005 is amended to read:

31 238A.005. For the purposes of this chapter:

32 (1) "Active member" means a member of the pension program or the individual account program  
33 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

34 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the  
35 payment or series of payments replaced, computed on the basis of interest rate and mortality as-  
36 sumptions adopted by the board.

37 (3) "Board" means the Public Employees Retirement Board.

38 (4) "Eligible employee" means a person who performs services for a participating public em-  
39 ployer, including elected officials other than judges. "Eligible employee" does not include:

40 (a) Persons engaged as independent contractors;

41 (b) Aliens working under a training or educational visa;

42 (c) Persons provided sheltered employment or make-work by a public employer;

43 (d) Persons categorized by a participating public employer as student employees;

44 (e) Any person who is an inmate of a state institution;

45 (f) Employees of foreign trade offices of the Oregon Business Development Department who live

1 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

2 (g) An employee actively participating in an alternative retirement program established under  
3 ORS 353.250 or an optional retirement plan established under ORS 341.551;

4 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an  
5 optional retirement plan offered under ORS 243.800;

6 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-  
7 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;

8 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,  
9 for membership in the system under the provisions of ORS chapter 238 or other law;

10 (k) Any person who belongs to a class of employees who are not eligible to become members  
11 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

12 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who  
13 continues to receive retirement benefits while employed; and

14 (m) Judges.

15 (5) "Firefighter" means:

16 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job  
17 duties include the fighting of fires;

18 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;  
19 and

20 (c) An employee of the State Forestry Department who is certified by the State Forester as a  
21 professional wildland firefighter and whose primary duties include the abatement of uncontrolled  
22 fires as described in ORS 477.064.

23 (6) "Fund" means the Public Employees Retirement Fund.

24 (7)(a) "Hour of service" means:

25 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment  
26 by a participating public employer for performance of duties in a qualifying position; and

27 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave  
28 during which an employee does not perform duties but for which the employee is directly or indi-  
29 rectly paid or entitled to payment by a participating public employer for services in a qualifying  
30 position, as long as the hour is within the number of hours regularly scheduled for the performance  
31 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-  
32 thorized leave.

33 (b) "Hour of service" does not include any hour for which payment is made or due under a plan  
34 maintained solely for the purpose of complying with applicable unemployment compensation laws.

35 (8) "Inactive member" means a member of the pension program or the individual account pro-  
36 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who  
37 is not a retired member and who is not employed in a qualifying position.

38 (9) "Individual account program" means the defined contribution individual account program of  
39 the Oregon Public Service Retirement Plan established under ORS 238A.025.

40 (10) "Institution of higher education" means a public university listed in ORS 352.002, the  
41 Oregon Health and Science University or a community college, as defined in ORS 341.005.

42 (11) "Member" means an eligible employee who has established membership in the pension pro-  
43 gram or the individual account program of the Oregon Public Service Retirement Plan and whose  
44 membership has not been terminated under ORS 238A.110 or 238A.310.

45 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that

1 provides retirement benefits for employees of the public employer under the system.

2 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service  
3 Retirement Plan established under ORS 238A.025.

4 (14) "Police officer" means a police officer as described in ORS 238.005.

5 (15) "Qualifying position" means one or more jobs with one or more participating public em-  
6 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,  
7 excluding any service in a job for which benefits are not provided under the Oregon Public Service  
8 Retirement Plan pursuant to ORS 238A.070 (2).

9 (16) "Retired member" means a pension program member who is receiving a pension as provided  
10 in ORS 238A.180 to 238A.195.

11 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the  
12 participating public employer, including remuneration in the form of living quarters, board or other  
13 items of value, to the extent the remuneration is includable in the employee's taxable income under  
14 Oregon law. "Salary" includes the additional amounts specified in paragraph (b) of this subsection,  
15 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether  
16 those amounts are includable in taxable income.

17 (b) "Salary" includes the following amounts:

18 (A) Payments of employee and employer money into a deferred compensation plan that are made  
19 at the election of the employee.

20 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the  
21 employee.

22 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit  
23 plan by the employer at the election of the employee and that is not includable in the taxable in-  
24 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2016]  
25 **2017**.

26 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the  
27 election of the employee and that is not included in the taxable income of the employee by reason  
28 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2016] **2017**.

29 (E) Retroactive payments described in ORS 238.008.

30 (F) The amount of an employee contribution to the individual account program that is paid by  
31 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335  
32 (1) and (2)(a).

33 (G) The amount of an employee contribution to the individual account program that is not paid  
34 by the employer under ORS 238A.335.

35 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS  
36 652.190.

37 (c) "Salary" does not include the following amounts:

38 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the  
39 employer.

40 (B) Payments made on account of an employee's death.

41 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid  
42 leave.

43 (D) Any severance payment, accelerated payment of an employment contract for a future period  
44 or advance against future wages.

45 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

1 (F) Payment for a leave of absence after the date the employer and employee have agreed that  
2 no future services in a qualifying position will be performed.

3 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or  
4 the Oregon Health and Science University when those services are in excess of full-time employment  
5 subject to this chapter. A person employed under a contract for less than 12 months is subject to  
6 this subparagraph only for the months covered by the contract.

7 (H) The amount of an employee contribution to the individual account program that is paid by  
8 the employer and is not deducted from the compensation of the employee, as provided under ORS  
9 238A.335 (1) and (2)(b).

10 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is  
11 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a  
12 fraction, the numerator of which is the number of months in the determination period and the de-  
13 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate  
14 cost-of-living adjustments authorized by the Internal Revenue Service.

15 (18) "System" means the Public Employees Retirement System.

16 (19) "Workers' compensation benefits" means:

17 (a) Payments made under ORS chapter 656; or

18 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

19 **SECTION 3.** ORS 238A.125 is amended to read:

20 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall  
21 be paid an annual pension for the life of the member as follows:

22 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied  
23 by the number of years of retirement credit attributable to service as a police officer or firefighter.

24 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary  
25 multiplied by the number of years of retirement credit attributable to service as other than a police  
26 officer or firefighter.

27 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to  
28 a member under the pension program and under any other tax-qualified defined benefit plan main-  
29 tained by the participating public employer may not exceed the applicable limitations set forth in  
30 26 U.S.C. 415(b), as in effect on December 31, [2016] 2017. The Public Employees Retirement Board  
31 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar  
32 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

33 (3) The board shall make no actuarial adjustment in a member's pension calculated under this  
34 section by reason of the member's retirement after normal retirement age.

35 **SECTION 4.** ORS 238A.150 is amended to read:

36 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-  
37 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-  
38 vices, and who subsequently returns to employment with a participating public employer with  
39 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the  
40 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS  
41 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)  
42 of this section.

43 (2) The board shall adopt rules establishing benefits and service credit for any period of service  
44 in the uniformed services by an employee described in subsection (1) of this section. For the purpose  
45 of adopting rules under this subsection, the board shall consider and take into account all federal

1 law relating to benefits and service credit for any period of service in the uniformed services, in-  
2 cluding 26 U.S.C. 414(u), as in effect on December 31, [2016] **2017**. Benefits and service credit under  
3 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit  
4 required under federal law for periods of service in the uniformed services.

5 **SECTION 5.** ORS 238A.170 is amended to read:

6 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must  
7 retire not later than April 1 of the calendar year following the calendar year in which the member  
8 terminates employment with all participating public employers. An inactive member of the pension  
9 program must retire not later than April 1 of the calendar year following the calendar year in which  
10 the member attains 70-1/2 years of age.

11 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a  
12 member of the pension program must be distributed over a time period commencing no later than  
13 the required beginning date set forth in subsection (1) of this section, and must be distributed in a  
14 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-  
15 lations implementing that section, as in effect on December 31, [2016] **2017**. The Public Employees  
16 Retirement Board shall adopt rules implementing those minimum distribution requirements.

17 **SECTION 6.** ORS 238A.230 is amended to read:

18 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-  
19 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided  
20 for in this section to:

21 (a) The spouse of the member to the extent not provided to a former spouse in accordance with  
22 a judgment or order under ORS 238.465;

23 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

24 (c) Any other person who is constitutionally required to be treated in the same manner as a  
25 spouse for the purpose of retirement benefits.

26 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse, former  
27 spouse or other person who is constitutionally required to be treated in the same manner as a  
28 spouse, and shall be the actuarial equivalent of 50 percent of the pension that would otherwise have  
29 been paid to the deceased member.

30 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would  
31 otherwise have been paid to the deceased member shall be calculated:

32 (A) As of the date of death if the member dies after the earliest retirement date for the member  
33 under ORS 238A.165; or

34 (B) As if the member became an inactive member on the date of death and thereafter retired  
35 at the earliest retirement date if the member dies before the earliest retirement date for the member  
36 under ORS 238A.165.

37 (3) The death benefit provided under this section is first effective on the first day of the month  
38 following the date of death of the member. The surviving spouse, former spouse or other person  
39 entitled to the death benefit may elect to delay payment of the death benefit, but payment must  
40 commence no later than December 31 of the calendar year in which the member would have reached  
41 70-1/2 years of age.

42 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death  
43 benefits under the pension program must comply with the minimum distribution requirements of 26  
44 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on December 31, [2016]  
45 **2017**. The board shall adopt rules implementing those minimum distribution requirements.

1       **SECTION 7.** ORS 238A.370 is amended to read:

2       238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition  
3 to the employee and employer accounts of a member of the individual account program for a cal-  
4 endar year, together with the annual additions to the accounts of the member under any other de-  
5 fined contribution plan maintained by the participating public employer for a calendar year, may  
6 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.  
7 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.  
8 415(c)(2), as in effect on December 31, [2016] **2017**, and "compensation" has the meaning given the  
9 term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on December 31, [2016] **2017**.  
10 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,  
11 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized  
12 by the Internal Revenue Service.

13       **SECTION 8.** ORS 238A.400 is amended to read:

14       238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS  
15 238A.165, a member of the individual account program shall receive in a lump sum the amounts in  
16 the member's employee account, rollover account and employer account to the extent the member  
17 is vested in those accounts under ORS 238A.320.

18       (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-  
19 ual account program may elect to receive the amounts in the member's employee account and em-  
20 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in  
21 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is  
22 equal to the anticipated life span of the member as actuarially determined by the Public Employees  
23 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event  
24 may the period selected by the member exceed the time allowed by the minimum distribution re-  
25 quirements described in subsection (5) of this section. The board shall by rule establish the manner  
26 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance  
27 during the payout period elected by the member under this subsection. The board by rule may es-  
28 tablish minimum monthly amounts payable under this subsection. The board may require that a  
29 lump sum payment, or an installment schedule different than the schedules provided for in this  
30 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not  
31 adequate to generate the minimum monthly amounts specified by the rule.

32       (3) A member of the individual account program electing to receive installments under sub-  
33 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies  
34 before all amounts in the employee and vested employer accounts are paid, all remaining installment  
35 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary  
36 may elect to receive a lump sum distribution of the remaining amounts.

37       (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive  
38 vested amounts in the member's employee account, rollover account and employer account in the  
39 manner provided by this section when the member retires for service under the provisions of ORS  
40 chapter 238.

41       (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a  
42 member of the individual account program must be distributed over a time period commencing no  
43 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner  
44 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-  
45 plementing that section, as in effect on December 31, [2016] **2017**. The board shall adopt rules im-

1 plementing those minimum distribution requirements.

2 **SECTION 9.** ORS 238A.410 is amended to read:

3 238A.410. (1) If a member of the individual account program dies before retirement, the amounts  
4 in the member's employee account, rollover account and employer account, to the extent the member  
5 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or  
6 beneficiaries designated by the member for the purposes of this section.

7 (2) If a member of the individual account program is married at the time of death, or there exists  
8 at the time of death any other person who is constitutionally required to be treated in the same  
9 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the  
10 beneficiary for purposes of the death benefit payable under this section unless the spouse or other  
11 person consents to the designation of a different beneficiary or beneficiaries before the designation  
12 has been made and the consent has not been revoked by the spouse or other person as of the time  
13 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a  
14 notary public, and submitted to the Public Employees Retirement Board in accordance with rules  
15 adopted by the board. If the member's spouse is designated as the member's beneficiary and the  
16 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as

21 ciary, or if the person or persons designated do not survive the member, the death benefit provided

24 in the same manner as a spouse;

25 (b) The member's surviving children, in equal shares; or

26 (c) The member's estate.

27 (4) The entire amount of a deceased member's vested accounts must be distributed by December  
28 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other  
29 provision of this chapter, distributions of death benefits under the individual account program must  
30 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-  
31 plementing that section, as in effect on December 31, [2016] 2017. The Public Employees Retirement  
32 Board shall adopt rules implementing those minimum distribution requirements.

33 **SECTION 10.** ORS 238A.415 is amended to read:

34 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-  
35 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-  
36 vices, and who subsequently returns to employment with a participating public employer with  
37 reemployment rights under federal law, is entitled to credit toward the probationary period required  
38 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under

44 (xi) Worker's compensation, except for reimbursement of medical expense.

- 2 (xiv) Payments received under the federal Social Security Act that are excluded from federal

35 quired, or voluntary payments permitted, by this chapter.

36 (14) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the  
37 individual meets the wages-paid-for-employment requirements of ORS 657.150.

38 (15) "Week" means any period of seven consecutive calendar days ending at midnight, as the  
39 director may, by regulation, prescribe. The director may by regulation prescribe that a "week" shall  
40 be "in," "within," or "during" the calendar quarter that includes the greater part of such week.

41 **SECTION 27. (1) Except as provided in subsections (2) and (3) of this section, the**  
42 **amendments to statutes by sections 1 to 26 of this 2018 Act apply to transactions or activities**  
43 **occurring on or after January 1, 2018, in tax years beginning on or after January 1, 2018.**

44 **(2) The effective and applicable dates, and the exceptions, special rules and coordination**  
45 **with the Internal Revenue Code, as amended, relative to those dates, contained in the Dis-**

1 aster Tax Relief and Airport and Airway Extension Act of 2017 (P.L. 115-63), and An Act to  
 2 Provide for Reconciliation Pursuant to Titles II and V of the Concurrent Resolution on the  
 3 Budget for Fiscal Year 2018 (P.L. 115-97) and other federal law amending the Internal Re-  
 4 venue Code and enacted before January 1, 2018, apply for Oregon personal income and cor-  
 5 porate excise and income tax purposes, to the extent they can be made applicable, in the  
 6 same manner as they are applied under the Internal Revenue Code and related federal law.

7 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before  
 8 January 1, 2018, and the deficiency or any portion thereof is attributable to any retroactive  
 9 treatment under the amendments to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011,  
 10 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by sections 1 and 13 to 24 of this  
 11 2018 Act, then any interest or penalty assessed under ORS chapter 305, 314, 315, 316, 317 or  
 12 318 with respect to the deficiency or portion thereof shall be canceled.

13 (b) If a refund is due any taxpayer for a tax year beginning before January 1, 2018, and  
 14 the refund or any portion thereof is due the taxpayer on account of any retroactive treat-  
 15 ment under the amendments to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306,  
 16 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by sections 1 and 13 to 24 of this 2018 Act,  
 17 for a tax year beginning before January 1, 2018, then notwithstanding ORS 305.270 or 314.415  
 18 or any other law, the refund or portion thereof shall be paid without interest.

19 (c) Any changes required because of the amendments to ORS 178.300, 305.230, 305.494,  
 20 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010 and 317.097 by  
 21 sections 1 and 13 to 24 of this 2018 Act, for a tax year beginning before January 1, 2018, shall  
 22 be made by filing an amended return within the time prescribed by law.

23 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,  
 24 the Department of Revenue shall make any changes under paragraph (c) of this subsection  
 25 on the return to which the changes relate within the period specified for issuing a notice of  
 26 deficiency or claiming a refund as otherwise provided by law with respect to that return, or  
 27 within one year after a return for a tax year beginning on or after January 1, 2018, and be-  
 28 fore January 1, 2019, is filed, whichever period expires later.

29 **SECTION 28.** ORS 317.267 is amended to read:

30 317.267. (1) To derive Oregon taxable income, there shall be added to federal taxable income  
 31 amounts received as dividends from corporations deducted for federal purposes pursuant to section  
 32 243 or 245 of the Internal Revenue Code, except section 245(c) of the Internal Revenue Code,  
 33 **amounts deducted for income repatriated, deemed or otherwise, under An Act to Provide for**  
 34 **Reconciliation Pursuant to Titles II and V of the Concurrent Resolution on the Budget for**  
 35 **Fiscal Year 2018 (P.L. 115-97),** amounts paid as dividends by a public utility or telecommunications  
 36 utility and deducted for federal purposes pursuant to section 247 of the Internal Revenue Code or  
 37 dividends eliminated under Treasury Regulations adopted under section 1502 of the Internal Revenue  
 38 Code that are paid by members of an affiliated group that are eliminated from a consolidated federal  
 39 return pursuant to ORS 317.715 (2).

40 (2) To derive Oregon taxable income, after the modification prescribed under subsection (1) of  
 41 this section, there shall be subtracted from federal taxable income an amount equal to 70 percent  
 42 of dividends (determined without regard to section 78 of the Internal Revenue Code) received or  
 43 deemed received from corporations if such dividends are included in federal taxable income. How-  
 44 ever:

45 (a) In the case of any dividend on debt-financed portfolio stock as described in section 246A of

1 the Internal Revenue Code, the subtraction allowed under this subsection shall be reduced under the  
 2 same conditions and in same amount as the dividends received deduction otherwise allowable for  
 3 federal income tax purposes is reduced under section 246A of the Internal Revenue Code.

4 (b) In the case of any dividend received from a 20 percent owned corporation, as defined in  
 5 section 243(c) of the Internal Revenue Code, this subsection shall be applied by substituting “80  
 6 percent” for “70 percent.”

7 (c) A dividend that is not treated as a dividend under section 243(d) or 965(c)(3) of the Internal  
 8 Revenue Code may not be treated as a dividend for purposes of this subsection.

9 (d) If a dividends received deduction is not allowed for federal tax purposes because of section  
 10 246(a) or (c) of the Internal Revenue Code, a subtraction may not be made under this subsection for  
 11 received dividends that are described in section 246(a) or (c) of the Internal Revenue Code.

12 (e) In the case of any dividend received from an alien, domestic or foreign insurer, as defined  
 13 in ORS 731.082, that would be included in the taxpayer’s consolidated Oregon return but for the  
 14 application of ORS 317.710 (5) or (7), this subsection shall be applied by substituting “100 percent”  
 15 for “70 percent.”

16 (3) There shall be excluded from the sales factor of any apportionment formula employed to at-  
 17 tribute income to this state any amount subtracted from federal taxable income under subsection (2)  
 18 of this section.

19 **SECTION 29. The amendments to ORS 317.267 by section 28 of this 2018 Act apply to tax**  
 20 **years beginning on or after January 1, 2017.**

21 **SECTION 30. Section 31 of this 2018 Act is added to and made a part of ORS chapter 317.**

22 **SECTION 31. On or before July 1, 2021, the Department of Revenue shall:**

23 (1) Estimate the increase, if any, of corporate tax revenue received by the department  
 24 and attributable to the treatment of post-1986 deferred foreign income under An Act to  
 25 Provide for Reconciliation Pursuant to Titles II and V of the Concurrent Resolution on the  
 26 Budget for Fiscal Year 2018 (P.L. 115-97); and

27 (2) Notwithstanding ORS 317.853, distribute an amount equal to the estimate required  
 28 under subsection (1) of this section as follows:

29 (a) 18 percent shall be transferred to the Employer Incentive Fund established under  
 30 section 31a of this 2018 Act.

31 (b) 82 percent shall be transferred to the School Districts Unfunded Liability Fund es-  
 32 tablished under section 31b of this 2018 Act.

33 **SECTION 31a. (1) The Employer Incentive Fund is established in the State Treasury,**  
 34 **separate and distinct from the General Fund. Interest earned by the Employer Incentive**  
 35 **Fund shall be credited to the fund.**

36 (2) Moneys in the fund are continuously appropriated to the Public Employees Retirement  
 37 Board for the purpose of incentivizing participating public employers, as defined in ORS  
 38 238.005, to make lump sum prepayments of employer contributions.

39 **SECTION 31b. (1) The School Districts Unfunded Liability Fund is established in the State**  
 40 **Treasury, separate and distinct from the General Fund. Interest earned by the School Dis-**  
 41 **tricts Unfunded Liability Fund shall be credited to the fund.**

42 (2) Moneys in the fund are continuously appropriated to the Public Employees Retirement  
 43 Board for the purpose of applying the moneys against the liabilities of participating public  
 44 employers, as defined in ORS 238.005, that are school districts.

45 **SECTION 32. Section 33 of this 2018 Act is added to and made a part of ORS chapter 317.**

1       **SECTION 33.** (1) A credit against the taxes otherwise due under ORS chapter 317 or 318  
2 shall be allowed to a taxpayer for Oregon tax attributable to income reported under section  
3 965 of the Internal Revenue Code as post-1986 deferred foreign income.

4       (2) The credit allowed under this section may not exceed the lesser of:

5       (a) The amount of Oregon tax attributable to income reported under section 965 of the  
6 Internal Revenue Code as post-1986 deferred foreign income for tax years beginning on or  
7 after January 1, 2017, and before January 1, 2018; or

8       (b) The total amount of tax, if any, attributable to the addition required under ORS  
9 317.716 and imposed for all tax years beginning on or after January 1, 2014, and before Jan-  
10 uary 1, 2017.

11       (3) The credit allowed under this section may not exceed the tax liability of the taxpayer  
12 for the tax year.

13       (4) Any tax credit otherwise allowable under this section that is not used by the taxpayer  
14 in a particular tax year may be carried forward and offset against the taxpayer's tax liability  
15 for the next succeeding tax year. Any credit remaining unused in the next succeeding tax  
16 year may be carried forward and used in the second succeeding tax year. Any credit re-  
17 maining unused in the second succeeding tax year may be carried forward and used in the  
18 third succeeding tax year. Any credit remaining unused in the third succeeding tax year may  
19 be carried forward and used in the fourth succeeding tax year. Any credit remaining unused  
20 in the fourth succeeding tax year may be carried forward and used in the fifth succeeding  
21 tax year, but may not be used in any tax year thereafter.

22       **SECTION 34.** Except as provided in section 33 (4) of this 2018 Act, section 33 of this 2018  
23 Act applies to tax years beginning on or after January 1, 2017, and before January 1, 2018.

24       **SECTION 35.** ORS 317.716 and 317.717 are repealed.

25       **SECTION 36.** The repeal of ORS 317.716 and 317.717 by section 35 of this 2018 Act applies  
26 to tax years beginning on or after January 1, 2017.

27       **SECTION 37.** On or before December 1, 2020, the Department of Revenue shall report in  
28 the manner required by ORS 192.245 to a committee of the Legislative Assembly related to  
29 revenue regarding the relative efficacy of the provisions of ORS 317.716, in comparison to the  
30 provisions of section 951A of the Internal Revenue Code, requiring shareholders of controlled  
31 foreign corporations to include global intangible low-taxed income in gross income.

32       **SECTION 38.** This 2018 Act takes effect on the 91st day after the date on which the 2018  
33 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
