SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows local government to disclose payment distribution amounts made pursuant to agreement to collect taxes imposed on sale of marijuana items. Enables person responsible for marijuana grow site, registry identification cardholder or designated primary caregiver to obtain immature marijuana plants from recreational marijuana producers. Exempts certain processing of marijuana for medical purposes from testing requirements. Clarifies information that application for marijuana grow site registration must include. Limits number of immature marijuana plants that are less than 24 inches in height allowed at marijuana grow sites to number established by Oregon Health Authority by rule. Exempts certain medical marijuana grow sites from tracking requirements. Changes reporting date for Oregon Cannabis Commission. Allows certain marijuana establishments to be located within 1,000 feet of school.

Requires industrial hemp item sold by marijuana retailer to carry label identifying whether product is derived from hemp or marijuana. Prohibits anyone other than marijuana retailer from selling marijuana item to consumer.

Establishes Illegal Marijuana Market Enforcement Grant Program to assist local governments with costs incurred by local law enforcement agencies in addressing unlawful marijuana cultivation or distribution operations. Sunsets program on January 2, 2024.

Takes effect on 91st day following adjournment sine die.

7 **MARIJUANA TAXATION**

8
9 **SECTION 1.** ORS 305.620 is amended to read:

10 305.620. (1)(a) Any state agency or department may enter into agreements with any political
11 subdivision of this state for the collection, enforcement, administration and distribution of local
12 taxes of the political subdivision imposed upon or measured by gross or net income, wages or net
13 earnings from self-employment, local general sales and use taxes, local transient lodging taxes or
14 taxes imposed under ORS 475B.491.

15 **(b) Notwithstanding ORS 314.835, a local government may disclose payment distribution**
16 **amounts made pursuant to an agreement under this subsection to collect taxes imposed**
17 **under ORS 475B.491.**

18 (2) The department or agency shall prescribe the rules by which the agreements entered into

1 under subsection (1) of this section are administered.

2 (3) The department or agency shall prescribe the rules by which the taxes described by sub-
3 section (1) of this section are administered, collected, enforced and distributed.

4 (4) A political subdivision may appear as an intervenor at any conference held by the Depart-
5 ment of Revenue or conference, hearing or proceeding held by another department or agency in
6 connection with a local tax administered by the department or agency. The political subdivision may
7 be represented by its own counsel. The department or agency shall adopt rules governing the pro-
8 cedures to be followed by the political subdivision in making an appearance.

9 (5) Costs incurred by the department or agency in the administration, enforcement, collection
10 and distribution of taxes under the agreements entered into under subsection (1) of this section shall
11 be first deducted from the taxes collected before distribution is made to the political subdivision
12 which is a party to the agreement.

13 (6) The Oregon Tax Court shall have exclusive jurisdiction to review determinations of the De-
14 partment of Revenue or orders of another department or agency relating to the collection, enforce-
15 ment, administration and distribution of local taxes under agreements entered into under subsection
16 (1) of this section.

17 (7) A proceeding for refund or to set aside additional taxes or taxes assessed when no return
18 was filed may be initiated before the state agency or department.

19 (8) An appeal from a determination or an order may be taken by the taxpayer or by the political
20 subdivision whose taxes are in issue, by filing a complaint with the clerk of the Oregon Tax Court
21 at its principal office in Salem, Oregon, within 60 days after the notice of the determination of the
22 Department of Revenue or the order of the department or agency is sent to the taxpayer or the
23 political subdivision. The filing of the complaint in the Oregon Tax Court shall constitute perfection
24 of the appeal. Service of the taxpayer's complaint shall be accomplished by the clerk of the tax
25 court by filing a copy of the complaint with the administrative head of the department or agency
26 and a copy with the political subdivision. Service of the political subdivision's complaint shall be
27 accomplished by the clerk of the tax court by filing a copy of the complaint with the administrative
28 head of the department or agency and mailing a copy of the complaint to the taxpayer. The com-
29 plaint of a taxpayer shall be entitled in the name of the person filing as plaintiff and the department
30 or agency as defendant. The complaint of a political subdivision shall be entitled in the name of the
31 political subdivision as plaintiff and the taxpayer and the department or agency as defendants. A
32 copy of the order of the department or agency shall be attached to the complaint. All procedures
33 shall be in accordance with ORS 305.405 to 305.494.

35 **MARIJUANA GROW SITES AND PLANTS**

36
37 **SECTION 2.** ORS 475B.136 is amended to read:

38 475B.136. (1) To produce marijuana for medical purposes, a marijuana producer that holds a li-
39 cense issued under ORS 475B.070 must register with the Oregon Liquor Control Commission under
40 this section.

41 (2) The commission shall register a marijuana producer for the purpose of producing marijuana
42 for medical purposes if the marijuana producer:

- 43 (a) Holds a license issued under ORS 475B.070;
- 44 (b) Meets any qualifications adopted by the commission by rule;
- 45 (c) Applies to the commission in a form and manner prescribed by the commission; and

1 (d) Pays any fee adopted by the commission by rule.

2 (3) Subject to subsection (4) of this section, a marijuana producer registered under this section
3 may produce marijuana plants on a medically designated grow canopy in addition to producing
4 marijuana plants on the grow canopy allowed under rules adopted under ORS 475B.085. The com-
5 mission shall specify the size of medically designated grow canopies by rule, provided that the size
6 of any medically designated grow canopy does not exceed 10 percent of the total size of both the
7 medically designated grow canopy and the grow canopy allowed under rules adopted under ORS
8 475B.085 at the time that the marijuana producer applies for registration under this section.

9 (4) A marijuana producer registered under this section must provide, for no consideration, at
10 least 75 percent of the annual yield of usable marijuana harvested from the marijuana producer's
11 medically designated grow canopy to registry identification cardholders and designated primary
12 caregivers.

13 (5) A marijuana producer registered under this section may not, during a single transaction,
14 provide a registry identification cardholder or the designated primary caregiver of a registry iden-
15 tification cardholder an amount of usable marijuana that exceeds the amount of usable marijuana
16 that a registry identification cardholder and a designated primary caregiver may jointly possess
17 under ORS 475B.834.

18 **(6) A marijuana producer registered under this section may provide immature marijuana**
19 **plants to a person responsible for a marijuana grow site registered under ORS 475B.810, a**
20 **registry identification cardholder or a designated primary caregiver of a registry identifica-**
21 **tion cardholder.**

22 [(6)(a)] (7)(a) The commission shall adopt rules necessary to administer this section.

23 (b) The rules must establish sanctions for failure to meet the requirements of this section or a
24 rule adopted under this section, including revocation of permission for the marijuana producer's
25 medically designated grow canopy.

26 (c) The rules must provide that any fee adopted by the commission under subsection (2)(d) of this
27 section be in an amount reasonably calculated to not exceed, together with other fees collected
28 under ORS 475B.010 to 475B.545, the cost of administering ORS 475B.010 to 475B.545.

29 **SECTION 3.** ORS 475B.139 is amended to read:

30 475B.139. (1) To process marijuana for medical purposes, a marijuana processor that holds a li-
31 cense issued under ORS 475B.090 must register with the Oregon Liquor Control Commission under
32 this section.

33 (2) The commission shall register a marijuana processor for the purpose of processing marijuana
34 for medical purposes if the marijuana processor:

- 35 (a) Holds a license issued under ORS 475B.090;
- 36 (b) Meets any qualifications adopted by the commission by rule;
- 37 (c) Applies to the commission in a form and manner prescribed by the commission; and
- 38 (d) Pays any fee adopted by the commission by rule.

39 (3) A marijuana processor registered under this section may:

40 (a) Process marijuana and usable marijuana into medical grade cannabinoid products,
41 cannabinoid concentrates and cannabinoid extracts; and

42 (b) Notwithstanding ORS 475B.206, receive marijuana and usable marijuana from, and for a fee
43 process that marijuana and usable marijuana into cannabinoid products, cannabinoid concentrates
44 and cannabinoid extracts for, a registry identification cardholder or the designated primary
45 caregiver of a registry identification cardholder, provided that the cannabinoid products,

1 cannabinoid concentrates and cannabinoid extracts meet the requirements of ORS 475B.550 to
2 475B.590 and **the concentration standards adopted under ORS 475B.625.**

3 (4)(a) The commission shall adopt rules necessary to administer this section.

8 475B.630. (1) ORS 475B.600 to 475B.655 do not apply to:

9 [(1)] (a) A person responsible for a marijuana grow site under ORS 475B.810 if the person is
10 transferring usable marijuana or an immature marijuana plant, as defined in ORS 475B.015, to:

11 [(a)] (A) A person who holds a registry identification card under ORS 475B.797 and who desig-
12 nated the person responsible for the marijuana grow site to grow marijuana for the person who
13 holds a registry identification card; or

14 [(b)] (B) A person who has been designated as the primary caregiver under ORS 475B.804 of a
15 person who holds a registry identification card under ORS 475B.797, and who designated the person
16 responsible for the marijuana grow site to grow marijuana for the person who holds a registry
17 identification card; or

18 [(2)] (b) A person who has been designated as the primary caregiver under ORS 475B.804 of a
19 person who holds a registry identification card under ORS 475B.797 if the person is transferring a

32 grow site; or]

33 [(c) *The exact location of the marijuana grow site using one or more of the following:]* **if a**
34 **marijuana grow site has a physical United States Postal Service address, an application filed**
35 **for a marijuana grow site registration card under ORS 475B.810 must include the physical**
36 **address. If the grow site does not have a physical United States Postal Service address, the**
37 **application must include:**

38 (a) **An assessor's map number with a map showing the exact location of the grow site;**

39 (b) **The name of the city or, if outside of a city, the name of the county in which the grow**
40 **site is located;**

41 (c) **The zip code for the location; and**

42 (d) **One or more of the following for the location:**

43 (A) Longitude and latitude coordinates;

44 (B) Township coordinates; *[or]*

11 *produced at the address.*]; **and****

15 475B.810 is located in an area other than an area described in subsection (3) of this section:

23 (b) Subject to subsections (5) and (6) of this section, if each person responsible for a marijuana
24 grow site located at the address first registered with the authority under ORS 475B.810 before
25 January 1, 2015[:],

26 [(A)] no more than the **following amounts of marijuana plants may be produced at the ad-
27 dress:**

28 **(A) The amount of mature marijuana plants located at that address on December 31, 2014, in
29 excess of 48 mature marijuana plants, not to exceed 96 mature marijuana plants[, *may be produced*
30 *at the address; and*];**

31 **(B) [*No more than*] 192 immature marijuana plants that are 24 inches or more in height [*may be*
32 *produced at the address.*]; **and****

33 **(C) The amount, established by the authority by rule, of immature marijuana plants that
34 are less than 24 inches in height.**

35 [(5) *If the authority suspends or revokes the registration of a person responsible for a marijuana
36 grow site that is located at an address described in subsection (3)(b) or (4)(b) of this section.*]

37 [(a) *No more than 12 mature marijuana plants and no more than 24 immature marijuana plants
38 that are 24 inches or more in height may be subsequently produced at any address described in sub-
39 section (3) of this section at which the person responsible for that marijuana grow site produces
40 marijuana.*]

41 [(b) *No more than 48 mature marijuana plants and no more than 96 immature marijuana plants
42 that are 24 or more inches in height may be subsequently produced at any address described in Sub-
43 section (4) of this section at which the person responsible for that marijuana grow site produces
44 marijuana.*]

45 **(5)(a) If the authority suspends or revokes the registration of a person responsible for a**

1 marijuana grow site that is located at an address described in subsection (3)(b) of this sec-
2 tion, no more than the following amounts of marijuana plants may subsequently be produced
3 at any address described in subsection (3) of this section at which the person responsible for
4 the marijuana grow site produces marijuana:

5 (A) 12 mature marijuana plants;

6 (B) 24 immature marijuana plants that are 24 inches or more in height; and

7 (C) The amount, established by the authority by rule, of immature marijuana plants that
8 are less than 24 inches in height.

9 (b) If the authority suspends or revokes the registration of a person responsible for a
10 marijuana grow site that is located at an address described in subsection (4)(b) of this sec-
11 tion, no more than the following amounts of marijuana plants may subsequently be produced
12 at any address described in subsection (4) of this section at which the person responsible for
13 the marijuana grow site produces marijuana:

14 (A) 48 mature marijuana plants;

15 (B) 96 immature marijuana plants that are 24 inches or more in height; and

16 (C) The amount, established by the authority by rule, of immature marijuana plants that
17 are less than 24 inches in height.

18 (6) If a registry identification cardholder who designated a person to produce marijuana for the
19 registry identification cardholder pursuant to ORS 475B.810 terminates the designation, the person
20 responsible for the marijuana grow site whose designation has been terminated may not be desig-
21 nated to produce marijuana by another registry identification cardholder, except that the person
22 may be designated by another registry identification cardholder if no more than 48 mature
23 marijuana plants and no more than 96 immature marijuana plants that are 24 or more inches in
24 height are produced at the address for the marijuana grow site at which the person produces
25 marijuana.

26 (7) Subject to the limits described in subsections (2) to (6) of this section, if multiple persons
27 responsible for a marijuana grow site under ORS 475B.810 are located at the same address, the
28 persons designated to produce marijuana by registry identification cardholders who are located at
29 that address may collectively produce marijuana plants for any number of registry identification
30 cardholders who designate the persons to produce marijuana.

31 (8) If a law enforcement officer determines that there is a number of marijuana plants at an
32 address in excess of the quantities specified in this section, or that an address is being used to
33 produce a number of marijuana plants in excess of the quantities specified in subsection (1)(b) of this
34 section, the law enforcement officer may confiscate only the excess number of marijuana plants.

35 **SECTION 7.** ORS 475B.895 is amended to read:

36 475B.895. (1) The Oregon Health Authority shall enter into an agreement with the Oregon Li-
37 quor Control Commission under which the commission shall use the system developed and main-
38 tained under ORS 475B.177 to track:

39 (a) The propagation of immature marijuana plants and the production of marijuana by marijuana
40 grow sites;

41 (b) The processing of marijuana into medical cannabinoid products, cannabinoid concentrates
42 and cannabinoid extracts that are transferred to a medical marijuana dispensary;

43 (c) The transfer of usable marijuana, immature marijuana plants, medical cannabinoid products,
44 cannabinoid concentrates and cannabinoid extracts by a marijuana grow site or a medical marijuana
45 dispensary to a registry identification cardholder or the designated primary caregiver of a registry

1 identification cardholder; and

2 (d) The transfer of usable marijuana, immature marijuana plants, medical cannabinoid products,
3 cannabinoid concentrates and cannabinoid extracts between marijuana grow sites, marijuana pro-
4 cessing sites and medical marijuana dispensaries.

5 (2) Marijuana grow sites, marijuana processing sites, medical marijuana dispensaries and any
6 other person that processes marijuana into medical cannabinoid products and cannabinoid concen-
7 trates for the purpose of transferring the medical cannabinoid products and cannabinoid concen-
8 trates to a medical marijuana dispensary are subject to tracking under this section.

9 (3) On and after the date on which a marijuana grow site becomes subject to tracking under this
10 section, the person is exempt from the requirements of ORS 475B.816 and the provisions of ORS
11 475B.810 that relate to ORS 475B.816.

12 (4) On and after the date on which a marijuana processing site becomes subject to tracking
13 under this section, the marijuana processing site is exempt from the requirements of ORS 475B.846
14 and the provisions of ORS 475B.840 that relate to ORS 475B.846.

15 (5) On and after the date on which a medical marijuana dispensary becomes subject to tracking
16 under this section, the medical marijuana dispensary is exempt from the requirements of ORS
17 475B.867 and the provisions of ORS 475B.858 that relate to ORS 475B.867.

18 (6) The commission may conduct inspections and investigations of alleged violations of ORS
19 475B.785 to 475B.949 about which the commission obtains knowledge as a result of performing the
20 commission's duties under this section. Notwithstanding ORS 475B.299, the commission may use
21 regulatory specialists, as defined in ORS 471.001, to conduct the inspections and investigations, in-
22 cluding inspections and investigations of marijuana grow sites located at a primary residence.

23 *[(7) Notwithstanding ORS 475B.759, before making any other distribution from the Oregon*
24 *Marijuana Account established under ORS 475B.759, the Department of Revenue shall first distribute*
25 *moneys quarterly from the account to the commission for deposit in the Marijuana Control and Regu-*
26 *lation Fund established under ORS 475B.296 for purposes of paying administrative, inspection and*
27 *investigatory costs incurred by the commission under this section, provided that the amount of distrib-*
28 *uted moneys does not exceed \$1.25 million per quarter. For purposes of estimating the amount of*
29 *moneys necessary to pay costs incurred under this section, the commission shall establish a formulary*
30 *based on expected costs for each marijuana grow site, marijuana processing site or medical marijuana*

32 *venue and the Legislative Fiscal Officer before each quarter the estimated amount of moneys necessary*
33 *to pay costs expected to be incurred under this section and the formulary.]*

34 *[(8)]* (7) When imposing a fee on a person responsible for a marijuana grow site, marijuana
35 processing site or medical marijuana dispensary under ORS 475B.810, 475B.840 or 475B.858, the au-
36 thority shall impose *[an additional]* a fee that is reasonably calculated to pay costs incurred under
37 this section *[other than costs paid pursuant to subsection (7) of this section]*. As part of the agreement
38 entered into under subsection (1) of this section, the authority shall transfer fee moneys collected
39 pursuant to this subsection to the commission for deposit in the Marijuana Control and Regulation
40 Fund established under ORS 475B.296. Moneys collected pursuant to this subsection and deposited
41 in the Marijuana Control and Regulation Fund are continuously appropriated to the commission for
42 purposes of this section.

43 *[(9)]* (8) The authority and the commission may adopt rules as necessary to administer this sec-
44 tion.

45 *[(10)]* (9) This section does not apply to a marijuana grow site located at an address where:

1 (a) A registry identification cardholder produces marijuana and no more than 12 mature
2 marijuana plants and 24 immature marijuana plants are produced *[at the address]*; or

3 (b)(A) **No more than two persons are registered under ORS 475B.810 to produce**
4 **marijuana; and**

5 (B) **The address is used to produce marijuana for no more than two registry identification**
6 **cardholders.**

7 **SECTION 7a.** ORS 475B.895, as amended by section 7 of this 2018 Act, is amended to read:

8 475B.895. (1) The Oregon Health Authority shall enter into an agreement with the Oregon Li-
9 quor Control Commission under which the commission shall use the system developed and main-
10 tained under ORS 475B.177 to track:

11 (a) The propagation of immature marijuana plants and the production of marijuana by marijuana
12 grow sites;

13 (b) The processing of marijuana into medical cannabinoid products, cannabinoid concentrates
14 and cannabinoid extracts that are transferred to a medical marijuana dispensary;

15 (c) The transfer of usable marijuana, immature marijuana plants, medical cannabinoid products,
16 cannabinoid concentrates and cannabinoid extracts by a marijuana grow site or a medical marijuana
17 dispensary to a registry identification cardholder or the designated primary caregiver of a registry
18 identification cardholder; and

19 (d) The transfer of usable marijuana, immature marijuana plants, medical cannabinoid products,
20 cannabinoid concentrates and cannabinoid extracts between marijuana grow sites, marijuana pro-
21 cessing sites and medical marijuana dispensaries.

22 (2) Marijuana grow sites, marijuana processing sites, medical marijuana dispensaries and any
23 other person that processes marijuana into medical cannabinoid products and cannabinoid concen-
24 trates for the purpose of transferring the medical cannabinoid products and cannabinoid concen-
25 trates to a medical marijuana dispensary are subject to tracking under this section.

26 (3) On and after the date on which a marijuana grow site becomes subject to tracking under this
27 section, the person is exempt from the requirements of ORS 475B.816 and the provisions of ORS
28 475B.810 that relate to ORS 475B.816.

29 (4) On and after the date on which a marijuana processing site becomes subject to tracking
30 under this section, the marijuana processing site is exempt from the requirements of ORS 475B.846
31 and the provisions of ORS 475B.840 that relate to ORS 475B.846.

32 (5) On and after the date on which a medical marijuana dispensary becomes subject to tracking
33 under this section, the medical marijuana dispensary is exempt from the requirements of ORS
34 475B.867 and the provisions of ORS 475B.858 that relate to ORS 475B.867.

35 (6) The commission may conduct inspections and investigations of alleged violations of ORS
36 475B.785 to 475B.949 about which the commission obtains knowledge as a result of performing the
37 commission's duties under this section. Notwithstanding ORS 475B.299, the commission may use
38 regulatory specialists, as defined in ORS 471.001, to conduct the inspections and investigations, in-
39 cluding inspections and investigations of marijuana grow sites located at a primary residence.

40 (7) **Notwithstanding ORS 475B.759, before making any other distribution from the Oregon**
41 **Marijuana Account established under ORS 475B.759, the Department of Revenue shall first**
42 **distribute moneys quarterly from the account to the commission for deposit in the Marijuana**
43 **Control and Regulation Fund established under ORS 475B.296 for purposes of paying admin-**
44 **istrative, inspection and investigatory costs incurred by the commission under this section,**
45 **provided that the amount of distributed moneys does not exceed \$1.25 million per quarter.**

1 **For purposes of estimating the amount of moneys necessary to pay costs incurred under this**
2 **section, the commission shall establish a formulary based on expected costs for each**
3 **marijuana grow site, marijuana processing site or medical marijuana dispensary that is**
4 **tracked under this section. The commission shall provide to the Department of Revenue and**
5 **the Legislative Fiscal Officer before each quarter the estimated amount of moneys necessary**
6 **to pay costs expected to be incurred under this section and the formulary.**

7 [(7)] (8) When imposing a fee on a person responsible for a marijuana grow site, marijuana
8 processing site or medical marijuana dispensary under ORS 475B.810, 475B.840 or 475B.858, the au-
9 thority shall impose [a] **an additional** fee that is reasonably calculated to pay costs incurred under
10 this section **other than costs paid pursuant to subsection (7) of this section.** As part of the
11 agreement entered into under subsection (1) of this section, the authority shall transfer fee moneys
12 collected pursuant to this subsection to the commission for deposit in the Marijuana Control and
13 Regulation Fund established under ORS 475B.296. Moneys collected pursuant to this subsection and
14 deposited in the Marijuana Control and Regulation Fund are continuously appropriated to the com-
15 mission for purposes of this section.

16 [(8)] (9) The authority and the commission may adopt rules as necessary to administer this sec-
17 tion.

18 [(9)] (10) This section does not apply to a marijuana grow site located at an address where:

19 (a) A registry identification cardholder produces marijuana and no more than 12 mature
20 marijuana plants and 24 immature marijuana plants are produced; or

21 (b)(A) No more than two persons are registered under ORS 475B.810 to produce marijuana; and

22 (B) The address is used to produce marijuana for no more than two registry identification
23 cardholders.

24 **SECTION 8. The fact that a marijuana grow site registered under ORS 475B.810 is subject**
25 **to the provisions of ORS 475B.895 does not, by itself, mean that the marijuana grow site is**
26 **a commercial operation for purposes of state law.**

40 (iv) Marijuana processing sites, as defined in ORS 475B.410; and

42 (B) Necessary amendments to the laws of the state pertaining to cannabis, including any nec-
43 essary amendments to ORS 475B.010 to 475B.395 and 475B.400 to 475B.525; and

44 (C) The future role of the commission with respect to the possible framework.

45 (b) Steps that the state must take, whether administrative or legislative in nature, to ensure that

1 research on cannabis and cannabis-derived products is being conducted for public purposes, includ-
2 ing the advancement of:

- 3 (A) Public health policy and public safety policy;
- 4 (B) Agronomic and horticultural best practices; and
- 5 (C) Medical and pharmacopoeia best practices.

6 (2) In determining the possible framework for the future governance of the Oregon Medical
7 Marijuana Program under subsection (1)(a) of this section, the commission shall consider:

- 8 (a) Potential factors that could prevent access to cannabis for medical use;
- 9 (b) Potential laws and rules that will facilitate access to cannabis for medical use; and
- 10 (c) The impact of federal laws, regulations and policies on the possible framework.

11 (3) On or before [December 15, 2017] **February 1, 2019**, the commission shall submit a report in
12 the manner prescribed by ORS 192.245 to the interim committees of the Legislative Assembly related
13 to health and judiciary on the findings and determinations made by the commission under subsection
14 (1) of this section. As part of the report, the commission may make recommendations for legislation.

26 475B.109. Notwithstanding ORS 475B.105 (2)(d), a marijuana retailer may be located within 1,000
27 feet of a school if:

28 (1)(a) The marijuana retailer is not located within 500 feet of:

29 [(a)] (A) A public elementary or secondary school for which attendance is compulsory under
30 ORS 339.020; or

31 [(b)] (B) A private or parochial elementary or secondary school, teaching children as described
32 in ORS 339.030 (1)(a); and

33 [(2)] (b) The Oregon Liquor Control Commission determines that there is a physical or ge-
34 ographic barrier capable of preventing children from traversing to the premises of the marijuana
35 retailer[.]; or

36 (2) **The marijuana retailer was established before August 1, 2017, in accordance with a**
37 **city or county ordinance adopted under section 29b, chapter 83, Oregon Laws 2016.**

38 **SECTION 12.** ORS 475B.864 is amended to read:

39 475B.864. Notwithstanding ORS 475B.858 (3)(d), a medical marijuana dispensary may be located
40 within 1,000 feet of a school if:

41 (1)(a) The medical marijuana dispensary is not located within 500 feet of:

42 [(a)] (A) A public elementary or secondary school for which attendance is compulsory under
43 ORS 339.020; or

44 [(b)] (B) A private or parochial elementary or secondary school, teaching children as described
45

1 in ORS 339.030 (1)(a); and

2 [(2)] (b) The Oregon [*Liquor Control Commission*] **Health Authority** determines that there is a
3 physical or geographic barrier capable of preventing children from traversing to the premises of the
4 medical marijuana dispensary[.]; **or**

5 (2) **The medical marijuana dispensary was established before August 1, 2017, in accord-**
6 **ance with a city or county ordinance adopted under section 29, chapter 83, Oregon Laws 2016.**

8 **ILLEGAL MARIJUANA MARKET ENFORCEMENT**
9 **GRANT PROGRAM**

10
11 **SECTION 13. (1) The Illegal Marijuana Market Enforcement Grant Program is estab-**
12 **lished to assist cities and counties with the costs incurred by local law enforcement agencies**
13 **in addressing unlawful marijuana cultivation or distribution operations.**

14 (2) **The Oregon Criminal Justice Commission shall administer the grant program de-**
15 **scribed in subsection (1) of this section and shall award the grants described in this section.**

16 (3) **The commission shall adopt rules to administer the grant program. Rules adopted**
17 **under this section must include:**

18 (a) **A methodology for reviewing and approving grant applications and awarding grants;**
19 **and**

20 (b) **A process for evaluating the efficacy of local law enforcement programs and services**
21 **funded by the grant program.**

22 (4) **Moneys distributed to grant recipients under this section must be spent on costs as-**
23 **sociated with addressing and prosecuting unlawful marijuana cultivation or distribution op-**
24 **erations.**

25 (5) **The commission shall prioritize the following when awarding grants under this sec-**
26 **tion:**

27 (a) **Providing financial assistance to local law enforcement agencies and district attor-**
28 **neys in rural areas of this state to address unlawful marijuana cultivation or distribution**
29 **operations;**

30 (b) **Supporting local law enforcement agencies and district attorneys in investigating and**
31 **prosecuting large-scale unlawful marijuana cultivation or distribution operations;**

32 (c) **Providing financial assistance to local law enforcement agencies and district attorneys**
33 **in the investigation and prosecution of organized crime involved in unlawful marijuana cul-**
34 **tivation or distribution operations; and**

35 (d) **Providing financial assistance to local law enforcement agencies and district attor-**
36 **neys in the investigation and prosecution of unlawful marijuana cultivation or distribution**
37 **operations that divert marijuana outside of this state.**

38 **SECTION 14. Not later than January 1, 2020, and not later than January 1 each year**
39 **thereafter, the Oregon Criminal Justice Commission shall submit a report in the manner**
40 **provided in ORS 192.245 on the status and effectiveness of the Illegal Marijuana Market**
41 **Enforcement Grant Program established under section 13 of this 2018 Act to the interim**
42 **committees of the Legislative Assembly related to the judiciary.**

43 **SECTION 15. The Illegal Marijuana Market Enforcement Grant Program Fund is estab-**
44 **lished in the State Treasury separate and distinct from the General Fund. Moneys in the Il-**
45 **legal Marijuana Market Enforcement Grant Program Fund are continuously appropriated to**

1 the Oregon Criminal Justice Commission for the purposes of carrying out the provisions of
2 section 13 of this 2018 Act. Interest earned by the fund shall be credited to the fund.

3 **SECTION 16.** (1) Notwithstanding ORS 475B.759, before making any other distribution
4 from the Oregon Marijuana Account established under ORS 475B.759, the Department of
5 Revenue shall first distribute quarterly from the account the following:

6 (a) \$875,000 to the Oregon Liquor Control Commission for deposit in the Marijuana Con-
7 trol and Regulation Fund established under ORS 475B.296; and

8 (b) \$375,000 to the Oregon Criminal Justice Commission for deposit into the Illegal
9 Marijuana Market Enforcement Grant Program Fund established under section 15 of this
10 2018 Act for the purposes of paying the costs incurred by the commission in carrying out the
11 provisions of section 13 of this 2018 Act.

12 (2) The final distribution made under subsection (1) of this section shall be made in the
13 fiscal quarter beginning on October 1, 2023.

17 Grant Program Fund had section 15 of this 2018 Act remained in effect, shall be transferred
18 to and deposited in the Marijuana Control and Regulation Fund, and are appropriated for
19 expenditure as in the case of other moneys in the Marijuana Control and Regulation Fund.

21 **INDUSTRIAL HEMP PRODUCTS AND COMMODITIES**

22
23 **SECTION 18.** Sections 19 and 20 of this 2018 Act are added to and made a part of ORS
24 475B.010 to 475B.545.

25 **SECTION 19.** (1) As used in this section, “industrial hemp” has the meaning given that
26 term in ORS 571.300.

27 (2) An industrial hemp product or commodity offered for sale by a marijuana retailer that
28 holds a license issued under ORS 475B.105 must carry a label that clearly identifies whether
29 the product or commodity is derived from hemp or marijuana.

30 (3) The Oregon Liquor Control Commission may inspect the premises of a marijuana
31 retailer that holds a license issued under ORS 475B.105 to ensure compliance with this sec-
32 tion.

33 **SECTION 20.** (1) As used in this section:

34 (a) “Consumer” means a person who purchases, acquires, owns, holds or uses marijuana
35 items other than for the purpose of resale.

36 (b) “Marijuana item” includes industrial hemp products and commodities that contain
37 more than 0.3 percent tetrahydrocannabinol.

38 (2) A person other than a marijuana retailer that holds a license issued under ORS
39 475B.105 may not sell marijuana items to a consumer.

40 **SECTION 21.** ORS 475B.227 is amended to read:

41 475B.227. (1) For purposes of this section[,]:

42 (a) “Export” includes placing a marijuana item in any mode of transportation for hire, such as
43 luggage, mail or parcel delivery, even if the transportation of the marijuana item is intercepted prior
44 to the marijuana item leaving this state.

45 (b) “Marijuana item” includes industrial hemp products and commodities that contain

1 **more than 0.3 percent tetrahydrocannabinol.**

2 (2) A person may not import marijuana items into this state or export marijuana items from this
3 state.

4 (3) Except as provided in subsection (4) of this section, a violation of this section is a Class B
5 violation.

6 (4) A violation of this section is a:

7 (a) Class A misdemeanor, if the importation or exportation:

8 (A) Is not for consideration and the person holds a license issued under ORS 475B.070, 475B.090,
9 475B.100 or 475B.105; or

10 (B) Concerns an amount of marijuana items that exceeds the applicable maximum amount spec-
11 ified in ORS 475B.337 (1)(a) to (f).

12 (b) Class C felony, if the importation or exportation:

13 (A) Is for consideration and the person holds a license issued under ORS 475B.070, 475B.090,
14 475B.100 or 475B.105;

15 (B) Concerns an amount of marijuana items that exceeds 16 times the applicable maximum
16 amount specified in ORS 475B.337 (1)(a) to (f); or

17 (C) Concerns a cannabinoid extract that was not purchased from a marijuana retailer that holds
18 a license issued under ORS 475B.105.

19
20 **UNIT CAPTIONS**

21
22 **SECTION 22. The unit captions used in this 2018 Act are provided only for the conven-**
23 **ience of the reader and do not become part of the statutory law of this state or express any**
24 **legislative intent in the enactment of this 2018 Act.**

26 **EXPENDITURE LIMITATIONS**

27
28 **SECTION 23. Notwithstanding any other law limiting expenditures, the limitation on**
29 **expenditures established by section 2, chapter 505, Oregon Laws 2017, for the biennium end-**
30 **ing June 30, 2019, as the maximum limit for payment of expenses from fees, moneys or other**
31 **revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds,**
32 **collected or received by the Oregon Criminal Justice Commission, is increased by \$1,500,000**
33 **to administer the Illegal Marijuana Market Enforcement Grant Program established in sec-**
34 **tion 13 of this 2018 Act.**

35 **SECTION 24. Notwithstanding any other law limiting expenditures, the limitation on**
36 **expenditures established by section 1 (2), chapter 578, Oregon Laws 2017, for the biennium**
37 **ending June 30, 2019, as the maximum limit for payment of expenses from fees, moneys or**
38 **other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal**
39 **funds, collected or received by the Oregon Liquor Control Commission for marijuana regu-**
40 **lation, is increased by \$600,693 for regulatory and tracking expenses related to medical**
41 **marijuana.**

5 **SECTION 26.** Sections 13 to 16 of this 2018 Act are repealed on January 2, 2024.

9 **SECTION 27.** (1) Sections 8, 13 to 17, 19 and 20 of this 2018 Act and the amendments to
10 ORS 305.260, 475B.109, 475B.136, 475B.139, 475B.227, 475B.630, 475B.813, 475B.831, 475B.864 and
11 475B.895 and sections 4 and 5, chapter 613, Oregon Laws 2017, by sections 1 to 7, 9 to 12 and
12 21 of this 2018 Act become operative on July 1, 2018.

13 (2) The amendments to ORS 475B.895 by section 7a of this 2018 Act become operative on
14 January 2, 2024.
