SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires community colleges, public universities and Oregon Health and Science University to provide certain rights to students ordered to federal or state active duty for 30 or fewer consecutive days.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to students ordered to active duty; creating new provisions; amending ORS 341.499, 352.293

3 and 353.200; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 341.499 is amended to read:

6 341.499. (1) A student at a community college who is a member of the military, a member of the 7 commissioned corps of the National Oceanic and Atmospheric Administration or a member of the 8 Public Health Service of the United States Department of Health and Human Services detailed by 9 proper authority for duty with the Army or Navy of the United States and who is ordered to federal 10 or state active duty for more than 30 consecutive days has the following rights:

(a) With regard to a course in which the student is enrolled and for which the student has paidtuition and fees, the right to:

13 (A) Withdraw from the course, subject to the provisions of subsection (2) of this section;

(B) Receive a grade of incomplete and, upon release from active duty, complete the course in
 accordance with the community college's practice for completion of incomplete courses; or

16 (C) Continue and complete the course for full credit, subject to the provisions of subsection (3) 17 of this section;

(b) The right to a credit described in ORS 341.502 for all amounts paid for room, board, tuitionand fees;

(c) If the student elects to withdraw from the community college, the right to be readmitted and
 reenrolled at the community college within one year after release from active duty without a re quirement of redetermination of admission eligibility; and

(d) The right to continuation of scholarships and grants awarded to the student that were funded
by the community college or the Office of Student Access and Completion before the student was
ordered to active duty. The Higher Education Coordinating Commission may adopt rules for

1 the administration of scholarships and grants described in this paragraph that are funded 2 by the Office of Student Access and Completion.

3 (2) If the student elects to withdraw from a course under subsection (1)(a)(A) of this section, the
