

## SENATE AMENDMENTS TO A-ENGROSSED SENATE BILL 1565

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed A-engrossed bill, delete lines 5 through 14.

2 On page 2, delete lines 1 through 4.

3 In line 5, delete “3” and insert “1” and delete “4” and insert “2”.

4 In line 6, delete “4” and insert “2”.

5 In line 37, delete “5” and insert “3”.

6 On page 6, line 24, delete “6” and insert “4” and delete “5” and insert “3”.

7 On page 10, line 8, delete “7” and insert “5”.

8 In line 13, delete “8” and insert “6” and delete “7” and insert “5”.

9 Delete lines 17 through 44 and insert:

10 **“SECTION 7. Section 2 of this 2018 Act and the amendments to ORS 279B.060 and**  
11 **279B.145 by sections 3 and 5 of this 2018 Act apply to public contracts that a contracting**  
12 **agency has advertised or otherwise solicited, or if the contracting agency has not advertised**  
13 **or solicited the public contract, to public contracts into which the contracting agency enters**  
14 **on or after the operative date specified in section 8 (1) of this 2018 Act and before the oper-**  
15 **ative date specified in section 8 (2) of this 2018 Act.**

16 **“SECTION 8. (1) Section 2 of this 2018 Act and the amendments to ORS 279B.060 and**  
17 **279B.145 by sections 3 and 5 of this 2018 Act become operative on January 1, 2019.**

18 **“(2) The amendments to ORS 279B.060 and 279B.145 by sections 4 and 6 of this 2018 Act**  
19 **become operative on January 2, 2020.**

20 **“(3) The Attorney General, the Director of the Oregon Department of Administrative**  
21 **Services, the Director of Transportation and a contracting agency that adopts rules under**  
22 **ORS 279A.065 or 279A.070 may adopt rules and take any other action before the operative**  
23 **date specified in subsection (1) of this section that is necessary to enable the Attorney**  
24 **General, the director or the contracting agency, on and after the operative date specified in**  
25 **subsection (1) of this section, to undertake or exercise all of the duties, functions and powers**  
26 **conferred on the Attorney General, the director or the contracting agency under section 2**  
27 **of this 2018 Act and the amendments to ORS 279B.060 and 279B.145 by sections 3 and 5 of this**  
28 **2018 Act.**

29 **“SECTION 9. Section 2 of this 2018 Act is repealed on January 2, 2020.**

30 **“SECTION 10. This 2018 Act takes effect on the 91st day after the date on which the 2018**  
31 **regular session of the Seventy-ninth Legislative Assembly adjourns sine die.”.**
