**PROPOSED AMENDMENTS TO
HOUSE BILL 4144**

1 On page 3 of the printed bill, line 24, after “support” delete the rest of
2 the line and line 25 and insert “for worker recruitment, training or retention;
3 and”.

4 In line 26, delete the first “the” and insert “worker” and delete “of the”.

5 In line 27, delete “apprentices or former apprentices”.

6 After line 28, insert:

7 **“SECTION 6. The Construction Contractors Board shall report to**
8 **an interim committee of the Eightieth Legislative Assembly related**
9 **to business regarding licensing under section 2 of this 2018 Act. The**
10 **report shall include, but need not be limited to, the number of licenses**
11 **issued under section 2 of this 2018 Act and the number and types, if**
12 **any, of complaints received by the board regarding licensees under**
13 **section 2 of this 2018 Act. The board shall make the report to the in-**
14 **terim committee in the manner provided by ORS 192.245 no later than**
15 **October 1, 2020.**

16 **“SECTION 7. The Department of Consumer and Business Services**
17 **shall report to an interim committee of the Eightieth Legislative As-**
18 **sembly related to business regarding licensing under sections 3 and 4**
19 **of this 2018 Act. The report shall include, but need not be limited to,**
20 **the number of licenses issued under sections 3 and 4 of this 2018 Act**
21 **and the number and types, if any, of complaints received by the de-**

1 department regarding licensees under sections 3 and 4 of this 2018 Act.
2 The department shall make the report to the interim committee in the
3 manner provided by ORS 192.245 no later than October 1, 2020.

4 **“SECTION 8. The Oregon Business Development Department shall**
5 **report to an interim committee of the Eightieth Legislative Assembly**
6 **related to business regarding loans for capital investment purposes**
7 **issued under section 5 (2) of this 2018 Act. The report shall include,**
8 **but need not be limited to, the number of loans approved under section**
9 **5 (2) of this 2018 Act. The department shall make the report to the**
10 **interim committee in the manner provided by ORS 192.245 no later**
11 **than October 1, 2020.**

12 **“SECTION 9. The Higher Education Coordinating Commission shall**
13 **report to an interim committee of the Eightieth Legislative Assembly**
14 **related to business regarding the provision of financial support for**
15 **workforce investment under section 5 (3) of this 2018 Act. The report**
16 **shall include, but need not be limited to, the number of grants ap-**
17 **proved for financial support under section 5 (3) of this 2018 Act. The**
18 **commission shall make the report to the interim committee in the**
19 **manner provided by ORS 192.245 no later than October 1, 2020.”.**

20 In line 29, delete “6” and insert “10”.

21
