**PROPOSED AMENDMENTS TO
HOUSE BILL 4013**

1 On page 1 of the printed bill, delete lines 5 through 30 and delete page
2 2 and insert:

3 **“SECTION 1.** ORS 326.021 is amended to read:

4 “326.021. (1) The State Board of Education shall consist of:

5 “(a) The State Treasurer, or [*the designee*] **a person employed on a**
6 **full-time basis in the office** of the State Treasurer;

7 “(b) The Secretary of State, or [*the designee*] **a person employed on a**
8 **full-time basis in the office** of the Secretary of State; and

9 “(c) Seven members, appointed by the Governor for a term of four years
10 beginning July 1 of the year of appointment, subject to confirmation by the
11 Senate in the manner provided in ORS 171.562 and 171.565. A person ap-
12 pointed under this paragraph may not be appointed to serve consecutively
13 more than two full terms as a board member.

14 “(2) In making appointments under subsection (1)(c) of this section, the
15 Governor shall select from residents of Oregon one member from each con-
16 gressional district and two members from the state at large. An appointed
17 member may not be engaged in teaching or participate in the administration
18 or operation of any school.

19 “(3) The Governor may remove appointed members of the State Board of
20 Education for cause at any time after notice and public hearing.

21 “(4) The State Treasurer and the Secretary of State, or the [*designee of*

1 *the State Treasurer or Secretary of State*] **employee in the office of the**
2 **State Treasurer or Secretary of State**, are nonvoting, ex officio members
3 of the board.

4 “(5) The board shall coordinate and collaborate with the Chief Education
5 Office as provided by section 1, chapter 519, Oregon Laws 2011.

6 **“SECTION 2.** ORS 326.021, as amended by section 42, chapter 774, Oregon
7 Laws 2015, is amended to read:

8 “326.021. (1) The State Board of Education shall consist of:

9 “(a) The State Treasurer, or [*the designee*] **a person employed on a**
10 **full-time basis in the office** of the State Treasurer;

11 “(b) The Secretary of State, or [*the designee*] **a person employed on a**
12 **full-time basis in the office** of the Secretary of State; and

13 “(c) Seven members, appointed by the Governor for a term of four years
14 beginning July 1 of the year of appointment, subject to confirmation by the
15 Senate in the manner provided in ORS 171.562 and 171.565. A person ap-
16 pointed under this paragraph may not be appointed to serve consecutively
17 more than two full terms as a board member.

18 “(2) In making appointments under subsection (1)(c) of this section, the
19 Governor shall select from residents of Oregon one member from each con-
20 gressional district and two members from the state at large. An appointed

29 **“SECTION 3. This 2018 Act being necessary for the immediate**
30 **preservation of the public peace, health and safety, an emergency is**

1 **declared to exist, and this 2018 Act takes effect on its passage.”.**
