**PROPOSED AMENDMENTS TO  
SENATE BILL 1514**

1 On page 1 of the printed bill, line 11, after the period delete the rest of  
2 the line and delete lines 12 through 22 and insert:

3 “(1)(a) Each board, commission, committee, task force or other entity that  
4 meets the following criteria is subject to periodic sunset review described in  
5 this section:

6 “(A) Is a part of the executive department, as defined in ORS 174.112;

7 “(B) Consists of a decision-making body of two or more individuals and  
8 any other staff as is appointed by the decision-making body or by one or  
9 more delegates of the decision-making body;

10 “(C) Is established by statute;

11 “(D) Is directed by statute to make decisions or recommendations con-  
12 cerning some aspect of state government; and

13 “(E) Has a continuing existence or a history of existence for at least six  
14 years as of the date the entity is placed on the roster of periodic sunset re-  
15 view described in subsection (2) of this section.

16 “(b) Notwithstanding paragraph (a) of this subsection, this section does  
17 not apply to:

18 “(A) A commodity commission established under ORS 576.062;

19 “(B) The Oregon Beef Council created in ORS 577.210;

20 “(C) The Oregon Wheat Commission created in ORS 578.030;

21 “(D) The Oregon Wine Board created in ORS 576.753;

- 1 “(E) The State Land Board created in ORS 273.031;
- 2 “(F) The Oregon Investment Council created in ORS 293.706;
- 3 “(G) The Oregon 529 Savings Board created in ORS 178.310;
- 4 “(H) The Oregon Facilities Authority created in ORS 289.100;
- 5 “(I) The Oregon Growth Board created in ORS 284.883;
- 6 “(J) The Oregon Retirement Savings Board created in ORS 178.200;
- 7 “(K) The Oregon Municipal Debt Advisory Commission created in ORS
- 8 287A.630;
- 9 “(L) The Oregon Short Term Fund Board created in ORS 294.885;
- 10 “(M) The Private Activity Bond Committee created in ORS 286A.615;
- 11 “(N) The State Debt Policy Advisory Commission created in ORS
- 12 286A.250;
- 13 “(O) The Oregon Innovation Council created in ORS 284.706;
- 14 “(P) The State Board of Education created in ORS 326.021;
- 15 “(Q) The Oregon Infrastructure Finance Authority created in ORS
- 16 285A.096;
- 17 “(R) The Oregon Forest Resources Institute created in ORS 526.610;
- 18 “(S) The Employment Appeals Board created in ORS 657.685;
- 19 “(T) The Employment Department Advisory Council created in ORS
- 20 657.695;
- 21 “(U) An entity that has oversight or policymaking duties with respect to
- 22 another entity described in this subsection; or
- 23 “(V) An entity that routinely and customarily appears before a committee
- 24 of the Legislative Assembly and can demonstrate at least one appearance per
- 25 biennium for the preceding three biennia.”.
