4 455.148, 455.150, 455.200, 455.210, 455.450, 455.485, 455.685, 455.715, 455.720,
5 455.723, 455.730, 455.732, 455.737, 455.740, 455.800 and 479.530; and declaring
6 an emergency.”.

7 Delete lines 6 through 29 and delete pages 2 through 14 and insert:

9 **“GENERAL DEFINITIONS**

10

11 **“SECTION 1.** ORS 455.010 is amended to read:

12 “455.010. As used in this chapter, unless the context requires otherwise:

13 “(1)(a) ‘Advisory board’ means the board with responsibility for assisting
14 in the adoption, amendment or administration of a specialty code, specif-
15 ically:

16 “(A) The Building Codes Structures Board established under ORS 455.132;

17 “(B) The Electrical and Elevator Board established under ORS 455.138;

18 “(C) The State Plumbing Board established under ORS 693.115;

19 “(D) The Board of Boiler Rules established under ORS 480.535;

20 “(E) The Residential and Manufactured Structures Board established un-
21 der ORS 455.135;

1 “(F) The Mechanical Board established under ORS 455.140; or

2 “(G) The Construction Industry Energy Board established under ORS
3 455.492.

4 “(b) ‘Appropriate advisory board’ means the advisory board that has ju-
5 risdiction over a particular code, standard, license, certification or matter.

6 “(2) ‘Department’ means the Department of Consumer and Business Ser-
7 vices.

8 “(3) ‘Director’ means the Director of the Department of Consumer and
9 Business Services.

10 “(4) ‘Low-Rise Residential Dwelling Code’ means the adopted specialty
11 code prescribing standards for the construction of residential dwellings that
12 are three stories or less above grade and have an exterior door for each
13 dwelling unit, but are not facilities or homes described in ORS 443.400 or
14 transient lodging.

15 “(5) **‘Municipal building official’ means a person who is charged by**
16 **a municipality with responsibility for the administration and enforce-**
17 **ment of a building inspection program in the municipality and is:**

18 “(a) **An employee of the municipality;**

19 “(b) **Employed under an intergovernmental agreement that provides**
20 **for the person to supply administration and enforcement services for**
21 **respective building inspection programs of municipalities; or**

22 “(c) **Employed by a council of governments to supply administration**
23 **and enforcement services for respective building inspection programs**
24 **of member governments.**

25 “(6) **‘Municipal inspector’ means a person who performs routine**
26 **enforcement of one or more state building code specialty codes or**
27 **parts of one or more specialty codes for a municipality and is:**

28 “(a) **An employee of the municipality;**

29 “(b) **Employed under an intergovernmental agreement that provides**
30 **for the person to perform routine enforcement of one or more state**

1 **building code specialty codes or parts of one or more specialty codes**
2 **for respective building inspection programs of municipalities;**

3 **“(c) Employed by a council of governments to perform routine**
4 **enforcement of one or more state building code specialty codes or**
5 **parts of one or more specialty codes for respective building inspection**
6 **programs of member governments; or**

7 **“(d) Performing under actual or apparent authority as an agent on**
8 **behalf of the municipality.**

9 “[5] (7) ‘Municipality’ means a city, county or other unit of local gov-
10 ernment otherwise authorized by law to administer a building code.

11 “[6] (8) ‘Prefabricated structure’ means a building or subassembly that
12 has been in whole or substantial part manufactured or assembled using
13 closed construction at an off-site location to be wholly or partially assembled
14 on-site. ‘Prefabricated structure’ does not include a manufactured dwelling,
15 recreational structure or recreational vehicle, as those terms are defined in
16 ORS 446.003.

17 “[7] (9) ‘Specialty code’ means a code of regulations adopted under ORS
18 446.062, 446.185, 447.020 (2), 455.020 (2), 455.496, 455.610, 455.680, 460.085,
19 460.360, 479.730 (1) or 480.545, but does not include regulations adopted by
20 the State Fire Marshal pursuant to ORS chapter 476 or ORS 479.015 to
21 479.200 and 479.210 to 479.220.

22 “[8] (10) ‘State building code’ means the combined specialty codes.

23 “[9] (11) ‘Structural code’ means the specialty code prescribing struc-
24 tural standards for building construction.

25 “[10] (12) ‘Unsafe condition’ means a condition caused by earthquake
26 which is determined by the department or any representative of the depart-
27 ment to be dangerous to life and property. ‘Unsafe condition’ includes but
28 is not limited to:

29 **“(a) Any portion, member or appurtenance of a building that has become**
30 **detached or dislodged or appears likely to fail or collapse and thereby injure**

1 persons or damage property; or

2 “(b) Any portion, of a building or structure that has been damaged by
3 earthquake, or by fire or explosion resulting from an earthquake, to the ex-
4 tent that the structural strength or stability of the building is substantially
5 less than it was prior to the earthquake.

7 **“BUILDING OFFICIAL AND INSPECTOR QUALIFICATIONS**

8

9 **“SECTION 2.** ORS 455.715 is amended to read:

10 “455.715. As used in ORS 455.715 to 455.740, unless the context otherwise
11 requires:

12 “(1) ‘Building official’ means a person charged by a municipality with
13 responsibility for administration and enforcement of the state building code
14 in the municipality.

15 “(2) ‘Business of providing prefabricated structure plan approvals and in-
16 spections’ means an independent contractor providing prefabricated structure
17 plan approval or inspection services, or both, under the following specialty
18 codes, as provided in ORS 455.020, 455.705 and 455.715:

19 “(a) Structural;

20 “(b) Mechanical;

21 “(c) Plumbing;

22 “(d) Electrical; *[and]* **or**

23 “(e) Low-rise residential dwelling.

24 “(3) ‘Inspector’ means:

25 “(a) A person, including a plans examiner, [*acting under the authority and*
26 *direction of a building official and]* charged **by a municipality** with the re-
27 sponsibility of routine enforcement of one or more specialty codes or parts
28 of specialty codes **on behalf of the municipality;**

29 “(b) A person, including a plans examiner, who provides enforcement of
30 one or more specialty codes or parts of specialty codes and who is personally

1 in the business of providing prefabricated structure plan approvals or in-
2 spections or is employed by such a business;

3 “(c) A specialized building inspector certified under ORS 455.723 who [*is*
4 *employed by*] **provides services to** a municipality or [*by*] **through** the De-
5 partment of Consumer and Business Services;

6 “(d) A person [*employed by*] **providing services to** a municipality or the
7 department who is certified under ORS 455.732 to perform inspections under
8 one or more specialty codes throughout a building code administrative re-
9 gion; or

10 “(e) A person designated by the Director of the Department of Consumer
11 and Business Services to ensure compliance with a specialty code or with
12 any requirement for a license, registration, certification, endorsement or
13 other authorization to perform work [*related to the administration and*
14 *enforcement of*] **regulated under** the state building code.

15 **“SECTION 3.** ORS 455.720 is amended to read:

16 “455.720. (1) In accordance with applicable provisions of ORS chapter 183,
17 to promote effective and uniform enforcement of the state building code by
18 improving the competence of building officials and inspectors, the Director
19 of the Department of Consumer and Business Services, with the advice of the
20 advisory boards, shall:

21 “(a) Establish for building officials and inspectors reasonable minimum
22 training and experience standards, including but not limited to courses or
23 subjects for instruction, facilities for instruction, qualification of instructors
24 and methods of instruction. The standards shall include provisions for de-
25 termining a practical experience equivalent.

26 “(b) Establish a procedure to be used by municipalities to determine
27 whether a person meets minimum standards or has minimum training to [*be*
28 *appointed or employed*] **provide services** as a building official or inspector.
29 The procedure shall allow for a field examination of a person to determine
30 if the person meets the practical experience equivalent of a minimum stand-

1 ard.

2 “(c) Subject to such terms, conditions and classifications as the director
3 may impose, certify building officials as being qualified, and revoke such
4 certifications in the manner provided in ORS 455.740.

5 “(d) Require an applicant for a certificate as a building official or in-
6 spector to demonstrate knowledge of the laws governing accessibility to
7 buildings by persons with disabilities by passing an examination prescribed
8 by the director.

9 “(2) The director shall maintain and, upon request of [*municipalities, fur-*
10 *nish information on applicants for appointment or employment as building of-*
11 *ficials or inspectors.*] **a municipality, furnish information on candidates**
12 **for the provision of municipal building official services, or municipal**
13 **inspector services, to the municipality.**

14 “(3) Pursuant to ORS chapter 183, the director shall adopt rules necessary
15 to carry out the certification programs provided by subsection (1) of this
16 section.

17 “(4) The director, by rule, may require evidence of completion of contin-
18 uing education covering any certification created under this section as a
19 condition of maintaining the certification. Nothing in this subsection shall
20 prohibit the director from delegating any of this power to a municipality.

21 “(5) The director, with the advice of the appropriate advisory boards, may
22 adopt rules for certifying inspectors as being qualified to enforce one or more
23 particular specialty codes, subject to any terms, conditions and classifica-
24 tions the director may impose, and for revoking those certifications in the
25 manner provided in ORS 455.740.

26 “**SECTION 4.** ORS 455.723 is amended to read:

27 “455.723. (1) The Director of the Department of Consumer and Business
28 Services, with the advice of the appropriate advisory boards, may adopt rules
29 establishing one or more programs to train, qualify and certify an individual
30 as a specialized building inspector authorized to enforce [*portions*] **parts** of

1 specialty codes. Notwithstanding ORS 455.720 (1) and 455.725, the rules may
2 include, but need not be limited to, rules that establish:

3 “(a) Work experience, training and other qualifications for program par-
4 ticipation;

5 “(b) Content and presentation requirements for training programs;

6 “(c) Methods for verifying the qualification of the individual to enforce
7 [portions] **parts** of specialty codes as a specialized building inspector certi-
8 fied under this section;

9 “(d) The [portions] **parts** of various specialty codes that each program
10 will enable a qualifying individual to enforce and any terms, conditions or
11 classifications applicable for that enforcement; and

12 “(e) Requirements the director believes reasonable for the administration
13 and enforcement of this section.

14 “(2) Notwithstanding ORS 446.250, 455.630, 455.720, 455.725, 479.530,
15 479.810 and 479.855, the director may issue or cause to be issued a certificate
16 as a specialized building inspector to an individual who successfully com-
17 pletes an approved training program and satisfies qualification verification
18 under this section. **A specialized building inspector may be trained and**
19 **certified in parts of more than one specialty code.**

20 “(3) An individual certified as a specialized building inspector under this
21 section may conduct inspections and enforce [portions] **parts** of specialty
22 codes under ORS 479.510 to 479.945 and 479.950 and this chapter and ORS
23 chapters 446, 447 and 693 as identified by the director. The enforcement of
24 [portions] **parts** of specialty codes by a specialized building inspector is
25 subject to any terms, conditions or classifications applicable to that
26 enforcement established by the director by rule.

27 **“SECTION 5.** ORS 455.730 is amended to read:

28 “455.730. *[No person shall be appointed or employed as a building official*
29 *or inspector by any municipality]* **A municipality may not accept municipi-**
30 **pal building official or municipal inspector services from a person un-**

1 less the person has been certified as being qualified under ORS 455.715 to
2 455.740, and the certification has not lapsed or been revoked.

3 **“SECTION 6.** ORS 455.732 is amended to read:

4 “455.732. (1) As used in this section, ‘building code administrative
5 region’ means a region established by the Director of the Department of
6 Consumer and Business Services under ORS 455.042 for the uniform admin-
7 istration of the state building code.

8 “(2) The authority of the director under **this section and** ORS 455.720
9 and 455.723 to specify terms, conditions and classifications for the certifica-
10 tion of inspectors includes the authority to certify an inspector to perform
11 inspections under multiple specialty codes or parts of a specialty code.

12 “(3) The director may provide for an inspector who is likely to be em-
13 ployed within a specific building code administrative region to be certified
14 to perform inspections throughout a building code administrative region,
15 whether within or outside of a municipality. The director may recognize any
16 training program certified by the director under ORS 455.723 or 455.725 for
17 purposes of certifying an inspector to perform inspections throughout a
18 building code administrative region. This subsection does not require a
19 municipality administering and enforcing a building inspection program un-
20 der ORS 455.148 or 455.150 to allow an inspector certified under this sub-
21 section who is not [*employed by*] **an employee of** the municipality to perform
22 building inspections on behalf of the municipality.

23 “(4) In determining the appropriate experience, training or other quali-
24 fications for an inspector under ORS 455.720 or 455.723, the director shall
25 consult with the appropriate advisory boards. The factors to be considered
26 by the director may include, but need not be limited to:

27 “(a) Any factors specific to, or of particular relevance to, a specialty code
28 or to the types of buildings, structures, systems or equipment in a geographic
29 area that are inspected under the specialty code;

30 “(b) Staffing levels or other specific criteria for building inspection pro-

1 grams established by a municipality where the inspector is likely to [*be em-*
2 *ployed*] **provide services** or for building inspection programs established by
3 the director; and

4 “(c) Any factors specific to, or of particular relevance to, the building
5 code administrative region within which the inspector is likely to [*be em-*
6 *ployed*] **provide services**.

7 “(5) In determining the scope of certifications and qualifications for an
8 inspector, the director may utilize field training equivalency, independent
9 evaluations or other methods the director deems appropriate.

10 **“SECTION 7.** ORS 455.737 is amended to read:

11 “455.737. (1) Notwithstanding ORS 455.720 (1), the Director of the De-
12 partment of Consumer and Business Services, by rule, shall adopt criteria for
13 review of the experience and training in building inspection and building
14 plan review acquired by a person outside the State of Oregon. The criteria
15 shall be adopted in a manner that facilitates review of a person’s qualifica-
16 tions by a [*local*] **municipal** building official.

17 “(2)(a) A [*local*] **municipal** building official who wishes to [*employ*] **use**
18 **the services of** a person who is not certified under ORS 455.735 as an in-
19 spector shall submit the person’s qualifications to the director. The director
20 shall review the stated qualifications against the criteria adopted under
21 subsection (1) of this section, including verification of experience and train-
22 ing. The director shall respond to the [*local*] **municipal** building official in
23 writing within 10 working days of receiving the applicant’s qualifications,
24 stating whether the person meets the applicable criteria.

25 “(b) Upon application and payment of the required fee, the director shall
26 allow a person whose qualifications meet the criteria adopted under sub-
27 section (1) of this section to sit for any examination necessary for the re-
28 quired certification.

29 **“SECTION 8.** ORS 455.740 is amended to read:

30 “455.740. (1) Subject to ORS chapter 183, the Director of the Department

1 of Consumer and Business Services may deny, condition, suspend, revoke or
2 refuse to renew a certificate of a building official or inspector if the director
3 finds that the building official or inspector has:

4 “(a) Consistently failed to act in the public interest in the performance
5 of duties;

6 “(b) Failed to complete the continuing education requirements as required
7 under ORS 455.720 (4);

8 “(c) Provided false information to the Department **of Consumer and**
9 **Business Services**; or

10 “(d) Committed an act described in ORS 455.125 or 455.129.

11 “(2) In any revocation proceeding under this section, [*the*] **a municipality**
12 **or council of governments** that employs the building official or inspector
13 [*shall be*] **is** entitled to appear as a party in interest, either for or against
14 the revocation.

15 “(3) When a certification is suspended or revoked under this section, the
16 director may also suspend, deny or place conditions on that person’s right
17 to reapply for certification under ORS 455.735 for a period not to exceed 12
18 months.

19 “(4) This section does not limit or otherwise affect the authority of a
20 municipality to dismiss or suspend a building official or inspector at the
21 discretion of the municipality.

22 “(5) Notwithstanding the requirements of subsections (1) to (4) of this
23 section, the director may adopt rules that:

24 “(a) Allow certifications to be placed on inactive status; and

25 “(b) Extend continuing education compliance requirements in case of ill-
26 ness or hardship.

27

28 **“MUNICIPAL BUILDING INSPECTION PROGRAMS**

29

30 **“SECTION 9.** ORS 455.148 is amended to read:

1 “455.148. (1)(a) A municipality that assumes the administration and
2 enforcement of a building inspection program shall administer and enforce
3 the program for all of the following:

4 “(A) The state building code, as defined in ORS 455.010, except as set
5 forth in paragraph (b) of this subsection.

6 “(B) Manufactured structure installation requirements under ORS 446.155,
7 446.185 (1) and 446.230.

8 “(C) Manufactured dwelling parks and mobile home parks under ORS
9 chapter 446.

10 “(D) Park and camp programs regulated under ORS 455.680.

11 “(E) Tourist facilities regulated under ORS 446.310 to 446.350.

12 “(F) Manufactured dwelling alterations regulated under ORS 446.155.

13 “(G) Manufactured structure accessory buildings and structures under
14 ORS 446.253.

15 “(H) Boilers and pressure vessels described in rules adopted under ORS
16 480.525 (5).

17 “(b) A building inspection program of a municipality may not include:

18 “(A) Boiler and pressure vessel programs under ORS 480.510 to 480.670
19 except those described in rules adopted under ORS 480.525 (5);

20 “(B) Elevator programs under ORS 460.005 to 460.175;

21 “(C) Amusement ride regulation under ORS 460.310 to 460.370;

22 “(D) Prefabricated structure regulation under ORS chapter 455;

23 “(E) Manufacture of manufactured structures programs under ORS 446.155
24 to 446.285, including the administration and enforcement of federal manu-
25 factured dwelling construction and safety standards adopted under ORS
26 446.155 or the National Manufactured Housing Construction and Safety
27 Standards Act of 1974;

28 “(F) Licensing and certification, or the adoption of statewide codes and
29 standards, under ORS chapter 446, 447, 455, 479 or 693; or

30 “(G) Review of plans and specifications as provided in ORS 455.685.

1 “(2) A municipality that administers a building inspection program as
2 allowed under this section shall do so for periods of four years. The De-
3 partment of Consumer and Business Services shall adopt rules to adjust time
4 periods for administration of a building inspection program to allow for
5 variations in the needs of the department and participants.

6 “(3)(a) When a municipality administers a building inspection program,
7 the governing body of the municipality shall[, *unless other means are already*
8 *provided, appoint a person to administer and enforce the building inspection*
9 *program, who shall be known as the building official. A building official*
10 *shall, in the municipality for which appointed, attend to all aspects of code*
11 *enforcement, including the issuance of all building permits. Two or more*
12 *municipalities may combine in the appointment of a single building official for*
13 *the purpose of administering a building inspection program within their com-*
14 *munities.] **arrange for the services of a municipal building official for***
15 **the municipality. The municipality shall also arrange for the services**
16 **of a head building inspector for the municipality, who may also be the**
17 **building official. The head building inspector must be an employee of**
18 **the municipality or be employed under an intergovernmental agree-**
19 **ment or by a council of governments to provide services to the**
20 **municipality. The head building inspector must hold the highest level**
21 **of certification issued by the department under ORS 455.715 to 455.740**
22 **for conducting inspections for compliance with the structural specialty**
23 **code.**

24 “(b) **Except as provided in this subsection, the municipal building**
25 **official shall be responsible for ensuring the adequate and proper ad-**
26 **ministration and enforcement of building inspection program activ-**
27 **ities, including but not limited to the issuance of building permits,**
28 **whether the program activities are carried out by employees of the**
29 **municipality or by other persons authorized to act on behalf of the**
30 **municipality. The head building inspector shall provide supervision**

1 **for, and be actively involved in, the aspects of the program involving**
2 **inspections for routine enforcement of the specialty codes under the**
3 **program.**

4 “(4)(a) By January 1 of the year preceding the expiration of the four-year
5 period described in subsection (2) of this section, the governing body of the
6 municipality shall notify the Director of the Department of Consumer and
7 Business Services and, if the municipality is not a county, notify the county
8 whether the municipality will continue to administer and enforce the build-
9 ing inspection program after expiration of the four-year period.

10 “(b) Notwithstanding the January 1 date set forth in paragraph (a) of this
11 subsection, the director and the municipality and, if the municipality is not
12 a county, the county may by agreement extend that date to no later than
13 March 1.

14 “(5) If a city does not notify the director, or notifies the director that it
15 will not administer the building inspection program, the county or counties
16 in which the city is located shall administer and enforce the county program
17 within the city in the same manner as the program is administered and en-
18 forced outside the city, except as provided by subsection (6) of this section.

19 “(6) If a county does not notify the director, or notifies the director that
20 it will not administer and enforce a building inspection program, the director
21 shall contract with a municipality or other person or use such state em-
22 ployees or state agencies as are necessary to administer and enforce a
23 building inspection program, and permit or other fees arising therefrom shall
24 be paid into the Consumer and Business Services Fund created by ORS
25 705.145 and credited to the account responsible for paying the expenses
26 thereof. A state employee may not be displaced as a result of using contract
27 personnel.

28 “(7) The governing body of a municipality may commence responsibility
29 for the administration and enforcement of a building inspection program be-
30 ginning July 1 of any year by notifying the director no later than January

1 1 of the same year and obtaining the director's approval of an assumption
2 plan as described in subsection [(11)(c)] **(12)(c)** of this section.

3 “(8) The department shall adopt rules to require the governing body of
4 each municipality assuming or continuing a building inspection program
5 under this section to submit a written plan with the notice required under
6 subsection (4) or (7) of this section. If the department is the governing body,
7 the department shall have a plan on file. The plan must specify how coop-
8 eration with the State Fire Marshal or a designee of the State Fire Marshal
9 will be achieved and how a uniform fire code will be considered in the review
10 process of the design and construction phases of buildings or structures.

11 “**(9) A municipal inspector who performs routine enforcement ser-**
12 **vices under actual or apparent authority as an agent on behalf of the**
13 **municipality shall, subject to the approval of the head building in-**
14 **spector, establish the resources used or needed for the inspector to**
15 **perform the enforcement services and establish the method by which**
16 **the enforcement services are to be performed.**

17 “[9] **(10)** A municipality that administers and enforces a building in-
18 spection program pursuant to this section shall recognize and accept the
19 performances of state building code activities by businesses and persons au-
20 thorized under ORS 455.457 to perform the activities as if the activities were
21 performed by the municipality. A municipality is not required to accept an
22 inspection, a plan or a plan review that does not meet the requirements of
23 the state building code.

24 “[10] **(11)** The department or a municipality that accepts an inspection
25 or plan review as required by this section by a person licensed under ORS
26 455.457 has no responsibility or liability for the activities of the licensee.

27 “[11] **(12)** In addition to the requirements of ORS 455.100 and 455.110,
28 the director shall regulate building inspection programs that municipalities
29 assume on or after January 1, 2002. Regulation under this subsection shall
30 include but not be limited to:

1 “(a) Creating building inspection program application and amendment
2 requirements and procedures;

3 “(b) Granting or denying applications for building inspection program
4 authority and amendments;

5 “(c) Requiring a municipality assuming a building inspection program to
6 submit with the notice given under subsection (7) of this section an as-
7 sumption plan that includes, at a minimum:

8 “(A) A description of the intended availability of program services, in-
9 cluding proposed service agreements for carrying out the program during at
10 least the first two years;

11 “(B) Demonstration of the ability and intent to provide building in-
12 spection program services for at least two years;

13 “(C) An estimate of proposed permit revenue and program operating ex-
14 penses;

15 “(D) Proposed staffing levels; and

16 “(E) Proposed service levels;

17 “(d) Reviewing procedures and program operations of municipalities;

18 “(e) Creating standards for efficient, effective, timely and acceptable
19 building inspection programs;

20 “(f) Creating standards for justifying increases in building inspection
21 program fees adopted by a municipality;

22 “(g) Creating standards for determining whether a county or department
23 building inspection program is economically impaired in its ability to rea-
24 sonably continue providing the program throughout a county, if another
25 municipality is allowed to provide a building inspection program within the
26 same county; and

27 “(h) Enforcing the requirements of this section.

28 “[~~12~~] **(13)** The department may assume administration and enforcement
29 of a building inspection program:

30 “(a) During the pendency of activities under ORS 455.770;

1 “(b) If a municipality abandons or is no longer able to administer the
2 building inspection program; and

3 “(c) If a municipality fails to substantially comply with any provision of
4 this section or of ORS 455.465, 455.467 and 455.469.

5 “[~~(13)~~] **(14)** If the department assumes the administration and enforcement
6 of a building inspection program under this section, in addition to any other
7 power granted to the director, the director may:

8 “(a) Enter into agreements with local governments under ORS 455.185
9 regarding the administration and enforcement of the assumed building in-
10 spection program;

23 include, but not be limited to, information regarding any projected need for
24 an increase in department resources required for carrying out the adminis-
25 tration and enforcement of building inspection programs under ORS 455.148
26 [(13)] (14), 455.150 [(13)] (14) or 455.185 to 455.198.

27 **“SECTION 22.** ORS 455.210 is amended to read:

28 “455.210. (1) Fees shall be prescribed as required by ORS 455.020 for plan
29 review and permits issued by the Department of Consumer and Business
30 Services for the construction, reconstruction, alteration and repair of pre-

1 fabricated structures and of buildings and other structures and the installa-
2 tion of mechanical heating and ventilating devices and equipment. The fees
3 may not exceed 130 percent of the fee schedule printed in the ‘Uniform
4 Building Code,’ 1979 Edition, and in the ‘Uniform Mechanical Code,’ 1979
5 Edition, both published by the International Conference of Building Officials.
6 Fees are not effective until approved by the Oregon Department of Admin-
7 istrative Services.

22 “(b) Ten or more persons or an association with 10 or more members may

25 ation must file the appeal no later than 60 days after the director receives
26 notice of the proposed adoption of the fee from the municipality under par-

28 or other formal authorization is required by any specialty code, any pro-
29 vision of ORS 446.003 to 446.200, 446.225 to 446.285, 446.395 to 446.420, 446.566
30 to 446.646, 446.666 to 446.746, 479.510 to 479.945, 479.950 and 480.510 to 480.670,

1 this chapter or ORS chapter 447, 460 or 693, or any rule adopted or order
2 issued for the administration and enforcement of those provisions, without
3 first having obtained such permit, label, license, certificate, registration or
4 other formal authorization.

5 “(3) Violate, or procure or assist in the violation of, any standard, spec-
6 ification, requirement, prohibition or other technical provision set forth in
7 the state building code or an applicable local building code or in any rule
8 or order of the Department of Consumer and Business Services, an advisory
9 board, a [local] **municipal** governing body or [local] **municipal** building of-
10 ficial.

11 **“SECTION 24.** ORS 455.485 is amended to read:

12 “455.485. (1) When adopting the state building code, the Director of the
13 Department of Consumer and Business Services shall give special consider-
14 ation to the unique needs of construction in rural or remote parts of this
15 state.

16 “(2) Notwithstanding any description of State Fire Marshal duties in ORS
17 476.030, 476.033, 476.035, 476.150 or 476.155, the Director of the Department

15 requires otherwise:

16 “(1) ‘Approved testing laboratory’ means a testing laboratory that meets
17 criteria for electrical product evaluation established by the Director of the
18 Department of Consumer and Business Services with the approval of the
19 Electrical and Elevator Board under ORS 479.730.

20 “(2) ‘Board’ means the Electrical and Elevator Board established under
21 ORS 455.138.

22 “(3) ‘Certified electrical product’ means an electrical product that is cer-
23 tified under ORS 479.760 and that is not decertified.

24 “(4) ‘Competent inspection service’ means an electrical inspection service
25 [of a city or county] administered **by a municipality** under ORS 455.148 or
26 455.150 that [employs] **provides services through** electrical inspectors who

10 479.630 authorizing the person whose name appears as licensee thereon to
