**PROPOSED AMENDMENTS TO
HOUSE BILL 4059**

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the
2 line and delete lines 3 and 4 and insert “184.620, 184.661, 184.751, 184.758,
3 184.761, 184.766, 316.189, 320.400, 320.405, 320.415, 320.445, 320.455, 320.490,
4 320.550, 366.155, 366.483, 366.772, 377.725, 377.756, 801.041, 801.042, 803.445,
5 803.645, 805.045, 805.205, 811.215, 811.485, 818.225, 818.270, 825.450 and 825.480
6 and section 2, chapter 823, Oregon Laws 2009, section 18, chapter 30, Oregon
7 Laws 2010, and sections 45, 71d, 85, 122r, 139, 149 and 150, chapter 750,
8 Oregon Laws 2017; repealing section 2, chapter 346, Oregon Laws 2017, and
9 sections 50, 56, 59 and 119, chapter 750, Oregon Laws 2017; and prescribing
10 an effective date.”.

11 On page 6, line 17, delete “design only” and insert “shovel ready prepara-
12 tions”.

13 On page 9, delete lines 29 through 45 and delete pages 10 through 12.

14 On page 13, delete lines 1 through 18 and insert:

15 **“SECTION 10.** ORS 320.400 is amended to read:

16 “320.400. As used in ORS 320.400 to 320.490 and 803.203:

17 “(1)(a) ‘Bicycle’ means a vehicle that is designed to be operated on the
18 ground on wheels and is propelled exclusively by human power.

19 **“(b) ‘Bicycle’ includes an electric assisted bicycle as defined in ORS**
20 **801.258.**

21 “[*(b)*] (c) ‘Bicycle’ does not include durable medical equipment.

1 “[2] ‘New motor vehicle’ has the meaning given that term in ORS 803.350
2 (8)(c).]

3 “[3] **(2)(a)** ‘Retail sales price’ means the total price paid at retail for a
4 taxable vehicle, exclusive of the amount of any excise, privilege or use tax,
5 to a seller by a purchaser of the taxable vehicle.

6 **“(b) ‘Retail sales price’ does not include the retail value of:**

7 **“(A) Modifications to a taxable vehicle that are necessary for a
8 person with a disability to enter or drive or to otherwise operate or
9 use the vehicle.**

10 **“(B) Customized industrial modifications to the chassis of a truck
11 that has a gross vehicle weight rating of at least 10,000 pounds and not
12 more than 26,000 pounds.**

13 “[4] **(3)** ‘Seller’ means:

14 “(a) With respect to the privilege tax imposed under ORS 320.405 and the
15 use tax imposed under ORS 320.410, a vehicle dealer.

16 “(b) With respect to the excise tax imposed under ORS 320.415, a person
17 engaged in whole or in part in the business of selling bicycles.

18 “[5] **(4)** ‘Taxable bicycle’ means a new bicycle that has [*wheels of at least
19 26 inches in diameter and*] a retail sales price of \$200 or more.

20 “[6] **(5)** ‘Taxable motor vehicle’ means a [*new motor*] vehicle [*with*] **that:**

21 **“(a) Has** a gross vehicle weight rating of 26,000 pounds or less [*that
22 is:*];

23 **“(b)(A) If equipped with an odometer, has 7,500 miles or less on the
24 odometer; or**

25 **“(B) If not equipped with an odometer, has a manufacturer’s cer-
26 tificate of origin or a manufacturer’s statement of origin; and**

27 **“(c) Is:**

28 “[*a*] **(A)** A vehicle as defined in ORS 744.850, other than an all-terrain
29 vehicle **or a trailer;**

30 “[*b*] **A bus trailer as defined in ORS 801.165;**]

1 “[c] (B) A camper as defined in ORS 801.180;
2 “[d] (C) A commercial bus as defined in ORS 801.200;
3 “[e] (D) A commercial motor vehicle as defined in ORS 801.208;
4 “[f] (E) A commercial vehicle as defined in ORS 801.210;
5 “[g] *An electric assisted bicycle as defined in ORS 801.258;*
6 “[h] (F) A fixed load vehicle as defined in ORS 801.285;
7 “[i] (G) A moped as defined in ORS 801.345;
8 “[j] *A motor assisted scooter as defined in ORS 801.348;*
9 “[k] (H) A motor home as defined in ORS 801.350;
10 “[L] (I) A motor truck as defined in ORS 801.355;
11 “[m] (J) A tank vehicle as defined in ORS 801.522;
12 “[K] **A trailer as defined in ORS 801.560 that is required to be reg-**
13 **istered in this state;**
14 “[n] (L) A truck tractor as defined in ORS 801.575; **or**
15 “[o] *A truck trailer as defined in ORS 801.580; or*
16 “[p] (M) A worker transport bus as defined in ORS 801.610.
17 “[7] (6) ‘Taxable vehicle’ means a taxable bicycle or a taxable motor
18 vehicle.
19 “[8] (7) ‘Transportation project taxes’ means the privilege tax imposed
20 under ORS 320.405, the use tax imposed under ORS 320.410 and the excise tax
21 imposed under ORS 320.415.
22 “[9(a)] (8)(a) ‘Vehicle dealer’ means:
23 “(A) A person engaged in business in this state that [*has been issued*] **is**
24 **required to obtain** a vehicle dealer certificate under ORS [822.020] **822.005;**
25 **and**
26 “(B) A person engaged in business in another state that would be subject
27 to ORS 822.005 if the person engaged in business in this state.
28 “(b) Notwithstanding paragraph (a) of this subsection, a person is not a
29 vehicle dealer for purposes of ORS 320.400 to 320.490 and 803.203 to the ex-
30 tent the person:

1 “(A) Conducts an event that lasts less than seven consecutive days, for
2 which the public is charged admission and at which otherwise taxable motor
3 vehicles are sold at auction; or

4 “(B) Sells an otherwise taxable motor vehicle at auction at an event de-
5 scribed in this paragraph.

6 **“SECTION 11.** ORS 320.405 is amended to read:

7 “320.405. (1) A tax is imposed on each vehicle dealer for the privilege of
8 engaging in the business of selling taxable motor vehicles at retail in this
9 state.

10 “(2)(a) The privilege tax shall be computed at the rate of 0.5 percent of
11 the retail sales price of the taxable motor vehicle. The tax may be rounded
12 to the nearest whole cent.

13 **“(b) The privilege tax becomes due upon the sale at retail of a tax-
14 able motor vehicle that:**

15 **“(A) Has never been registered in this state; or**

16 **“(B) Has been registered only to a vehicle dealer for use as a dem-
17 onstrator in the course of the vehicle dealer’s business.**

18 “(3)(a) A vehicle dealer may collect the amount of the privilege tax com-
19 puted on the retail sales price of a taxable motor vehicle from the purchaser
20 of the taxable motor vehicle.

21 “(b) Notwithstanding paragraph (a) of this subsection, the purchaser of
22 a taxable motor vehicle from whom the privilege tax is collected is not con-
23 sidered a taxpayer for purposes of the privilege tax imposed under this sec-
24 tion.

25 **“SECTION 12.** ORS 320.415 is amended to read:

26 “320.415. (1) An excise tax of \$15 is imposed on each sale at retail in this
27 state of a taxable bicycle **and becomes due upon the sale.**

28 “(2) The excise tax is a liability of the purchaser of the taxable bicycle.

29 “(3) The amount of the excise tax shall be separately stated on an invoice,
30 receipt or other similar document that the seller provides to the purchaser

1 or shall be otherwise disclosed to the purchaser.

2 “(4) A seller shall collect the excise tax at the time of the taxable sale.

3 “(5) A purchaser’s liability for the excise tax is satisfied by a valid receipt
4 given to the purchaser by the seller of the taxable bicycle **showing payment**
5 **of the excise tax.**

6 **“SECTION 13.** ORS 320.445 is amended to read:

7 “320.445. (1) Except as otherwise provided in ORS 320.400 to 320.490 and
8 803.203, the use tax imposed under ORS 320.410 and the excise tax imposed
9 under ORS 320.415 shall be collected at the point of sale and remitted by
10 each seller that engages in the retail sale of taxable vehicles. Each tax is
11 considered a tax upon the seller that is required to collect the tax, and the
12 seller is considered a taxpayer.

13 “(2) Each seller of taxable vehicles that is liable for transportation
14 project taxes shall file a return with the Department of Revenue, in the form
15 and manner prescribed by the department, on or before the last day of Jan-
16 uary, April, July and October of each year for the previous calendar quarter.
17 **The return shall show the amount of transportation project taxes due**
18 **for retail sales made during the calendar quarter to which the return**
19 **relates.**

20 “(3) Each seller shall pay the applicable transportation project taxes to
21 the department in the form and manner prescribed by the department, but
22 not later than the date of submitting each quarterly return, without regard
23 to extensions under subsection (5) of this section.

24 “(4) Sellers of taxable vehicles shall file the returns required under this
25 section with respect to the privilege tax imposed under ORS 320.405 and the
26 excise tax imposed under ORS 320.415 regardless of whether any taxes are
27 owed.

28 “(5) The department may extend the time for making any return required
29 under this section if a written request is filed with the department during
30 or prior to the period for which the extension may be granted. The depart-

1 ment may not grant an extension of more than 30 days.

2 “(6) Interest shall be added to delinquent tax amounts at the rate estab-
3 lished under ORS 305.220 from the time the return to which the delinquent
4 tax amounts relate was originally required to be filed to the time of payment.

5 **“SECTION 14.** ORS 320.455 is amended to read:

6 “320.455. Any purchaser liable for the use tax imposed under ORS 320.410
7 or the excise tax imposed under ORS 320.415 and from whom the tax has not
8 been collected shall, on or before the [*20th day of the month following the*
9 *close of the month in*] **30th day following the date on** which the tax became
10 due, file with the Department of Revenue a report of the amount of tax due
11 from the purchaser in a form and manner prescribed by the department. The
12 purchaser shall remit the amount of tax due with the report.

13 **“SECTION 15.** ORS 320.490 is amended to read:

14 “320.490. (1) A local government may not impose a tax described in sub-
15 section (2) of this section unless the tax is:

16 “(a) Authorized by statute; or

17 “(b) Approved by the governing body of the local government and in effect
18 on or before October 6, 2017.

19 “(2) This section applies to:

20 “(a) A tax **imposed** on the privilege of engaging in the business of selling
21 taxable motor vehicles at retail; and

22 “(b) Any [*other*] privilege, excise, sales or use tax **imposed on or with**
23 **respect to** taxable motor vehicles.

24 **“SECTION 16.** ORS 320.550 is amended to read:

25 “320.550. (1) As used in this section:

26 “(a) ‘Employer’ has the meaning given that term in ORS 316.162.

27 “(b) ‘Resident of this state’ has the meaning given that term in ORS
28 316.027.

29 “(c) ‘Wages’ has the meaning given that term in ORS 316.162.

30 “(2) A tax is imposed at the rate of one-tenth of one percent of[.]

1 “[(a)] the wages of an employee who is:

2 “[(A)] **(a)** A resident of this state, regardless of where services are per-
3 formed.

4 “[(B)] **(b)** Not a resident of this state, for services performed in this state.

5 “[(b) *The periodic payments under ORS 316.189.*]

6 “(3) Every employer at the time of the payment of wages shall deduct and
7 withhold from the total amount of the wages paid for services described un-
8 der subsection (2) of this section an amount equal to the total amount of
9 wages[, *without exemption or deduction,*] multiplied by the rate of tax im-
10 posed under subsection (2) of this section.

11 “[(4) *Every payer at the time of making a periodic payment under ORS*
12 *316.189 shall deduct and withhold from the payment an amount equal to the*
13 *total amount of the payment, without exemption or deduction, multiplied by the*
14 *rate of tax imposed under subsection (2) of this section.*]

15 “[(5)] **(4)** An employer [*or payer*] shall report and pay the tax imposed
16 under this section to the Department of Revenue at the time and in the
17 manner determined by the department by rule.

18 “[(6)] **(5)** For purposes of the tax imposed under this section, an employer
19 [*or payer*] is considered a taxpayer.

20 “[(7)] **(6)** If a lender, surety or other person who supplies funds to or for
21 the account of an employer for the purpose of paying wages of the employees
22 of such employer has actual notice or knowledge that such employer does
23 not intend to or will not be able to make timely payment or deposit of the
24 tax required to be deducted and withheld, such lender, surety or other person
25 shall be liable to the State of Oregon in a sum equal to the taxes, together
26 with interest, that are not timely paid over to the Department of Revenue.
27 Such liability shall be limited to the principal amount supplied by the lender,
28 surety or other person, and any amounts so paid to the department shall be
29 credited against the liability of the employer.

30 “[(8)(a)] **(7)(a)** An employer [*or payer*] shall submit an annual return

1 pursuant to ORS 316.202 to the Department of Revenue. The amounts de-
2 ducted from the wages during any calendar year in accordance with this
3 section shall be considered to be in payment of the tax imposed under sub-
4 section (2) of this section.

5 “(b) The return submitted by the employer shall be accepted by the De-
6 partment of Revenue as evidence in favor of the employee of the amounts so
7 deducted from the employee’s wages.

8 “[9] (8) Nothing in this section prohibits the Department of Revenue
9 from including the tax imposed under this section in the combined quarterly
10 tax report required under ORS 316.168.

11 “[10] (9) An employer that fails to deduct and withhold the tax required
12 under this section:

13 “(a) Is deemed responsible for the payment of the tax obligation in an
14 amount equal to the amount required to be withheld from the employee’s
15 wages and remitted to the Department of Revenue; and

16 “(b) Is subject to a penalty of \$250 per employee, up to a maximum pen-
17 alty of \$25,000, if the employer knowingly fails to deduct and withhold the
18 tax.

19 “[11] (10) Residents subject to the tax imposed under this section on
20 wages earned outside this state from an employer not doing business within
21 this state shall report and pay the tax **in an amount not to exceed one-**
22 **tenth of one percent of the wages earned outside this state, and** at the
23 time and in the manner, **as** determined by the Department of Revenue by
24 rule.

25 **“SECTION 17.** ORS 316.189 is amended to read:

26 “316.189. (1) As used in this section:

27 “(a) ‘Commercial annuity’ means an annuity, endowment or life insurance
28 contract issued by an insurance company authorized to transact insurance
29 in the State of Oregon.

30 “(b) ‘Department’ means the Oregon Department of Revenue.

1 “(c) ‘Designated distribution’ means any distribution or payment from or
2 under an employer deferred compensation plan, an individual retirement plan
3 or a commercial annuity. ‘Designated distribution’ does not include any
4 amount treated as wages as defined in ORS 316.162, the portion of any dis-
5 tribution or payment that is not includable in the gross income of the re-
6 cipient or any distribution or payment made under section 404(k)(2) of the
7 Internal Revenue Code.

8 “(d) ‘Employer deferred compensation plan’ means any pension, annuity,
9 profit-sharing or stock bonus plan or other plan deferring the receipt of
10 compensation.

11 “(e) ‘Individual retirement plan’ means an individual retirement account
12 described in section 408(a) of the Internal Revenue Code or an individual
13 retirement annuity described in section 408(b) of the Internal Revenue Code.

14 “(f) ‘Nonperiodic distribution’ means any designated distribution which
15 is not a periodic payment.

16 “(g) ‘Payer’ means any payer of a designated distribution doing business
17 in or making payments or distributions from sources in this state.

18 “(h) ‘Periodic payment’ means a designated distribution which is an an-
19 nuity or similar periodic payment.

20 “(i) ‘Plan administrator’ means a plan administrator as described in sec-
21 tion 414(g) of the Internal Revenue Code, who is the administrator of a plan
22 created by an Oregon employer.

23 “(j) ‘Qualified total distribution’ means any designated distribution made
24 under a retirement, annuity or deferred compensation plan described in sec-
25 tion 401(a), 403(a) or 457(b) of the Internal Revenue Code, that consists of
26 the balance to the credit of the employee, exclusive of accumulated deduct-
27 ible employee contributions, made within one tax year of the recipient.

28 “(2)(a) The payer of any periodic payment shall withhold from such pay-
29 ment the amount which would be required to be withheld from such payment
30 under ORS 316.167 [or 320.550] if the payment were wages paid by an em-

1 ployer to an employee. The time and manner of payment of withheld amounts
2 to the department shall be the same as that required under ORS 316.197 for
3 withholding of income taxes from wages.

4 “(b) The payer of any nonperiodic distribution shall withhold from such
5 distribution an amount determined under tables prescribed by the depart-
6 ment.

7 “(c) The maximum amount to be withheld under this section on any des-
8 ignated distribution shall not exceed 10 percent of the amount of money and
9 the fair market value of other property received in the distribution. If the
10 distribution is not subject to withholding for federal income tax purposes
11 under section 3405 of the Internal Revenue Code, it shall not be subject to
12 withholding under this section.

13 “(3)(a) Except as provided in paragraph (b) of this subsection, the payer
14 of a designated distribution shall withhold and be liable for payment of
15 amounts required to be withheld under this section.

16 “(b) In the case of any plan described in section 401(a), 403(a) or 457(b)
17 of the Internal Revenue Code, or section 301(d) of the Tax Reduction Act of
18 1975, the plan administrator shall withhold and be liable for payment of
19 amounts required to be withheld under this section, unless the plan admin-
20 istrator has directed the payer to withhold the tax and has provided the
21 payer with the information required by rule of the department.

22 “(4)(a) An individual may elect to have no withholding by a payer under
23 subsection (2) of this section. If an individual has elected to have no federal
24 withholding from payments or distributions described in this section the in-
25 dividual shall be deemed to have elected no withholding for state purposes,
26 unless the individual notifies the payer otherwise.

27 “(b) An election made under this subsection shall be effective as provided
28 under rules promulgated by the department. The rules required under this
29 paragraph shall provide the manner in which an election may be revoked and
30 when such revocation shall be effective.

1 “(c) An election made under this subsection does not apply to amounts re-
2 quired to be withheld under ORS 320.550.]

3 “(5) The payer of any periodic payment or nonperiodic distribution shall
4 give notice to the payee of the right to make an election to have no state
5 withholding from the payment or distribution. The department shall provide
6 by rule for the time and manner of giving the notice required under this
7 subsection.

8 “(6) Any rules permitted or required to be promulgated by the department
9 under this section shall, insofar as is practicable, be consistent with corre-
10 sponding provisions of section 3405 of the Internal Revenue Code and regu-
11 lations promulgated thereunder.

12 “(7) Any designated distribution shall be treated as if it were wages paid
13 by an employer to an employee within the meaning of ORS 316.162 to 316.221
14 [and 320.550] for all other purposes of ORS 316.162 to 316.221 [and 320.550].
15 In the case of any designated distribution not subject to withholding by
16 reason of an election under subsection (4) of this section, the amount with-
17 held shall be treated as zero.

18 “**SECTION 18. Sections 148 to 152, chapter 750, Oregon Laws 2017,**
19 **are added to and made a part of ORS chapter 468.**

20 “**SECTION 19.** Section 149, chapter 750, Oregon Laws 2017, is amended
21 to read:

22 “**Sec. 149.** (1) The Department of Environmental Quality shall establish
23 a program for providing rebates to persons that purchase **or lease** qualifying
24 vehicles for use in this state. The Director of the Department of Environ-
25 mental Quality may hire or contract with a third-party [*nonprofit*] organiza-
26 tion to implement and serve as the administrator of the program required
27 by this section.

28 “(2) The department may:

29 “(a) Specify design features for the program; and

30 “(b) Establish procedures to:

1 “(A) Prioritize available moneys for specific qualifying vehicles; and

2 “(B) Limit the number of rebates available for each type of qualifying
3 vehicle.

4 “(3) The purchaser or lessee of a qualifying vehicle may apply for a rebate
5 for a portion of the purchase price or may choose to assign the rebate to a
6 vehicle dealer or lessor.

7 “(4) Rebates under the program shall be made from moneys credited to
8 or deposited in the Zero-Emission Incentive Fund established under section
9 152, **chapter 750, Oregon Laws 2017** [*of this 2017 Act*]. A rebate may not
10 be made until there are sufficient moneys available in the fund to make the
11 rebate.

12 “(5) The department shall prescribe the rebate application procedure for
13 purchasers and lessees. All rebate applications must include a declaration
14 under penalty of perjury in the form required by ORCP 1 E.

15 “(6) Rebates for qualifying vehicles shall be set annually by the depart-
16 ment as follows:

17 “(a) For light-duty zero-emission vehicles and plug-in hybrid electric ve-
18 hicles with an electrochemical energy storage capacity of 10 kilowatt hours
19 or more, up to \$2,500 but not less than \$1,500.

20 “(b) For light-duty zero-emission vehicles or plug-in hybrid electric vehi-
21 cles with an electrochemical energy storage capacity of less than 10 kilowatt
22 hours, up to \$1,500 but not less than \$750.

23 “(7) To be eligible for a rebate, a person requesting a rebate under the
24 program shall:

25 “(a) Purchase or lease a qualifying vehicle. A lease must have a minimum
26 term of 24 months.

27 “(b) Provide proof of an intent to use the qualifying vehicle primarily on
28 the public highways of this state, which may be satisfied by providing proof
29 of registration of the qualifying vehicle in Oregon.

30 “(c) Submit an application for a rebate to the administrator of the pro-

1 gram within six months after the date of purchase of the qualifying vehicle
2 or six months after the date the lease of the qualifying vehicle begins.

3 “(d) Retain registration of the qualifying vehicle for a minimum of 24
4 consecutive months after the date of purchase or the date the lease begins.

5 “(8) A rebate recipient may not make or allow any modifications to the
6 qualifying vehicle’s emissions control systems, hardware, software cali-
7 brations or hybrid system.

8 “(9) If a rebate recipient [*intends to sell the qualifying vehicle, or*
9 *terminate*] **sells the qualifying vehicle, or terminates** the qualifying vehi-
10 cle lease before the end of 24 months, the rebate recipient shall notify the
11 administrator of the program of the [*recipient’s intent to sell the vehicle or*
12 *terminate the lease*] **sale or termination** and shall reimburse the adminis-
13 trator for the entire rebate amount.

14 “(10) Rebate recipients may be requested to participate in ongoing re-
15 search efforts.

16 “(11) The administrator of the program shall work to ensure timely pay-
17 ment of rebates with a goal of paying rebates within 60 days after receiving
18 an application for a rebate.

19 “(12) A vehicle dealer may advertise the program on the premises owned
20 or operated by the vehicle dealer. If no moneys are available from the pro-
21 gram or the program otherwise changes, a vehicle dealer who advertises the
22 program may not be held liable for advertising false or misleading informa-
23 tion.

24 “(13) The Environmental Quality Commission may adopt any rules neces-
25 sary to carry out the provisions of this section.

26 “**SECTION 20.** Section 149, chapter 750, Oregon Laws 2017, as amended
27 by section 155, chapter 750, Oregon Laws 2017, is amended to read:

28 “**Sec. 149.** (1) The Department of Environmental Quality shall establish
29 a program for providing rebates to persons that purchase **or lease** qualifying
30 vehicles for use in this state. The Director of the Department of Environ-

1 mental Quality may hire or contract with a third-party [*nonprofit*] organiza-
2 tion to implement and serve as the administrator of the program required
3 by this section.

4 “(2) The department may:

5 “(a) Specify design features for the program; and

6 “(b) Establish procedures to:

7 “(A) Prioritize available moneys for specific qualifying vehicles; and

8 “(B) Limit the number of rebates available for each type of qualifying
9 vehicle.

10 “(3) The purchaser or lessee of a qualifying vehicle may apply for a rebate
11 for a portion of the purchase price or may choose to assign the rebate to a
12 vehicle dealer or lessor.

13 “(4) Rebates under the program shall be made from moneys credited to
14 or deposited in the Zero-Emission Incentive Fund established under section
15 152, **chapter 750, Oregon Laws 2017** [*of this 2017 Act*]. A rebate may not
16 be made until there are sufficient moneys available in the fund to make the
17 rebate.

18 “(5) The department shall prescribe the rebate application procedure for
19 purchasers and lessees. All rebate applications must include a declaration
20 under penalty of perjury in the form required by ORCP 1 E.

21 “(6) Rebates for qualifying vehicles shall be set annually by the depart-
22 ment as follows:

23 “(a) For light-duty zero-emission vehicles and plug-in hybrid electric ve-
24 hicles with an electrochemical energy storage capacity of 10 kilowatt hours
25 or more, up to \$2,500 but no less than \$1,500.

26 “(b) For light-duty zero-emission vehicles or plug-in hybrid electric vehi-
27 cles with an electrochemical energy storage capacity of less than 10 kilowatt
28 hours, up to \$1,500 but no less than \$750.

29 “(c) For neighborhood electric vehicles, up to \$750 but not less than \$375.

4 advertising sign would be totally blocked in its current location.

5 “(B) An owner of an outdoor advertising sign shall be considered
6 to have suffered a partial loss with respect to the outdoor advertising
7 sign if, due to a highway construction project, the face of the outdoor
8 advertising sign would be substantially but not totally blocked in its
9 current location.

10 “(b) Full compensation for loss of an outdoor advertising sign
11 equals the market value of the outdoor advertising sign, measured by
12 comparable sales of outdoor advertising signs as determined by an
13 appraiser recognized as a specialist in such valuations, less the salvage
14 value of the components of the outdoor advertising sign.

15 “(2)(a) When the Department of Transportation determines that a
16 highway construction project supervised by the department will result
17 in the total or partial loss of an outdoor advertising sign, the depart-
18 ment shall enter into negotiations with the owner of the outdoor ad-
19 vertising sign for relocation of the outdoor advertising sign.

20 “(b) The department may require the owner to provide information
21 about the owner’s efforts to acquire a comparable location for the
22 outdoor advertising sign.

23 “(c) The department may assist the owner’s efforts to acquire and
24 obtain approval for a comparable location for the outdoor advertising
25 sign.

26 “(3)(a) The department may enter into an agreement with the
27 owner of an outdoor advertising sign for relocation of the outdoor
28 advertising sign on any terms not prohibited by law or inconsistent
29 with this section.

30 “(b) An agreement entered into under this subsection may not re-

1 **quire the department to pay the owner of the outdoor advertising sign**
2 **an amount in compensation that is greater than the actual cost to the**
3 **owner of relocating the outdoor advertising sign.**

4 **“(4)(a) If, after reasonable efforts, the owner of an outdoor adver-**
5 **tising sign subject to total or partial loss is unable to acquire a com-**
6 **parable location in the same market area for the outdoor advertising**
7 **sign, except as provided in ORS 377.725 (4), the department shall pay**
8 **the owner compensation as provided in this subsection.**

9 **“(b) Except as provided in paragraph (c) of this subsection, for a**
10 **total loss of an outdoor advertising sign, the department shall pay the**
11 **owner full compensation for the loss and permanently cancel the sign**
12 **permit, and the owner shall remove the sign.**

13 **“(c) For a total loss of an outdoor advertising sign in which a new**
14 **site for the outdoor advertising sign is found at a less than comparable**
15 **location, the department shall pay the owner the difference between**
16 **the amount of full compensation for the loss and the market value of**

18 **is on a state highway, the owner may use the outdoor advertising**

24 shall complete forms furnished by the director. The permit application shall
25 include a precise description of the outdoor advertising sign and such other
26 information as the director considers necessary or desirable to determine
27 compliance with ORS 377.700 to 377.844. The director shall issue a permit for
28 an outdoor advertising sign that complies with ORS 377.700 to 377.844. A
29 valid permit may be transferred to another person upon written notice to the
30 director.

1 “(3) A permit may not be issued for an outdoor advertising sign located
2 adjacent to an interstate highway or freeway unless the director determines
3 that access to the **outdoor advertising** sign from the interstate highway or
4 freeway can be obtained without violating the access control line of the
5 interstate highway or freeway.

6 “(4) **If an application for a permit to relocate or reconstruct an**
7 **outdoor advertising sign is for a location identified in the current**
8 **Statewide Transportation Improvement Program, the department shall**
9 **require the applicant to execute an affidavit acknowledging the project**
10 **and forgoing any claim for compensation under section 46 of this 2018**
11 **Act.**

12 “[4] (5) A permit shall be renewed annually on the first day of January.
13 Application for renewal of a permit shall be filed prior to expiration of the
14 term of the permit. If application for renewal of a permit is filed within 30
15 days after the expiration of the term, the permit shall be granted if any ad-
16 ditional fee specified by the department in rules adopted under ORS 377.729
17 is paid at the time the application is filed. Any permit not renewed in ac-
18 cordance with this section shall be canceled.

19 “[5] (6) Permit fees for purposes of this section are as established by the
20 department by rule under ORS 377.729.

21 “[6] (7) A permit shall be issued for one year. The applicable fee shall
22 accompany the permit application. A fee may not be prorated for a fraction
23 of a year or be refunded if the outdoor advertising sign is removed.

24 “[7] (8) The display surface of an outdoor advertising sign may be
25 changed or cutouts may be attached or removed within the sign area without
26 obtaining a permit. However, a permit shall be obtained if the outdoor ad-
27 vertising sign is reconstructed.

28 “[8] (9) A reconstruction permit may be issued for the addition of an-
29 other display surface on the opposite side of an existing, conforming **outdoor**
30 **advertising** sign under permit, that is no larger than the existing display

1 surface.

2 “[9] (10) The director shall require removal of a sign or shall cancel a
3 permit and require removal of an outdoor advertising sign as provided by
4 ORS 377.775 if the director finds a sign **or an outdoor advertising sign** has
5 been erected, maintained or serviced from the highway right of way at any
6 portion of the right of way where the department has acquired rights of ac-
7 cess to the highway or rights of access have not accrued to the abutting
8 property. If there is no permit for the outdoor advertising sign, then the di-
9 rector shall require removal of the outdoor advertising sign. In addition, the
10 department may recover from the owner of the sign or outdoor advertising
11 sign or from the person erecting, maintaining or servicing the sign or out-
12 door advertising sign, the amount of damage to landscaping, sod, fencing,
13 ditches or other highway appurtenances resulting from such acts. If a permit
14 is canceled under this subsection, an outdoor advertising sign may not be
15 relocated under ORS 377.767.

16 “[10)(a)] (11)(a) The director may cancel a permit, unless a corrected
17 application is filed or the outdoor advertising sign is brought into compli-
18 ance within 30 days after written notice thereof is mailed to the permittee,
19 if the director finds:

20 “(A) The applicant has knowingly supplied materially false or misleading
21 information in the application for a permit or renewal thereof; or

22 “(B) The **outdoor advertising** sign covered by the permit violates ORS
23 377.700 to 377.844.

24 “(b) If a permit is canceled under this subsection, an outdoor advertising
25 sign may not be relocated under ORS 377.767, and the holder of the permit
26 is not entitled to a relocation credit.

27 “[11)] (12) The director shall cancel a permit immediately upon failure
28 of a permittee to erect or maintain the outdoor advertising sign as described
29 by the permit application and to attach a permit plate to the **outdoor ad-**
30 **vertising** sign 180 days after the date of issuance of the permit.

1 “[(12)] (13) The director shall assign a permit plate with an identification
2 number to the permit issued for an outdoor advertising sign. The permittee
3 shall attach the permit plate to the outdoor advertising sign so the plate is
4 visible from the adjacent state highway. The absence of a permit plate or
5 failure to renew the permit annually is prima facie evidence that the outdoor
6 advertising sign does not comply with ORS 377.700 to 377.844.

7 “[(13)] (14) Except as otherwise provided in ORS 377.712, 377.753 and
8 377.765, no permits shall be issued for the erection of any new outdoor ad-
9 vertising sign after May 30, 2007.

10 “[(14)] (15) The director may establish more than one class or type of
11 outdoor advertising sign permit as necessary or desirable to carry out ORS
12 377.700 to 377.844.

13 “[(15)] (16) Any hearing under this section shall be conducted as a con-
14 tested case hearing under ORS chapter 183.

15 **“SECTION 48. Section 46 of this 2018 Act and the amendments to**
16 **ORS 377.725 by section 47 of this 2018 Act apply to partial and total**
17 **losses suffered by owners of outdoor advertising signs on or after the**
18 **effective date of this 2018 Act.**

19 **“SECTION 49.** ORS 377.756 is amended to read:

20 “377.756. (1) The Department of Transportation shall issue permits for the
21 erection of signs authorized by ORS 377.756 to 377.758. Subject to subsections
22 (2) and (3) of this section, permits shall be issued at no cost to any city or
23 county that applies or to any nonprofit or civic applicant approved by a city
24 or county. Each permit entitles the holder of the permit to erect one sign in
25 accordance with this section.

26 “(2) Each city may be given permits under this section entitling the city
27 to erect [*not more than two*] signs that are visible from state highways and
28 that are within the city limits or, pursuant to a memorandum of under-
29 standing with appropriate federal authorities, are no more than one mile
30 outside of the city limits. The permits may be given directly to the city or

1 may be given to a nonprofit or civic organization designated by the city
2 governing body.

3 “(3) Each county may be given permits under this section entitling each
4 unincorporated community identified in the county comprehensive plan, as
5 defined in ORS 197.015, to erect [*not more than two*] signs that are visible
6 from state highways and that are within one mile of the community growth
7 boundary as designated by the county. The permits may be given directly to
8 the county or, if the county governing body so authorizes, to an unincor-
9 porated community or a nonprofit or civic organization designated by the
10 county governing body.

11 “[*(4) The department may not issue more than 200 permits under this sec-*
12 *tion.*]”.
