A-ENGROSSED SENATE BILL 1565**

3 In line 5, delete “3” and insert “1” and delete “4” and insert “2”.
4 In line 6, delete “4” and insert “2”.
5 In line 37, delete “5” and insert “3”.
6 On page 6, line 24, delete “6” and insert “4” and delete “5” and insert
7 “3”.
8 On page 10, line 8, delete “7” and insert “5”.
9 In line 13, delete “8” and insert “6” and delete “7” and insert “5”.
10 Delete lines 17 through 44 and insert:
11 **“SECTION 7. Section 2 of this 2018 Act and the amendments to ORS**
12 **279B.060 and 279B.145 by sections 3 and 5 of this 2018 Act apply to public**
13 **contracts that a contracting agency has advertised or otherwise solic-**
14 **ited, or if the contracting agency has not advertised or solicited the**
15 **public contract, to public contracts into which the contracting agency**
16 **enters on or after the operative date specified in section 8 (1) of this**
17 **2018 Act and before the operative date specified in section 8 (2) of this**
18 **2018 Act.**
19 **“SECTION 8. (1) Section 2 of this 2018 Act and the amendments to**
20 **ORS 279B.060 and 279B.145 by sections 3 and 5 of this 2018 Act become**
21 **operative on January 1, 2019.**

1 “(2) The amendments to ORS 279B.060 and 279B.145 by sections 4 and
2 6 of this 2018 Act become operative on January 2, 2020.

3 “(3) The Attorney General, the Director of the Oregon Department
4 of Administrative Services, the Director of Transportation and a con-
5 tracting agency that adopts rules under ORS 279A.065 or 279A.070 may
6 adopt rules and take any other action before the operative date speci-
7 fied in subsection (1) of this section that is necessary to enable the
8 Attorney General, the director or the contracting agency, on and after
9 the operative date specified in subsection (1) of this section, to
10 undertake or exercise all of the duties, functions and powers conferred
11 on the Attorney General, the director or the contracting agency under
12 section 2 of this 2018 Act and the amendments to ORS 279B.060 and
13 279B.145 by sections 3 and 5 of this 2018 Act.

14 “SECTION 9. Section 2 of this 2018 Act is repealed on January 2,
15 2020.

16 “SECTION 10. This 2018 Act takes effect on the 91st day after the
17 date on which the 2018 regular session of the Seventy-ninth Legislative
18 Assembly adjourns sine die.”.
