STATUTORY QUALIFICATIONS: ORS 413.006

- Nine members (ARANA, BANGSBERG, ISAACSON, JOHNSON, MCKELVEY, SANTA, SHIPPENTOWER, SMITH) who are citizens of the United States and residents of Oregon who:
 - o Have demonstrated leadership skills in their professional and civil lives;
 - o To the greatest extent practicable, represent the various geographic, ethnic, gender, racial and economic diversity of Oregon;
 - O Collectively offer expertise, knowledge and experience in consumer advocacy, management of a company that offers health insurance to its employees, public health, finance, organized labor, health care and the operation of a small business.
- No more than four members may:
 - o Be employed in, or have a household income that comes from, health care or a health care-related field.
 - o Receive benefits from a publicly funded state health benefit plan.
- At least one member must have an active license to provide health care.
- Four-year terms; serve at pleasure of Governor.
- Entitled to per diem.

DUTIES AND AUTHORITY: ORS 413.008 to 413.017

- Make policy for, and conduct oversight of, the Oregon Health Authority.
- Publish health outcome and quality measure data.
- Establish evidence-based clinical standards and practice guidelines.
- Approve and monitor specified community-centered health initiatives and regularly report to the Legislative Assembly on related accomplishments and needed changes.
- Establish cost containment mechanisms.
- Ensure that Oregon's health care workforce is sufficient in numbers and training.
- Work with Oregon's congressional delegation.
- Establish a health benefit package to be used as a baseline for plans offered through the exchange.

- Investigate and report annually to the Legislative Assembly on the feasibility and advisability of future changes to the health insurance market in Oregon.
- Meet cost-containment goals.
- Oversee the expenditures of moneys from the Health Care Workforce Strategic Fund.
- Work with the Public Health Benefit Purchasers Committee and the Health Information Technology Oversight Council.
- Submit requests for legislative measures directly to the Legislative Counsel.
- Establish advisory and technical committees.
