- Eight members, who are Oregon residents:
  - Five members licensed to practice veterinary medicine, surgery, and dentistry in Oregon (DAVIS, DEBESS, HAMILTON, LAMB, WILSON).
  - Two public members (PATE, YATES).
  - One member shall be a certified veterinary technician (MAIR WILLIAMSON).
- Four-year terms; to extent practicable, Governor to make appointments that are broadly representative of the geographic and cultural diversity of Oregon.
- Entitled to per diem.

**DUTIES AND AUTHORITY:** ORS 686.210 – 686.990

- Elect board president; adopt rules; impose fees.
- General supervision of practice of veterinary medicine; investigate complaints.
- Issue, suspend and revoke licenses; require continuing education.
