STATEMENT OF ECONOMIC INTEREST (ORS 244.050): Not required

STATUTORY QUALIFICATIONS: ORS 688.160

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Eight members who must be residents of Oregon:
 - Five must be licensed physical therapists who have been practicing physical therapy for at least five years, at least two of which must be in Oregon immediately preceding appointment (BENSON, HAWORTH, MCAVOY, OKUMURA, RESICH).
 - o One must be a licensed physical therapist assistant (GOLDSMITH).
 - Two must be public members who are interested in consumer rights and meet specified conflict provisions (HAHN, MUZIKANT).
- Four-year term; serve at pleasure of Governor; Governor to strive to balance representation according to geographic area and ethnicity.
- Entitled to per diem; board may increase statutory rate.

DUTIES AND AUTHORITY: ORS 688.010 - 688.240

- License physical therapists; establish standards and tests to determine qualifications of applicants.
- Establish minimum competency requirements and rules relating to the supervision of physical therapist aides.
- Impose and collect fees.
- Investigate complaints; suspend, revoke or refuse to renew license; impose probationary conditions, civil penalties and other appropriate sanctions, including letters of reprimand.
