Re: 2020 Committee LC Summaries

Date: January 13, 2020

LC 92 – Requires the Oregon Health Authority (OHA) to provide biannual reports to the Legislative Assembly on issues related to coordinated care organization (CCO) financial reporting requirements, including any civil penalties imposed, corrective action taken, financial problems, and concerns raised about the use of National Association of Insurance Commissioners' reporting standards. Extends the deadline for the Task Force on Universal Health Care (Senate Bill 770, 2019) to report its finding and recommendations for the Health Care for All Oregon Plan and Health Care for All Oregon Board to November 1, 2021. Requires the Task Force to report to the Legislative Assembly during the 2021 regulation session on any remaining work and timeline for completion. Prohibits CCOs from withholding required reporting information on the ground that the information is a trade secret. Prohibits OHA from involuntarily transferring a CCO member to another CCO prior to the member's eligibility redetermination period unless a CCO is out of compliance with its contract or the transfer is for good cause. Exempts certain benefits required by law to be provided by health insurance policies from implied repeal by operation of law. Declare emergency, effective on passage.

LC 263 – Directs the Oregon Health Authority (OHA) to continue administration of the certified community behavioral health clinic demonstration program until June 2021, or earlier if federal funding terminates. Requires OHA to evaluate specified aspects of the demonstration program and report findings and analysis to the Legislative Assembly by December 1, 2020. Declares emergency, effective on passage.

LC 270 – Requires the Oregon Health Authority, under the direction of the Oregon Health Policy Board, and in collaboration with specified stakeholders to identify, assess and prepare report on regulatory and policy barriers to effective and timely behavioral health treatment for individuals with co-occurring disorders. Specifies items to be included in report, including recommendations for comprehensive legislation for the 2021 regular session. Requires report to be delivered to the interim committees and subcommittees of the Legislative Assembly related to health and mental health by September 15, 2020. Declares emergency, effective on passage.
