# 2018 Federal Survey on Sexual Victimization in Juvenile Facilities

---

- National average of 7.1% reporting allegations
- Two OYA facilities above the national average

## 2018 Federal Survey

	# of youth surveyed	% reporting abuse
Oak Creek YCF	42	14.3% (6 youth)
Rogue Valley YCF	58	10.3% (6 youth)

- Allegations reported and investigated
- Reported under the Prison Rape Elimination Act (PREA)

## What We're Doing Next

---

- Forums with youth at all facilities to ensure they know how to report and identify any barriers to reporting
- Our internal auditor will do an objective, independent review
  - How we collect data for PbS and PREA
  - Want to make sure youth know PbS survey answers are anonymous, so data is accurate
