"Climate Emergency Resolution"

(ASOSU Statement on the Urgency of Climate Change, and Encouraging Action on the Part of OSU and the Oregon State Legislature)

- **WHEREAS** 97% of "actively publishing climate scientists," according to the National Aeronautics and Space Administration, are in agreement that the global climate is changing in a significant way due to human activity¹;
- "World Scientists' Warning of a Climate Emergency," signed by 11,000 global scientists, states that WHEREAS climate change will bring "untold suffering"² to global populations;
- WHEREAS The effects of global climate change have shown to contribute to droughts, heatwayes, water shortages, and rising sea levels, with implications for the biodiversity of plant and animal species as well as human lives³;
- WHEREAS The executive summary of a 2018 report of the Intergovernmental Panel on Climate Change (IPCC) warns the consequences of global warming in excess of 1.5 °C are in many cases irreversible, also writing that limiting warming to this extent "implies reaching net zero CO2 emissions globally around 2050 and concurrent deep reductions in emissions of non-CO2 forcers, particularly methane⁷⁴, making it clear that addressing climate change is a time-sensitive issue;
- WHEREAS The effects of warming will be felt disproportionately by marginalized communities who contribute the least to climate change, including lower-income communities and communities of color5 of whom OSU has expressed a commitment to supporting⁶;
- WHEREAS Climate change poses a risk to the reliability of infrastructure, the status of public health, the condition of the natural resource economy, and the condition of frontline and vulnerable communities in Oregon⁷;
- WHEREAS In 2007, OSU has become and remains a Carbon Commitment Charter Signatory, committing to carbon neutrality⁸;
- WHEREAS The United States of America has formally begun leaving the Paris Climate Accord⁹;

BE IT HEREBY RESOLVED BY THE ASOSU THAT:

As a crisis presenting itself not only to Oregon, but to the United States and the world, the Associated Students of Oregon State University urges and expresses support for Governor Brown and the Legislature of the State of Oregon to:

- 1. Introduce and pass legislation to take action on the issue of climate change as an emergency necessitating concrete steps toward the reduction of greenhouse gas emissions, as a matter of unfinished business during the 2020 short session;
- 2. As part of these legislative actions, hold industries and large-scale polluters directly accountable for the environmental cost of their emissions, and incentivize decreased total emissions statewide;
- 3. Explore and fund initiatives focused on environmental justice and community resilience;
- 4. Explore and fund nature-based solutions¹⁰ to climate change, which include soil health, reforestation, and conserving habitat for living things.

Furthermore, the Associated Students of Oregon State University urges and expresses support for the leadership of Oregon State University to:

- A. Establish and commit to a plan and a timeline for accomplishing carbon neutrality in a timely manner;
- B. Prioritize climate action in:
 - a. New construction projects;
 - b. Fundraising activities;
 - c. Lobbying efforts;
 - d. The mission of the OSU Extension Service;
 - e. Supporting student-led campus initiatives;
- C. Provide students with appropriate mental health resources due to detrimental mental health effects of a changing climate¹¹;
