Dear Joint Special Committee on Coronavirus Response,

In early February, 211info was asked by the Oregon Health Authority to provide general COVID-19 information and referral work to Oregonians. Call volume prior to Oregon's first presumptive case announcement on February 28 was in the range of 10-20 calls per day, and since then 211info has seen daily averages doubling every few days. This week we're averaging close to 1,000 incoming calls per day. With that in mind, we thought it would be beneficial for the Joint Special Committee on Coronavirus Response to see both a chart that shows the growth in call volume as well as an example of the daily reports 211info sends to OHA.


The 211info team is holding up well, and determined to meet the challenge. It's an amazing group of folks, at the front lines and across the leadership team. In order to respond quickly to the growing crisis this past week, the team has recruited and onboarded 15 new staff to help provide Oregonians with the up-to-date information they need. At this juncture, based on OHA discussions, we envision this increased demand and infrastructure staying in place until July 31, 2020.




