--lift restriction on self-service gasoline;

--temporarily lift maximum hours restriction in manufacturing;

--expand exemption from mandated closures to hardware, convenience stores, trash pickup, sanitation, janitorial workers, utilities, and banks;

--delay implementation of minimum wage increase;

--create ombudsman for businesses and individuals;

--convene emergency state task force to develop ideas to help the economy (small business, manufacturing, tourism, retail, transportation, etc.);

--regular lines of communication between business and leaders, sector-by-sector response teams;

--require state agencies to create designated resource sites for employers;
