OSH Response to the COVID-19 Pandemic

- Activated and operating the OSH Emergency Operations Center
- Following OHA guidance for long-term care facilities and in-patient psychiatric facilities
- Restricting non-essential guests and suspended all patient visitation, except for patients receiving hospice care
- Screening all patients twice a day for symptoms such as fever, cough, shortness of breath
- Testing every patient who displays symptoms of Covid-19











OSH Response to the COVID-19 Pandemic

- Everyone entering the hospital is screened for symptoms and exposure to COVID-19
- All staff entering the secure perimeter required to wear surgical masks
- Contact tracing is conducted for staff and patients with a confirmed case of COVID-19
- As of today:
 - Three staff have tested positive for COVID-19
 - No patients have tested positive











Additional Service Changes

- Limiting the size of patient groups
- Scheduling times for patients to use gymnasiums and outdoor spaces to maintain social distancing
- Offering virtual visitations and expanded phone visitation hours so patients can connect with their loved ones
- Offering telemedicine for outside medical follow-ups, informed consent assessments, and psychiatry
- Canceling all patient community outings except for those medically or behaviorally necessary or for post-discharge placement purposes











Workforce Experience

- Staff are provided with personal protective equipment and training on how to use it base on their work assignment
- Activated the Emergency Staffing Plan to bolster Nursing coverage
- Staff who exhibit symptoms are sent home to self-monitor, as necessary
- Staff assigned to the admissions units, protective units and quarantine units don't work on or enter other units
- Increased intensity and workload on admissions monitoring units
- Staff continue to show compassion, dedication and ingenuity











Limited Admissions March 16 thru April 13

OSH limited admissions to make a series of highly complicated logistical changes:

- Transferred 71 patients at serious risk if infected with the virus into three protective units – patients identified primarily by:
 - Underlying medical conditions
 - Age
- Developed two quarantine units to serve patients who are symptomatic or test positive for COVID-19, one on each campus
- Created two specialized admission monitoring units, both on the Salem campus











Current Admissions Process

- Admitting people under Aid & Assist orders in cohorts of 15 or 19, depending on the unit (one has four more beds than the other)
- Testing all newly admitted patients using strategy developed with guidance from the State Epidemiologists
- Patients in each admission cohort transfer to other hospital units within 14 days if none test positive for the virus
- If one or more patients test positive, they are immediately transferred to the quarantine unit, and the 14 days re-starts for rest of the cohort
- Opened a third admissions monitoring unit on June 1
