The ELD Office of Child Care is responsible for ensuring the health and safety of children in regulated child care settings across the state, technical assistance to providers to meet child care regulations, and providing information to families about the availability of safe and quality child care. Oregon Health Authority	Oversees requirements on communicable disease reporting and immunizations. Conducts environmental health inspections.	County Environmental Health Office
Oregon State Fire Marshal	Conducts fire inspection of child care providers for licensing.	
Building Codes Division	Administers Oregon's Statewide Building Code, which provides uniform standards that ensure newly constructed residential and commercial buildings are safe for citizens to occupy.	Oregon Structural Specialty Code (OSSC) regulates child care facilities in other buildings than dwellings. The Oregon Residential Specialty Code covers one- and two-family dwellings and townhouses.
Oregon Employment Department (OED)	Administers programs to support business and promote employment. Programs treat child care businesses with employees as they do other businesses with employees.	Self-Employment Assistance Program, Trade Adjustment Assistance Program, Training Unemployment Insurance (TUI), Work Share Oregon Program, Work Opportunity Tax Credit, Child and Adult Care Food Program (CACFP) <i>*OED does not have any programs at this time that are focused specifically on child care businesses and providers.</i>
Small Business Development Center Network (SBDC) (Public Partnership)	Coordinates the Self-Employment Assistance Program in collaboration with the Oregon Employment Department.	No-cost confidential advising, training and online courses for small businesses.
Oregon Department of Transportation	Oregon Department of Transportation (ODOT) has several resources for child care and supports local childcare facilities.
