# TRUST FOR CULTURAL DEVELOPMENT BOARD

The Governor has appointed the following individuals to the Trust for Cultural Development Board subject to Senate confirmation.<sup>1</sup>

# Statutory Requirements<sup>3</sup>

The board consists of 11 members appointed by the Governor and confirmed by the Senate (DOWNES-LE GUIN, GOODWIN, JOHNSON, JONES-CENTENO, KRAMER, **MORALES**, **PRICE**, RENARD, SAMS, VAN DYKE, YAMASAKI).<sup>4</sup> The membership of the board must reflect the geographical and cultural diversity of the state. Each member must have a background that demonstrates a commitment to Oregon's culture.

The Speaker of the House of Representatives and the President of the Senate must each appoint a member of the Legislative Assembly to be a nonvoting advisory member of the board (DOHERTY).

Members serve four-year terms at the pleasure of the appointing authority. The board must elect one of its voting members as chairperson and another as vice chairperson. Their terms

and duties and powers are determined by the board. The board must meet at least once every three months.<sup>5</sup> A majority of members constitutes a quorum for the transaction of business.

# **Duties and Authority**

The board oversees management of the Trust for Cultural Development Account and provides direction to the Administrator of the Arts Program for the coordination, administration, and evaluation of grant programs and the use of funds received by core partner agencies.<sup>6</sup>

The board acts as the custodian of any property accepted by the board and holds the property as trustee for the state. <sup>7</sup>

#### The board may:8

- adopt rules necessary to administer the Trust for Cultural Development;
- solicit and accept gifts, bequests or devises of money, securities, or other property of any kind; and
- sell or exchange any property accepted as a gift, bequest or devise as the board determines appropriate.
