- Notification of an arrest, a criminal citation to appear or its equivalent, a conviction, or any other criminal disposition.
- Notification of a non-voluntary separation of employment.
- Complaints made against a certified public safety professional who is not currently employed in a certifiable position; complaints made against an employed public safety professional whose employing agency is non-responsive to Standards and Certification's requests for further review.
