Dear Ways and Means subcommittee,

Last week the Jackson County 4-H & FFA program held its annual youth and livestock shows at our local fairgrounds, called the Expo. Educators and 4-H Leaders designed a safe and educational, inperson experience that followed all COVID safety guidelines. Since we have a large 4-H & FFA program with over 720 youth, we would not have been able to accomplish the physical distancing, bathroom sanitation, one way traffic flow, and outdoor space requirements without using the Expo's multiple buildings and well-trained staff. Youth exhibited their art, photography, chickens, pigs, steers, horses and dogs over the course of 9 days, and we used every building the Fairgrounds had to keep participants safe.

I enjoy using the Expo year round for our horse clinics and animal husbandry workshops. Now more than ever our kids and families need large spaces to safely participate in hands-on opportunities. I need a facility that is well maintained for their safety. I want to continue to use a space that is accessible to families with disabilities. 4-H simply cannot afford to use the fairgrounds if their rental prices increase. Please reconsider the potential \$1 million in cuts of lottery fund allocations to fairs. We need our fairgrounds to continue our educational mission. Thank you.

Two questions have come up. Why should the State fund fairs when they are cancelled this season? Secondly, should fair funding from the State be maintained in the current and upcoming difficult climate?

First of all, Multnomah County Fair IS planning to have an event this year. We have had to postpone twice, but we realize how important this is to our community and our youth exhibitors, so we are planning a modified event for early October. We will have a Harvest Festival and Creative Living fair, featuring homemade crafts, needlework, foods, and also photography, art, and horticulture exhibits. The fair will be promoted in appreciation to all of the front line workers who have helped sustain our community through the crisis.

Multnomah County Fair is dependent upon State funding to exist. We have no staff, including no office staff, we don't have the funds to hire anyone. We provide our manager \$9000 per year to plan the fair, coordinate vendors, bring in entertainment, and create the layout of our event. We pay our Superintendents a small stipend to run their departments. All the rest of the work is done by a Fair Board of five volunteers and a small number of additional volunteers. With a group this small, most of whom are working to support their families, we haven't been able to host other fundraisers or garner grants or other forms of support. Aside from the lottery funds, we take in annually only \$10,000-\$15,000 in vendor fees and small donations, giving us a total budget of about \$65,000 each year to put on our entire fair.

We do not own a fairgrounds as we don't have the financial ability to purchase and maintain facilities. Since Multnomah County government sold our grounds off many years ago and have no involvement with our fair, we rent space from Historic Oaks Park to hold our event. County government also cut funding to our 4-H programs, so we created youth categories in order to encourage the 4-H kids to keep working on their projects and learning. While we are not able to directly offer year round youth programs, we work with different youth organizations to encourage and assist kids up to age 18 to participate in our youth fair categories. Our youth categories have been filling every year and we keep having to increase our budget for premiums paid out. Since we are under the rules of Oaks Park, we are not able to charge a gate admission and have no direct way of earning any significant funds for our youth program, so are dependent of the State lottery funds and, without that, we will likely be the first county fair in Oregon to cease to exist. I understand that many of the smaller counties are in the same boat, so others will likely follow.

Personal story: I was a very shy and withdrawn child with no self confidence. I didn't fit in with any school activities and did not want to participate. In the late 60's, my grandmothers encouraged and supported my participation in fairs and got me started on growing a garden and other projects so I could have entries. Over the years it taught me a work ethic and gave me confidence that I would not have gained in the school system or other youth activities. Participating in the local fairs taught me how to interact with others and the confidence to express myself to others individually and in a group. Today, I am a successful adult who holds leadership in several community groups. Aside from my fair participation, I am President and Accreditation Chair of Pacific NW Dahlia Assn, Publicy and PR Coordinator for American Dahlia Society, volunteer moderator for my Nextdoor website neighborhood, publicist for the 82nd Avenue of Roses parade, and have been Chairperson or President for a number of community events. I have also produced and hosted a nationa and regional award winning local community television program since 1986. I attribute much of my own success and ability to contribute to my community to my early training in working with fairs.

The current climate is presenting a significant challenge for today's youth. Please don't deny them the opportunities that I had, though fair participation. Continue to provide the needed State funding so that other youth may receive the many unique benefits that our fairs offer.

Legislators. I ask that you reconsider removing the funding from county fairs. Yamhill County Fair has served the citizen's and people of the State of Oregon since 1854. We have brought generations of family's from the rural areas to city to show their wares and skills to everyone. Some things have changed a little since the first fair in Oregon. We continue to serve all citizens but have concentrated on the youth. They will be the ones who will continue this tradition for the next 166 years. We are proud of the fact that the youth are interested and have seen a growth in the amount of youth who want to participate in the fair. The funding allows us to keep this affordable for family's to participate in the fair and all the youth groups that use the facility.

I had the County Sheriff tell me that the programs we have at the fairgrounds were great. He could only remember one time in 25 years of service that he arrested a youth that was involved in the programs we support.

While the amount does not seem large in reference to the state budget, it will allow us to keep helping youth through next year. Yamhill County Fair has lost over \$150,000.00 in income since March and as the COVID situation continues to decrease our income and the ability to rent the facility, it makes it tough to do all we can to keep the youth engaged. In Yamhill County's case the fair and fairgrounds are not in the county's general fund. We receive no TLT monies. We receive the \$53,000.00 from the State and \$70,000.00 from Lottery funds the county gives us. The rest of the \$800,000.00 budget was made by rentals of the facility. As you well know the lottery funds are going to be greatly reduced due to the lack of players.

I apologize for not being able to come before you to testify, but since we have had to make cuts in staffing, I am also doing the maintence and repairs along with the management of the fairgrounds. We are committed to prevail through all this and hope the that you will see the value of the funds that are committed to fairs and what do for the community.

I am writing to express my concern about the proposed budget cuts to county fairs. We receive roughly \$53,000 annually from lottery funds and that money accounts for one third of our public funding. This year is especially challenging. Without interim rentals our budget is already taking a huge hit. Those rentals account for a significant portion of our annual operating budget.

Our fair complex is not only the home of the Jefferson County Fair, but, during a normal year, we also host over 170 events year-round for local groups and citizens. More than 450 hours of volunteer time was donated during 2019 and fundraisers held at the fairgrounds benefitted local groups and individuals with more than \$792,000 being reinvested in our community through donations and auctions. Our annual fair had 876 local citizens who came and demonstrated their skills at everything from guilt making to growing flowers, not to mention educational displays by 4H and FFA clubs.

Our fair complex is also a critical emergency response asset for local law enforcement and public safety. We are an emergency evacuation location for the Red Cross, we serve as a reunification facility for the local school district, we are a distribution point for Public Health in the event of an outbreak or public health emergency. We host the forest service while firefighting and are a training location for State and Local SWAT teams. We have also hosted animals who have been evacuated during extreme weather.

As you can see, we are not simply a fairgrounds that operates the county fair. We are an essential resource for our community.

Please reconsider the \$1,000,000 in cuts to county fair funding. Without the support from Salem, small rural fairgrounds like ours will be required to cut programs and activities that serve our community, likely for many years to come.

At this time, we have already laid off 6 full time employees, leaving us with only 3 staff. The lottery dollars that we are currently receiving would be an equivalent to another Full Time Employee. Due to the COVID19 restrictions we have already lost 1.3 million dollars of our revenue and continue to lose event more (including the 2019 Douglas County Fair). We know that there was a large Cultural Trust Fund passed and we are hoping to see some of those dollars but that is a short term solution. The Lottery Dollars are imperative to our budget and to the success of the Douglas County Fair as well as the Fairgrounds in providing our community a place to go for disasters, weddings, funerals, fundraisers and all other community gatherings! It is my understanding that County Fairs are being recommended for up to \$1 million in 'cuts' from their approved lottery allocations. I would like to take this opportunity to point out a few facts about County Fairs and ask for consideration in future funding.
